You can send holiday cards to military members through a local American Red Cross chapter that participates in the Holidays for Heroes program.

**Collect donations for a food bank.** Food banks distribute food to families and various organizations that serve people in need. A charitable activity that your family and friends can rally around is collecting items from the community for a local food bank. You can facilitate your own food drive or gather cash and food donations to contribute to a food drive run by another organization. **Volunteer at a shelter.** If you don't have cash to spare for donations, you can donate your time, which is just as valuable. Volunteer at a homeless shelter or women and children's shelters in food prep or meal service. Visiting a shelter to meet the people you serve one-on-one can be a gratifying

Make sure the drop-off bin you use accepts donations for charitable purposes. Local religious and charitable groups will gather personal information from families who need sponsorship, including their clothing sizes and holiday wishlists. ## Sandoval Vota para Proteger a las Víctimas de Tráfico Humano

El Senador Estatal Martín A. Sandoval (D-Chicago) dio los pasos necesarios para combatir el tráfico humano el miércoles, votando para anular el veto del Gob. Bruce Rauner del Acta Voices of Immigrant Communities Empowering Survivors (VOICES). El proyecto daría poder a las víctimas del tráfico de inmigrantes para que se presentaran protegiéndose de la deportación si ayudan a entregar a la justicia a la gente de estas redes de tráfico humano. En el 2000, el gobierno federal comenzó a ofrecer visas especiales de inmigración a las víctimas de estos tipos de crímenes que cooperaran con la ley. La meta es animar a las víctimas a trabajar con la policía para llevar a sus captores a la justicia.

Sandoval dijo que la lista de actividad criminal calificada aplicable al Acta Voices, incluye secuestro, chantaje, mutilación genital femenina, ser retenido



como rehén, incesto, servidumbre involuntaria, asesinato, violación, asalto sexual, explotación sexual, trata de esclavos, tortura y tráfico. Hace dos años, el Gob Bruce Rauner aprobó una ley dando ayuda estatal a estas víctimas mientras

se procesaban sus papeles federales de inmigración. El Acta Voices simplemente fija una fecha límite para que las oficinas de la ley terminen ese papeleo y lo envíen a los oficiales federales de inmigración para su consideración. El

proyecto permite aún a las autoridades determinar en su reporte si creen en las cualidades del solicitante o no para el Acta de Protección Voices. El Acta Voices se convertirá en ley si es aprobada más tarde por la Cámara.

## Sandoval votes to protect human trafficking victims

State Senator Martin A. Sandoval (D-Chicago) took steps to combat human trafficking Wednesday by voting to override Gov. Bruce Rauner's veto of the Voices of Immigrant Communities Empowering Survivors (VOICES) Act. The bill would empower immigrant trafficking victims to come forward by protecting them from deportation if they help bring to justice the people behind these human trafficking rings. In 2000, the federal government began offering special immigration visas to victims of these types of crimes who cooperate with law enforcement. The goal is to encourage victims to work with police to bring their captors to justice.

Sandoval said the list of qualifying criminal activity applicable to the Voices Act includes abduction and kidnapping, blackmail, female genital mutilation, being held hostage, incest, involuntary servitude, murder, rape, sexual assault, sexual exploitation, slave trade, torture and trafficking. Two years ago, Gov. Bruce Rauner enacted a law giving state assistance to these victims while their federal immigration paperwork is processed. The Voices Act simply sets a deadline for law enforcement to wrap up that paperwork and submit it to federal immigration officials for consideration. The bill still allows authorities to determine in their report whether they believe the applicant qualifies for Voices Act protection or not. The Voices Act will become law if passed by the House at a later date.

## Body Found During Search for Missing Lyons Man

**POLICE UPDATE:** Lyons Police discover unidentified body in vehicle owned by missing Lyons man, Paresh Jhobalia

Lyons Police Department working with Major Case Assistance Team (MCAT), the West Suburban Detectives Task Force, discovered a body inside a vehicle owned by a man reported missing on Nov. 10, 2018. The identification of the body is being conducted by the Cook County Coroner, but the body was inside a vehicle that was owned by Paresh Jhobalia, 62, who was last seen in Downers Grove and reported missing by his family members. Police and MACT detectives obtained a search warrant to inspect the vehicle, a Honda, which was parked behind the missing man's home in Lyons near 44<sup>th</sup> and Prescott Avenue. Lyons Police officials had asked members of the public this week to assist in helping



to locate the missing individual. Police said that they are urging anyone who knows anything about the missing man and the

incident to contact the Lyons Police Department at 708-447-1225. Jhobalia has no children and was living alone at the home.



## Apple Watch Now Part of UnitedHealthcare Wearable Device Program

Apple Watch is now part of UnitedHealthcare Motion, a national wearable device program that encourages current participants to achieve nearly 12,000 steps per day – more than double the number of the average American adult. Starting this month, Apple Watch is now available to eligible employer-sponsored program participants, enabling people to use their Apple Watch or shop for a new one. ## Chicago's Airports Ready to Welcome Over Two Million Passengers for Thanksgiving Travel Week

The Chicago Department of Aviation (CDA) announced that O'Hare and Midway International Airports are expected to be among the busiest airports in the nation for Thanksgiving holiday travel this year, with more than two million passengers expected over the next seven days. ## Boeing Announces \$100,000 Grant to Support YMCA of Metro Chicago's Urban Warriors Program

The YMCA of Metropolitan Chicago has received a \$100,000 grant from Boeing to support Urban Warriors, a trauma-informed, violence prevention and intervention program that serves youth from 10 under-resourced communities. Youth mentoring is provided by post-9/11 military veterans, who receive training and ongoing support from YMCA staff. The Boeing grant, which is part of its Global Engagement Fund, will support program operations and concurrent strengths-based case management services that address each participant's needs and interests beyond the 16-week structured

sessions. This latest grant brings Boeing's total support of Urban Warriors to \$300,000 over three years. Last year, Urban Warriors served 102 youth and 26 veterans. The Y expects to serve 120 youth in eight cohorts in 2019, including two in its newest communities Woodlawn and South Shore. Urban Warriors is part of the YMCA's Youth Safety and Violence Prevention (YSVP) initiative, which serves youth at high risk for mental health and behavioral problems, including involvement in violence as both victims and perpetrators. YSVP serves more than 325 youth every year.

2.Remove giblets and neck from turkey cavities and reserve for making gravy. Place the turkey, breast-side up, on a rack in a large roasting pan; pat dry with paper towels. Mix minced herbs, oil, salt and pepper in a small bowl. Rub the

herb mixture all over the turkey, under the skin and onto the breast meat. Place aromatics and 10 of the herb sprigs in the cavity. Tuck the wing tips under the turkey. Tie the legs together with kitchen string. Add 3 cups water and the remaining 10 herb sprigs to the pan.  
3.Roast the turkey until the skin is golden brown, 45 minutes.  
4.Remove the turkey from the oven. If using a remote digital thermometer, insert it into the deepest part of

the thigh, close to the joint. Cover the breast with a double layer of foil, cutting as necessary to conform to the breast. Reduce oven temperature to 350 degrees and continue roasting for 1¼ to 1¾ hours more. If the pan dries out, tilt the turkey to let juices run out of the cavity into the pan and add 1 cup water. The turkey is done when the thermometer (or an instant-read thermometer inserted into the thickest part of the thigh without touching bone) registers 165°F.  
5.Transfer the turkey to a

serving platter and cover with foil. (If you're making Herbed Pan Gravy, start here.) Let the turkey rest for 20 minutes. Remove string and carve.
