Latino Art Beat held their second annual Youth Arts Initiative in Havana. Cuba earlier this month, once again transforming the lives of talented young artists across the island. "It's incredible to see the eagerness and passion from students to participate in this initiative," said President of Latino Art Beat Don Rossi Nuccio. "It is always an honor to come back and partner with Casas de Cultura and Cuban Ministry of Culture to reach high school students with such tremendous talent and who speak high praise for American students."

The partnership between Latino Art Beat and the Cuban Ministry of Culture began in March of 2016 when Rossi Nuccio served as a guest of the Obama White House during the former Present's historic trip to Cuba. "I distinctly remember former President Obama's

message to us all about connecting with people. I took that message to heart and decided to have Latino Art Beat expand its mission outside of the United States," said Rossi Nuccio. Latino Art Beat introduced an art competition to the youth of Cuba themed "Friendship between the Youth of the United State and Cuba.' The first initiative was an unequivocal success, which resulted in inviting two top Cuban young competition winners to study at the prestigious Maryland Institute College of Art, Baltimore, MD (MICA) for its advanced art summer courses.

This year's competition winners, who followed the same theme as the previous year, participated in a ceremony held at the Casas de Cultura headquarters in Havana where they were able to display their artwork in front of their parents, teachers, family members, and government officials. "It is extremely important to continue to build this partnership between our organizations and provide a platform for students... students who are selfreflective, knowledgeable, passionate, and students who have ambition," said Rossi Nuccio. Among this year's winner was Stephenie Rivero Toledo, 17, who created a drawing reflecting the fusion of a self-portrait with that of an American woman titled, "Ser Humano."

"In the artwork which I submitted, I have represented how two cultures can be together as one, and it doesn't matter if they are different. Sometimes we forget that we all are the same," said Toledo in a statement.

Each student was awarded with gift boxes containing substantial at materials and supplies, and a ribbon medallion. One of last year's winners was Favio Felipe Gonzalez, 17, who studied in the United States through the Latino Art Beat/MICA scholarship initiative and now serves as Latino Art Beats First

Youth Ambassador in Cuba. "I wish to relay my thanks to Don Rossi Nuccio for this opportunity through Latino Art Beat and MICA. It's not only the experience I had in studying advanced art outside of my country -it made me a better student and also a better artist."

As for what's

next for Latino Art Beat. Rossi Nuccio shared his upcoming plans. "It is Latino Art Beats objective to hopefully be able to do a proper student exchange with U.S. students going to Cuba and Cuban students once again coming to the States to study during the summer of 2019. "MICA", our premier academic partner is already on board and committed to receive next year's young Cuban student artist winners of this milestone competition/"

ICIRR: Members of Congress must condemn U.S. military action against unarmed migrants, asylum seekers

On Sunday, the U.S. Border Patrol violently attacked a crowd of migrants, including women, infants and small children, who were on the Mexico side of the U.S./ Mexico border at San Ysidro. Those attacked were among the estimated 5000 persons hoping to apply for asylum and to enter the U.S. Some have been waiting at the border crossing for six months. Following is a statement from Illinois Coalition for Immigrant and Refugee Rights Executive Director Lawrence Benito: "Instead of providing relief and compassion to those in need, and protecting the rights and safety of those awaiting their chance to apply, the U.S. government has rained violence down



on them. ICIRR calls upon our 18 Representatives in the U.S. Congress, along with Senators Duckworth and Durbin, to protest loudly and demand an immediate cessation of this provocative and unwarranted attack on migrants and refugees, before the U.S. forfeits entirely its reputation as a haven for the oppressed and a land of opportunity."

Chicago Animal Care and Control Announce Rehabilitation of Shelter Medical Facility

Mayor Rahm Emanuel and Chicago Animal Care and Control (CACC) **Executive Director Kelley** Gandurski announced new investments as part of the 2019 budget to renovate the shelter's medical facility and strengthen medical care. The new project will allow the shelter's medical practice to more efficiently and effectively treat CACC's animals to support the adoption, transfer and rescue of

shelter pets. In January, a complete renovation of the medical and surgery areas will begin on the existing medical facility, which is more than 20 years old. This will include electrical structural and mechanical updates to the prep, triage, surgery, recovery, and exam rooms. CACC is partnering with the University of Illinois to host veterinary medical students to assist with providing additional care to shelter

animals. The renovation of the medical and surgery suite will educate future veterinarians while the shelter will benefit from additional help to treat animals. The Department of Fleet and Facility Management is managing the improvements using existing City contracts. The renovation is estimated to cost \$1.5 million. Queda Completa la Primera Fase del Proyecto de Fulton Market Streetscape

El Alcalde Rahm Emanuel se unió al Concejal Walter Burnett (Dist 27) y partes interesadas de West Loop, para cortar la cinta de la primera fase de Fulton Market Stretscape, modernización inspirada en la comunidad del corredor que es el primer mercado mayorista de Chicago y ahora incubador de la economía technológia que florece en la Ciudad. Al terminarse la primera fase del proyecto, de la Ave. Halsted a la Calle Carpenter, el Departamento de Transporte de Chicago (CDOT) anunció que iniciará el trabajo de la segunda fase en las próximas semanas,

de Carpenter a Ogden Boulevard. El Concilio de la Ciudad designó el Distrito de Fulton-Randoph Market como Lugar Histórico de Chicago en julio del 2015. El plan del paisaje urbano fue desarrollado en cooperación con el Concejal Burnett y partes interesadas de la comunidad, incluyendo



West Loop Community Organization (WLCO) y el Departamento de Planeación y Desarrollo (DPD). El diseño intenta hacer el barrio más adaptado para los peatones, mientras preserva su carácter histórico y acentúa elementos históricos de la arquitectura del barrio. Las mejoras al paisaje urbano incluyen la total reconstrucción de la carretera y la instalación de nuevas rampas ADA y un diseño de calles flexibles que no tenga curvas en algunas cuadras. El trabajo de la segunda fase, de Carpenter a Ogden, se espera quede terminada para finales del 2019. El costo total de la construcción de ambas fases del proyecto es de \$20.3 millones

First Phase of Fulton Market Streetscape Project Complete

Mayor Rahm Emanuel ioined Alderman Walter Burnett (27th Ward) and West Loop stakeholders to cut the ribbon on the first phase of the Fulton Market Streetscape, a community-inspired modernization of the corridor that is Chicago's first wholesale market and now is an incubator for the City's thriving tech economy. As the first phase of the project wraps up from Halsted Avenue to Carpenter Street, the Chicago Department of Transportation (CDOT) announced it will launch work in the coming weeks on the second phase from Carpenter to Ogden The City Boulevard. Council designated the Fulton-Randolph Market District as a Chicago Landmark in July 2015. The streetscape plan was developed in cooperation with Alderman Burnett and community stakeholders, including the West Loop Community Organization (WLCO), and Department of Planning and Development (DPD). The design is intended to make the neighborhood

more pedestrian-friendly, while preserving its historic character and accentuating historic elements of the neighborhood's architecture. streetscape improvements include the full reconstruction of the roadway and installation of new ADA ramps and a flex-street design that has no curbs on some blocks. Work on the second phase from Carpenter to Ogden is expected to be complete by the end of 2019. The total construction cost for both phases of the project is \$20.3 million.

Number of College Students Seeking Help for Mental Health Troubles Increases

Nearly 26 percent of people 18 years and older are living with a mental health condition in the United States. Now, recent study findings published in the Journal of American College Health suggest that mental health problems are on the rise among university students, Medical News Today reports. For the study, researchers examined data provided by the American College Health Association on almost half a million undergraduates between 2009 and 2015. Next, scientists reviewed the trends in diagnosis and treatment for 12 mental health conditions: anorexia,



anxiety, attention deficit and hyperactivity disorder (ADHD), bipolar disorder, bulimia, depression insomnia, obsessive-compulsive disorder (OCD), panic attacks, phobia, schizophrenia and substance abuse/addiction. Results showed that during the six-year period, diagnoses and treatments for anxiety, depression and

panic attacks surged. In addition, researchers noted that students were more willing to seek mental health help on campus, with nearly one fifth reporting that they used their university's mental health facilities.





Fresh Ham with Red Pepper Glaze

Ingredients

12 servings

Brine & Ham

- 6 quarts water
- 2 cups light brown sugar
- 1 cup kosher salt
- 12 whole cloves
- 12 allspice berries
- 4 bay leaves
- 2 cups ice cubes
- 1 10- to 12-pound shank-end fresh ham

For Roasting

- 5 cloves garlic, chopped
- 3 tablespoons minced fresh thyme
- 1 tablespoon kosher salt
- 2 tablespoons extra-virgin olive

½ teaspoon crushed red pepper 6 medium leeks

Red Pepper Glaze

½ cup red pepper jelly

½ cup honey

1 tablespoon grated fresh ginger

1 tablespoon light brown sugar

Preparation

1.To brine ham: Heat water, 2 cups brown sugar, 1 cup salt, cloves, allspice and bay leaves in a large pot over medium-low heat, stirring often, until the sugar and salt are dissolved. Add ice and stir to

cool the liquid.

2. Score fat of ham into a 2-inch-wide crosshatch pattern without cutting into the meat. Submerge in the brine. Refrigerate for 2 to 3 days.

3.To roast ham: Preheat oven to 450°F.

4. Pound garlic, thyme and

salt to a paste in a mortar and pestle (or in a mini food processor). Transfer to a bowl and stir in oil and crushed red pepper. Remove the ham from the brine and thoroughly pat dry with paper towels. Rub the paste all over the ham and into the scored cuts.

5. Trim the root end and top inch of greens from leeks; cut in half lengthwise. Submerge them in a large bowl of water and gently separate the layers to remove any grit, while keeping each piece together. Drain well.

6.Arrange a layer of leeks in a large roasting pan. Set the ham on top, with the fat cap facing up. Roast in the middle of the oven for 20 minutes.

7.To prepare glaze: Bring jelly, honey, ginger and brown sugar to a simmer in a small saucepan, stirring, to melt the sugar. Remove from heat.

8. After 20 minutes, brush the ham with $\frac{1}{4}$ cup of the glaze.

9Reduce oven temperature to 300 degrees . Roast,

brushing with 1 tablespoon glaze every 30 minutes, until an instant-read thermometer inserted into the thickest part without touching bone registers 150°F, about 3 hours.

10.Transfer the ham to a clean cutting board, loosely tent with foil and let rest for 20 minutes before slicing. Serve with the leeks, if desired.
