

# Pappas: Pague los Impuestos a la Propiedad hasta el 1 de Octubre sin Penalización

Las facturas de impuestos sobre la propiedad de la segunda entrega del Condado de Cook vencen el 3 de agosto de 2020, pero los propietarios tienen dos meses adicionales para pagar sin recargo, dijo la Tesorera Maria Pappas. "En mis casi 22 años como Tesorero, nunca le dije a la gente que no pagara sus impuestos", dijo Pappas. "Pero la pandemia ha cambiado muchas cosas.

Si ha perdido su trabajo y no tiene el dinero, no tiene que pagar hasta el 1 de octubre de 2020 ". Los propietarios pueden pagar la segunda cuota sin un recargo hasta el 1 de octubre. 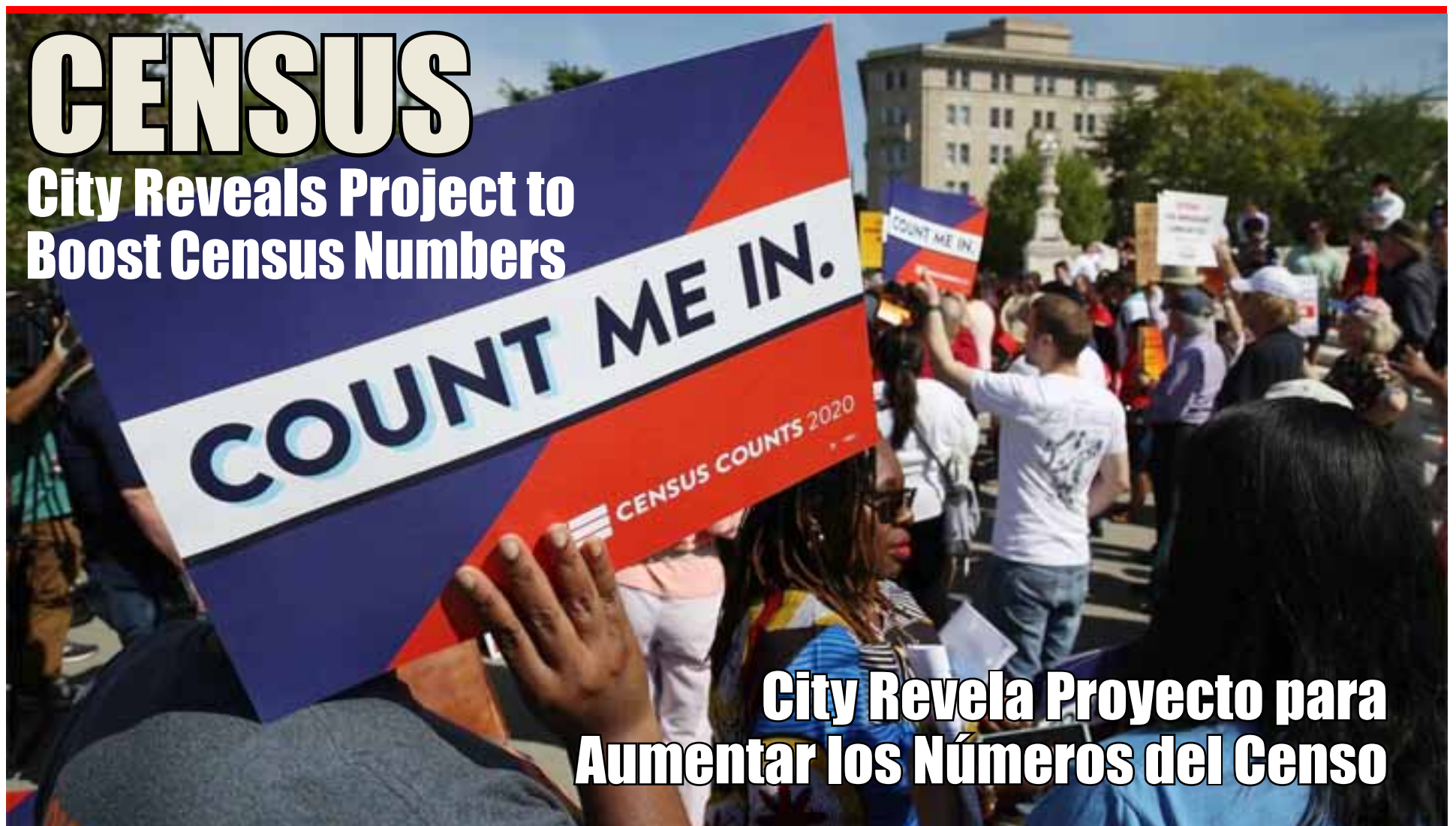

# Walgreens Chooses to Fight Cicero Face Mask Order

Walgreens, which operates three retail store locations in the Town of Cicero, has decided to fight a Cicero Executive Order requiring essential businesses to require employees and customers to wear face masks. Town President Larry Dominick and the Town of Cicero Board issued the face mask requirement in April requiring employees

and customers of every retail establishment to wear a face mask during business hours for health and safety reasons during the COVID-19 pandemic. The Town of Cicero has issued 8 citations to Walgreens for violating the Executive Order. Each citation carries a penalty of \$750. They are up for review before the Town's administration Court

Wednesday morning. "It's a basic health and safety issue for their customers but Walgreens refuses to adhere to the executive order. We feel they are putting their customers and employees at risk to the coronavirus," said Cicero Town Spokesman Ray Hanania.

"We have tried to work with Walgreens and have offered to reduce the fines significantly because our first concern is the safety and health of the public. Instead, Walgreens hired a law firm to fight the order and will appear at the Town's administrative hearing on Wednesday morning." The Executive Order, which President Dominick issued on April 15 using his statutory powers, includes 13 very specific provisions regarding health safety practices for essential businesses and for

customers who enter those businesses. They include: SECTION 1: Effective April 15, 2020, all employees and visitors of any grocery store, pharmacy or drug store, convenience store, gas station, and all other essential businesses as defined in Executive Order 2020-18 (collectively, the "Essential Businesses" and singularly, the "Essential Business") shall wear a face covering as recommended by the CDC, while on the premises.

SECTION 2: Essential Businesses and/or employers must provide, at their expense, such face coverings for all employees working in the establishment.

SECTION 3: If a visitor refuses to wear a face covering while on the premises of an Essential Business, the Essential Business must decline entry to the visitor.

Walgreens, que opera tres tiendas minoristas en la ciudad de Cicero, ha decidido luchar en contra a una orden ejecutiva de Cicero que requiere que las empresas esenciales exijan que los empleados y clientes usen máscaras faciales. El presidente de la ciudad, Larry Dominick, y la junta de la ciudad de Cicero emitieron el requisito de máscara facial en abril, exigiendo que los empleados y clientes de cada establecimiento comercial usen una máscara

facial durante el horario comercial por razones de salud y seguridad durante la pandemia COVID-19. La ciudad de Cicero ha emitido 8 citas a Walgreens por violar la Orden Ejecutiva. Cada citación conlleva una multa de \$ 750. Deben ser revisados ante el tribunal de administración de la ciudad el miércoles por la mañana. # City Reveals Project to Boost Census Numbers

The City unveiled a new civic engagement program designed to boost Census participation on Wednesday afternoon. Entitled "Boards of Change," the project will host an array of events citywide, such as registering to vote, going to the polls, and engaging in public dialogue.

During the press conference where the new project was launched, Mayor Lori Lightfoot was joined by artists, arts organization leaders and local aldermen to reveal a 50-foot-by-

15-foot mural made up of various pieces of plywood art that were used to secure local businesses during the recent protests and will be used to urge all Chicagoans to participate in "our shared democracy, which includes this year's Census."

"Democracy is about making our voices heard and ensuring everyone is counted," said Mayor Lightfoot. "It also demands we remain actively engaged in acts of democracy, from our public institutions, to our elected officials, legislative process, public dialogue, and—above all—engaged

with ourselves. 'Boards of Change' is an inspiring project channeling Chicago's passionate civic energy into being counted in our Census, voting booths, and beyond, enabling us to bring about the equitable changes our communities need, and our families deserve."

The City partnered with local artists, arts organizations including Sounding Boards and Paint the City, and businesses to curate these pieces of art from various neighborhoods throughout Chicago.

La Orden Ejecutiva, que el Presidente Dominick emitió el 15 de abril usando sus poderes legales, incluye 13 disposiciones muy específicas con respecto a las prácticas de seguridad de la salud para

negocios esenciales y para clientes que ingresan a esos negocios. Incluyen:

SECCIÓN 1: En vigencia a partir del 15 de abril de 2020, todos los empleados y visitantes de cualquier tienda de abarrotes, farmacia o farmacia, tienda de conveniencia, gasolinera y todos los demás negocios esenciales según se define en la Orden ejecutiva 2020-18 (colectivamente, los "Negocios esenciales" y singularmente, el "Negocio Esencial") deberá cubrirse la cara según lo

recomendado por los CDC, mientras se encuentre en las instalaciones.

SECCIÓN 2: Las empresas y / o empleadores esenciales deben proporcionar, a su costa, tales coberturas para todos los empleados que trabajan en el establecimiento.

SECCIÓN 3: Si un visitante se rehúsa a cubrirse la cara mientras se encuentra en las instalaciones de un Negocio Esencial, el Negocio Esencial debe rechazar la entrada al cliente.
