# Illinois Department of Public Health Issues COVID-19 Halloween Festivities Guidance

As we head into the holiday season, starting with Halloween, the Illinois Department of Public Health (IDPH) is issuing guidance to help people celebrate safely as we continue to battle the COVID-19 pandemic. Guidelines include following the 3 W's – Wash your hands. Watch your distance. Wear your mask.

As we head into the liday season, starting the Halloween, the nois Department of blic Health (IDPH) is using guidance to help liday season, starting the Halloween activities. If you think you could have COVID-19 or have been exposed to someone who has COVID-19, do not participate in any in-person Halloween activities.

#### **Trick-or-treating**

- Anyone participating in trick-or-treating, including those passing out candy, should maintain 6-feet of social distance and wear proper face coverings. - Consider leaving individually wrapped candy (spaced apart) on a table in driveways or in front of walkways, sidewalks, or any outdoor space where 6-feet of distance can be maintained. - A Halloween costume mask is not a substitute for a cloth mask. Ensure that breathing is not impaired if a cloth mask is worn under

a costume mask. If so, discard the costume mask. **Haunted Houses** 

- Halloween haunted houses currently are not allowed in Restore Illinois Phase 4 Guidelines. - Consider open-air, one-way haunted forests or haunted walks where 6-feet of distance can be maintained and face coverings are used.



# Adult costume parties, social gatherings, Halloween parties at bars - Gatherings of more than 50 people or 50 percent

- Gatherings of more than 50 people or 50 percent or more of a building's maximum occupancy are prohibited. (Lower limits may apply for regions in additional mitigation.)

# City of Berwyn Illinois Probationary Auxiliary Police Officer (Non-Conservator of the Peace)

**<u>Description:</u>** The City of Berwyn is now accepting applications for Probationary Auxiliary Police Officers. This position is classified as a non-conservator of the peace.

Qualifications: Candidates must be at least 21 years of age, must be a United States citizen, and have a high school diploma or a General Educational Development (GED) certificate. Applicants will have to pass drug screening, psychological screening, a comprehensive background investigation, an aptitude test and all prescribed training including firearms training. The applicant will be responsible for the cost of drug screening and firearms training. The applicant must be able to work under variable weather conditions and work days, nights and/or weekends as needed. The position may require up to 20 hours of work per week. The candidates who receive the position of Auxiliary Police Officer will be on probation for a period of two years.

Candidates who successfully pass all tests will be placed into an employment eligibility pool. Candidates chosen from the eligibility pool as needed and will attend, and successfully pass/complete approximately 175 hours of police oriented training including the State of Illinois mandated firearms training course.

**Salary:** \$14.00 per hour upon successful completion of all related training; a salary of \$15.50 per hour after two years, upon completion of probation.

Applications: Starting Tuesday November 3<sup>rd</sup>, 2020 at 09:00 a.m., applications may be obtained at the first floor reception desk at Berwyn City Hall, 6700 W. 26<sup>th</sup> Street, Berwyn, Illinois 60402 or on the City of Berwyn Website www.berwyn-il.gov. Completed applications must be submitted along with a non-refundable \$50.00 application fee, bank check or money order made payable to City of Berwyn. Additionally applicants must submit with their application a photocopy of current state issued driver's license, Firearms Owners Identification Card, Social Security Card, certificate of high school diploma or GED, and any current police/security certifications that the applicant has attained. Applications to be considered must be returned with all supporting documentation to the Berwyn Police Department Front Desk, 6401 W. 31<sup>st</sup> Street, Berwyn, Illinois 60402 no later than 4:00 p.m., Monday November 30<sup>th</sup>, 2020. No applications will be accepted after this time and date.

**Orientation:** A mandatory orientation will be held on Saturday, December 12<sup>th</sup>, 2020 at 9:00 a.m. (check-in will begin at 8:00 a.m.) at the Berwyn Police Department Community Center, 6401 W. 31<sup>st</sup> Street, Berwyn, Illinois 60402. At the completion of the Orientation a mandatory Aptitude Test will be administered.

## **Trick-or-treating**

-Cualquiera que participe en el trick-or-treating, incluyendo los que reparten dulces, deben mantener una distancia social de 6 pies y cubrirse apropiadamente con una máscara.

-Considere dejar dulces, apropiadamente envueltos (separados) en una mesa en la entrada o en el frente de la entrada de la casa, banquetas o cualquier espacio exterior donde pueda mantenerse la distancia de 6 pies.

-Una máscara de disfraz de Halloween no es substituto a una máscara regular. Asegúrese de no tener problemas de respiración si utiliza una máscara regular bajo la máscara del disfraz. Si es así, retire la máscara del disfraz.

#### Casas Embrujadas

-Las casas embrujadas de Halloween no están permitidas en este momento en la guía de la Fase 4 Restaure Illinois -Considere bosques encantados al aire libre en una sola dirección o senderos embrujados donde pueda mantenerse la distancia de 6 pies y se utilice una máscara.

#### Fiestas de Disfraces de Adultos, Reuniones Sociales, Fiestas de Halloween en los bares

-Las reuniones de más de 50 personas o 50 por ciento o más del cupo máximo del edificio están prohibidas. (Pueden aplicarse menores límites para regiones en mitigación adicional). -Mientras más tiempo pase en las reuniones, mayor contacto y más personas, mayor el riesgo de exponerse al COVID-19.

# Chicago Health Centers Among Recipients to Receive COVID-19 Grants

Foundation, in partnership with Illinois Children's Healthcare Foundation, awarded over \$3 million in grants to 36 Illinois Federally Qualified Health Centers and other public health clinics that deliver vital health care services. Sixteen of those grant recipients are in the Chicago metro area. The Foundations developed the grant opportunity to help offset costs associated with reopening and continuing operations during the COVID-19 pandemic. Grants of up to \$100,000 were available to Illinois health centers and clinics that integrate oral health into a primary health care setting. Grants were focused on these health centers and clinics because they offer crucial services to Illinois residents who are underserved and may face obstacles to receiving needed care. Among the

16 grant recipients from the Chicago metro area include: Alivio Medical Center, Chicago — \$100,000

This grant will go toward general operating support for children's oral health services. Funding will be used to support staffing, as well as personal protective equipment for the dental department. Alivio provides health care to the uninsured and underinsured, including many from the Latino community.

Howard Brown Health Center, Chicago — \$59,986 Howard Brown Health Center delivers health services to patients in areas disproportionately affected by health disparities at 11 clinical sites throughout Chicago, with a focus on the LGBTQ community, its allies and people with HIV/AIDS. This grant will support staff and construction costs for the health center's newly



opened pediatric dental suite in Englewood, as well as costs for personal protective equipment.

Erie Family Health Foundation, Inc., Chicago — \$100,000

Erie Family Health Foundation, Inc. will use its funding to help rebuild its capacity to pre-pandemic levels and continue to provide services to its pediatric patients, many who are from low-income families. Their goal is to reach 60% of that capacity this year, serving a minimum

of 6,354 children annually.





What happens in counseling? All counselors have a different style, but typically it begins with talking about what is going on and concerns and later the client, with their counselor, create goals that they want to accomplish in counseling. In later sessions, they talk more about what is going on, what happened

before and coping skills to confront difficulties and be successful.

counseling just Is for crazy people? Of course not! We all have problems—it can be changes in the present, trauma, or losses from the past, or worries about the future.

How is counseling different during the coronavirus? Adaptations that medical offices can make are more difficult counseling. For example, vou cannot see facial expressions with a mask. And although you can often sit six feet apart, typical sessions last an hour and the distance is not sufficient in that time. Therefore, the majority of counselors are using video chat or talk with



their clients on the phone. One advantage of this is that it matters less where your counselor's office is, you can meet in your home, in your car, and wherever to have a connection. There is so much stressful stuff in the world today, why not get some help in confronting it?
