

Fighting Drug, Alcohol Dependency in Latino Community

According to the National Survey on Drug

Use and Health (NSDUH), two in five Latinos struggled with illicit drugs, seven and nine struggled with alcohol use, and one in six struggled with illicit drugs and alcohol. Unfortunately, substance abuse continues and even increases as we live through the COVID-19 pandemic and organizations, such as PCC Community Wellness Center are diligently working to improve the lives for the medically underserved community through high quality, affordable, accessibility to health care and support services. "We provide services for those struggling with drug dependency and we are committed to serving the needs of all people in all stages of life," said Katie McDonough, MD, Medical Director Chemical Dependency Services of PCC Community Wellness

Center. "PCC Community Wellness Center are in areas where there are high incidence cases of drug and alcohol dependency," said Dr. McDonough. "We strive to set goals that will work for every individual who walks through our doors and equip them with the tools to live a healthy life." The PCC Community Wellness Center provides safe treatment for adults with addictions through their Chemical Dependency Program. The center can help with less heroin, prescription pain pills, alcohol, cigarettes, and other substances. PCC meets with an individual wherever they are in their recovery process and designs a program to meet the individual's goals. PCC also provides services in:

- Evaluations for adults who use opioids and substances
- Treatment, including Suboxone, Vivitrol, or buprenorphine
- Treatment for pregnant patients
- Counseling

•Access to ongoing care at a PCC health center

A prospective patient can visit PCC's Chemical Dependency Program. You will receive the first doses of medicine (induction) at either PCC Walk-In Wellness Center at West Suburban Medical Center or at PCC Melrose Park Family Health Center. After treatment is established, you may be able to have continued treatment at another PCC site. "There is such a stigma when it comes to substance abuse, most don't share their burden with their family members, keeping their struggle to themselves," said Dr. McDonough.

"Our goal is to take away the stigma surrounding substance abuse in order to have our patients lead a healthy lifestyle and we do that by providing privacy and providing an environment where they feel safe and comfortable." Lucha Contra la Dependencia de las Drogas y el Alcohol en la Comunidad Latina

De acuerdo a National Survey on Drug Use and

Health (NSDH), dos de cada cinco latinos luchan contra las drogas ilícitas, siete y nueve luchan contra el uso del alcohol y una de cada seis luchan con las drogas ilícitas y el alcohol. Desafortunadamente, el abuso de substancias continúa, e inclusive aumenta mientras vivimos con la pandemia del COVID-19 y organizaciones como PCC Community Wellness Center trabajan diligentemente para mejorar la vida para las comunidades médica desatendidas, a través de una accesibilidad de alta calidad y asequible a la atención médica y los servicios de apoyo. "Proveemos servicios para quienes luchan con la dependencia a las drogas y estamos comprometidos a atender las necesidades de toda la gente en todas las

etapas de la vida", dijo Katie McDonough, MD, Directora Médica de Servicios de Dependencia Química del Centro de Bienestar Comunitario de PCC. "PCC Community Wellness Center está en áreas donde hay una alta incidencia en casos de dependencia a las drogas y al alcohol", dijo la Dra. McDonough. "Luchamos para fijar metas que trabajen para todo individuo que entra por nuestras puertas y los equípate con las herramientas necesarias para llevar una vida saludable".

PCC Community Wellness Center provee tratamiento seguro para adultos con adicciones a través de su Programa de Dependencia Química. El centro puede ayudar con menos heroína, pastillas para el dolor con receta, alcohol, cigarrillos y otras substancias. PCC se reúne con una persona donde quiera que esté, en su proceso de recuperación y designa un programa para atender las metas de la persona. PCC brinda también servicios en:

- Evaluaciones para adultos que usan opioides y substancias
- Tratamiento, incluyendo



Suboxone, Vivitrol o Buprenorfina

- Tratamiento para pacientes embarazadas
- Consejería
- Acceso a cuidado continuo en un centro de salud PCC

Un paciente prospectivo puede visitar el Programa de Dependencia Química de PCC. Recibirá la primera dosis de medicina (inducción) en cualquier PCC Walk-In Wellness Center en West Suburban Medical Center o en PCC Melrose Park Family Health Center. Después que se establece el tratamiento, usted puede tener un tratamiento continuo en otro sitio PCC. "Hay tal estigma

cuando se trata de abuso de substancias, que la mayoría de personas no comparten el problema con los miembros de su familia, manteniendo su lucha para ellos mismos", dijo el Dr. McDonough.

"Nuestra meta es quitar el estigma que rodea el abuso de substancias para que nuestros pacientes lleven un estilo de vida saludable y lo logramos brindándoles privacidad y un ambiente donde se sientan seguros y cómodos". Mes de Concientización del Cáncer de Mama

Investigaciones de la Sociedad Estadounidense del Cáncer han demostrado que el fumar, el beber y la obesidad pueden aumentar el riesgo del cáncer de mama. Aunque todos hemos escuchado que un vaso de vino al día es bueno para la salud del corazón, pero también hay evidencia de que el alcohol aumenta el riesgo del cáncer en la mujer. Por cada bebida alcohólica

consumida al día, el riesgo de cáncer de mama en la mujer sube un promedio del 10 por ciento. La mujer tiene que considerar los beneficios del corazón contra los riesgos. También, las mujeres con sobrepeso, especialmente las postmenopáusicas tienen un riesgo de 1.5 a 2 más alto que las mujeres delgadas. Sin embargo, las mujeres que hacen una actividad física regular tienen un 10-25 por ciento menos riesgo que las que

permanecen inactivas. La Mejor Forma de Protegerse

La mejor protección es una pronta detección. Para aumentar su probabilidad de detectar el cáncer pronto, hay tres pasos que toda mujer debe seguir:

- Hacerse un autoexamen mensual. Familiarícese sobre la forma en que sus senos lucen y se sienten. De esta forma, cualquier cambio lo notará en seguida. Tenga cuidado si existe:



- un cambio en tamaño o forma
- hoyuelos o arrugas en la piel
- secreción del pezón
- piel escamosa, roja o inflamada en el seno
- un bulto en el pecho o en la axila
- Practíquese un examen anual. Esta revisión regular

debe incluir un examen del seno y tener la oportunidad de hacer preguntas sobre el estado de su salud.

• Hágase un mamograma anual. El Instituto Nacional del Cáncer recomienda que las mujeres de 40 años en adelante deben hacerse un mamograma cada año. Las mujeres con un historial familiar de cáncer de mama tal vez necesiten hacérselo más seguido. Hable con su doctor sobre cuando y con qué frecuencia debe ir. Los mamogramas son vitales porque pueden detectar el cáncer de mama antes de que pueda sentirse un bulto, en su etapa más temprana.

Breast Cancer Awareness Month

Research from The American Cancer Society has shown that smoking, drinking and obesity can all increase the risk of breast cancer. While we have all heard about the health risks of smoking, the alcohol and breast cancer link may be news. Many studies show that a glass of wine a day is good for heart health but there is also evidence that alcohol increases a woman's cancer risk. For every alcoholic drink consumed per day, a woman's breast cancer risk goes up an average of 10 percent. Women will have to weigh the heart benefits against the risks. Also, overweight women, especially postmenopausal, have about a 1.5 to 2x higher risk than lean women. However, women who get regular physical activity have a 10 percent -25 percent lower risk than those who are inactive.

The Best Way to Protect Yourself

The best protection is early detection. To increase your chance of detecting cancer early, there are three steps every woman should follow:

1. Perform a self-exam monthly. Get familiar with how your breasts normally look and feel. This way, any changes will be noticed right away. Look for:
 - a change in size or shape
 - dimpling or puckering of the skin
 - discharge from the nipple
 - scaly, red or swollen skin on the breast
 - a lump on the breast or underarm area

2. Get an annual exam. This regular check-up should include a breast exam and give you a chance to ask questions about breast health.

3. Go for a yearly mammogram. The National Cancer Institute recommends that women



State of Illinois Kicks Off Women's Small Business Month

State of Illinois officials joined First Women's Bank (in organization) to kick off Women's Small Business Month in Illinois and to recognize the contributions of hundreds of thousands of women owned businesses in communities across the state. Working alongside the future First Women's Bank, slated to open in early 2021, Illinois will partner on strategies to expand technical assistance and other resources to drive growth of women businesses in Illinois – which continue to lead on new business expansion, yet who remain historically underrepresented in loans. Preckwinkle, Housing Authority Announce Opening Housing Choice Voucher Program Waitlist

The Housing Authority of Cook County (HACC) announced it will accept applications for its Housing Choice Voucher (HCV) Program waitlist for the first time since 2001. Formerly known as Section 8, the HCV Program provides subsidies to income-eligible households to assist with rental payments in the private rental market.

Preckwinkle y la Autoridad de la Vivienda Anuncian la Apertura de la Lista de Espera del Programa de Vales de Elección de Vivienda

Housing Authority of Cook County (HACC) anunció que aceptará solicitudes para la lista de espera del programa Housing Choice Voucher (HCV) por primera vez desde el 2001. Anteriormente conocida como la Sección 8, el Programa HCV provee subsidios a viviendas de ingreso elegible para ayudarlos con el pago de la renta en el mercado de rentas privado. HACC actualmente brinda asistencia a más de 15,000 titulares de vales con fondos provistos por el Departamento de la Vivienda y Desarrollo Urbano (HUD). HACC aceptará solicitudes para la lista de espera hasta el 2 de noviembre. En el área metropolitana de Chicago, el umbral de elegibilidad de ingresos varía entre \$31,850 para una persona sola a \$60,100 para una familia de ocho. La lista de HACC tendrá 10,000 lugares para nuevos solicitantes. Solo se aceptará una solicitud por familia. La solicitud estará disponible en línea solo en <http://myportal.thehacc.org> hasta las 4:30 del 2 de noviembre. No se aceptarán solicitudes en papel. La solicitud estará disponible en inglés, español, ruso, polaco, árabe, hindi, coreano y chino. Los solicitantes que necesiten una adaptación razonable

HACC currently provides assistance to more than 15,000 voucher-holders with funding provided by the Department of Housing and Urban Development (HUD). HACC will accept applications for the waitlist through November 2. In the Chicago metro area, the income eligibility threshold ranges from \$31,850 for a single individual to \$60,100 for a household



of eight. The HACC waitlist will have 10,000 spots for new applicants. Only one application per household will be accepted. The application will be available online only at <http://myportal.thehacc.org> until 4:30pm on November 2. Paper

applications will not be accepted. The application will be available in English, Spanish, Russian, Polish, Arabic, Hindi, Korean and Chinese. Applicants who need a reasonable accommodation or assistance in filling out an application can contact the HACC by phone at (312) 517-2388 or at HCVWaitlist2020@thehacc.org.


