



# City Announces High Road Kitchens Program



Mayor Lori E. Lightfoot on Monday joined One Fair Wage to announce the creation of the High Road Kitchens Program in Chicago. Funded and administered by One Fair Wage, this \$1 million program will provide grants to participating restaurants that commit to pay their

employees a living wage by 2026 and providing free meals to community members in need. This program builds on Mayor Lightfoot's commitment to supporting business and employees affected by the ongoing COVID-19 pandemic and fighting for an equitable workplace and

protections for all workers. The High Road Kitchens program is rolling out in Chicago after successfully launching in California, New York City, Detroit and Boston. To be eligible, businesses must have annual revenue of under \$3 million and have experienced financial loss

due to COVID-19 totaling 25 percent of their annual revenue. Participating restaurants must commit to increasing their worker's non-tipped wages to \$15/hour by 2026. Grants will be distributed to participating restaurants in \$10,000 increments for each 500 free meals they serve for

community members in need, with a maximum grant size of \$30,000 per establishment. Restaurants

# State of Illinois Finishes First Among Populous States and Seventh Nationwide in 2020 Census Count



Governor Pritzker and the Illinois Department of Human Services (IDHS) announced the results

of the 2020 Census in Illinois and celebrated the over 400 nonprofits and organizations that

helped Illinois exceed its 2010 self-response rate during the pandemic. Illinois finished seventh

nationwide and first among states with over 9M in population size in self-response rates. Illinois Census grantees worked with IDHS get a complete count despite unforeseeable challenges, including the ongoing COVID-19 pandemic. With their help, Illinois surpassed the 2010 self-response rate of 70.5 percent, finishing at 71.4 percent. A self-response rate is the percentage of homes known by the U.S. Census Bureau that completed the census survey on their own. Chicago also outperformed most large cities with populations over 2M (Los Angeles, Houston, and Philadelphia), with New York City being the only city that outperformed

Chicago. Cook County also surpassed its 2010 self-response rate. On June 2019, the Pritzker Administration created the inaugural Illinois Census Office and established an

## CVS Health Begins Administering COVID-19 Vaccines in Long-Term Care Facilities



CVS Health (NYSE: CVS) has formally launched its COVID-19 vaccination program for long-term care facilities, whose residents have been disproportionately impacted by the pandemic. CVS Pharmacy teams will administer the first dose of the Pfizer vaccine in facilities across 12 states this week, and the company expects to vaccinate up to four million residents and staff at over 40,000 long-term care facilities through the program. CVS Pharmacy teams will make three visits to each long-term care facility to ensure residents and staff receive their initial shot and critical booster. The majority of

residents and staff will be fully vaccinated three to four weeks after the first visit, depending on which vaccine they receive. CVS Health expects to complete its long-term care facility vaccination effort in approximately 12 weeks. The long-term care facility vaccination effort is a precursor to the eventual availability of COVID-19 vaccines at all CVS Pharmacy locations throughout the country subject to product availability and prioritization of populations, which will be determined by states. # Senate committee discusses pandemic protocol in Illinois prisons



Testifying before the Senate State Government Committee Friday, Illinois Dept. of Corrections Director Rob Jeffreys said the state's prison system is working closely with state public health authorities to respond to the challenges posed by the COVID-19

pandemic. State Senator Pat McGuire, Vice-Chair of the committee, led the hearing Friday and asked IDOC personnel about the department's progress in processing prisoners for intake and release more efficiently, COVID-19 protocols, and efforts to

adapt the prison system's education programs to the realities of the pandemic. "We learned at today's hearing of steps DOC has taken to spend tax dollars more wisely, to ensure educational programs continue in our prisons during the pandemic,

and to protect staff and incarcerated men and women from COVID-19," McGuire said. "However, much remains to be done. Legislators of both parties pledged to work with DOC on the vital work which lies before us." IDOC is also partnering with local community colleges to set up distance learning programs for inmates, said Alyssa Williams, Chief of Programs and Services. State Senator Robert Peters (D-Chicago) asked how inmates are being directed to follow health and safety guidelines. Jeffreys said inmates are issued masks, hand sanitizer, and directed to frequently wash their hands. "We have had a difficult year, but it has been particularly hard for folks in congregate settings like our state prisons," Peters said, following his participation in the

hearing. "Incarcerated people deserve the ability to see their families, which is why we need quick turnaround for time served. They deserve the right to learn, grow, and be challenged mentally, which is why we need to

keep up IDOC education programs, and they deserve a healthy and safe living environment, which is why we need to need to limit lockdowns and increase fresh air time, especially during a pandemic."

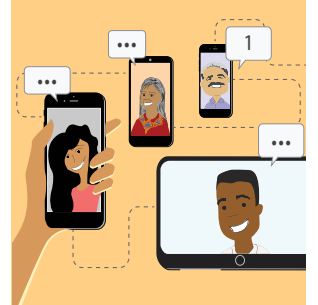
