

State Launches Training Program to Increase Human Trafficking Awareness

January is Human Trafficking Awareness Month, and the Illinois Department of Children and Family Services (DCFS) is reminding the public that human trafficking is not something that only happens to people in other countries but occurs

every day across Illinois to children whose average age is 14. To coincide with Human Trafficking Awareness Day, the department launched a new online human trafficking training for DCFS and private agency partner staff. The mandatory training encompasses key concepts

and terminology; signs that a youth may be a victim of human trafficking or at risk of being trafficked; experiences of trafficked youth in foster care; and techniques child welfare professionals can use to support youth who have been trafficked. In Fiscal Year 2020, Illinois DCFS

investigated 239 allegations of human trafficking of children – though experts believe the number of incidents that occurred during that time is

Los Maestros de Cicero se Niegan a Regresar a Salones Inseguros

La mayoría de maestros en el Distrito Escolar 99, que fueron encuestados el fin de semana, han escogido seguir enseñando en forma remota a pesar de la directiva del distrito de que regresen a las aulas el 11 de enero. "Al pedirnos que regresemos a las aulas en medio de la pandemia, el Superintendente Rodolfo Hernández y la Junta de Educación del Distrito 99 no ponen como prioridad la seguridad de nuestros maestros y el personal escolar", dijo Rachel Esposito, presidenta del Concilio de Cicero. "Por nuestra propia seguridad, no tenemos otra alternativa sino rechazar el plan del Distrito de regresar al salón de clases esta semana. Debemos defender nuestros derechos.

Los educadores que se han negado a regresar a los edificios continuarán enseñando en forma efectiva desde lugares remotos, como lo han estado haciendo desde el inicio de la pandemia. Las escuelas de Cicero atienden aproximadamente a 11,000 estudiantes, predominantemente de familias latinas que han sido golpeadas despiadadamente por el COVID-19. Hasta el 7 de enero, el índice de positividad del COVID en la comunidad es cerca del 13 por ciento, considerablemente más alto que el índice recomendado

higher. Often, victims of human trafficking do not seek help because they are fearful, ashamed of their situation, distrust law enforcement or become dependent on the perpetrator.

Know The Signs. A trafficked child might:

- Have an adult control them by speaking for them
- Seem out of place given the time of day or night

- Look disheveled or dressed in clothes that they could not afford to buy

- Show signs of physical abuse such as bruising or red marks
- Not possess any form of identification
- Perform inappropriate work for their age and not be compensated



Anyone who believes a child might be trafficked, or in danger of being trafficked, should immediately call 911 and the Child Abuse Hotline at 1-800-25-ABUSE (800-252-2873).

Lentil Vegetable Soup



Ingredients

- 1.1 pound French green lentils
- 2.4 cups chopped yellow onions (3 large onions)
- 3.4 cups chopped leeks, white part only (2 leeks)
- 4.1 tablespoon minced garlic (3 cloves)
- 5.1/4 cup good olive oil, plus additional for drizzling on top
- 6.1 tablespoon kosher salt
- 7.1 1/2 teaspoons freshly ground black pepper
- 8.1 tablespoon minced fresh thyme leaves or 1 teaspoon dried
- 9.1 teaspoon ground cumin
- 10.3 cups medium-diced celery (8 stalks)
- 11.3 cups medium-diced carrots (4 to 6 carrots)
- 12.3 quarts chicken stock
- 13.1/4 cup tomato paste
- 14.2 tablespoons red wine or red wine vinegar
- 15.Freshly grated Parmesan cheese

Directions

1. In a large bowl, cover the lentils with boiling water and allow to sit for 15 minutes. Drain.
2. In a large stockpot on medium heat, saute the onions, leeks, and garlic with the olive oil, salt, pepper, thyme, and cumin for 20 minutes, until the vegetables are translucent and very tender. Add

the celery and carrots and saute for 10 more minutes. Add the chicken stock, tomato paste, and lentils. Cover and bring to a boil. Reduce the heat and simmer uncovered for 1 hour, until the lentils are cooked through. Check the seasonings. Add the red wine and serve hot, drizzled with olive oil and sprinkled with grated Parmesan.
