

Chicago Latino Film Festival Announces Annual Poster Competition Winner

The International Latino Cultural Center of Chicago (ILCC), producer of the Chicago Latino Film Festival (CLFF), is proud to announce that New York-based graphic designer and marketing manager Natalia Osorio Quintero is the winner of their annual poster competition. Presented by Corona Extra and featuring close to 100

short and feature length films from Mexico, Central and South America, the Caribbean, Spain, Portugal and the United States, the 37th Chicago Latino Film Festival this year will be presented online and will feature two special Drive-In screenings in accordance with state and city health regulations. The Festival will run April 8-18. The

full program, including the Drive-In screenings, will be announced in March. Three raised fists, representing Ibero-America's racial diversity, each grasping a different film or digital camera, are the centerpiece of the winning design. "This poster is inspired by the resilience and strength of the Latino people. Latinos have experienced the

struggle for their rights and for being recognized as a diverse culture, rich in customs, race, and talent. For this reason, the fist symbolizes the courage we have to achieve our goals and the unity of the races because all lives are worth it," said Natalia Osorio. Lieutenant Governor Juliana Stratton and State Representative Delia Ramirez publicly released the concluding report and recommendations from the Task Force on Children of Incarcerated Parents on Wednesday morning. "The consequences of incarceration reverberate for generations to come, and the trauma of parental incarceration for children is often ignored," said Lt. Governor Juliana Stratton. "The recommendations of this Task Force are an important step towards creating a more equitable future for all Illinois children, and I am grateful to the Task Force for its work on these important issues." The Task Force was created through legislative statute in 2019 for the




purpose of developing recommendations to address the effects of incarceration on families throughout Illinois.

Led by State Rep. Delia Ramirez and Lt. Gov. Juliana Stratton's Justice Equity and Opportunity Initiative, the task force included 25 members

of state and local law enforcement, legislators, the adult and juvenile corrections systems, members of the academic community, individuals who had been incarcerated, and children of incarcerated parents. Cabrini Green Legal Aid provided subject



5 Day Comment Period PY 2019 CDBG Amended Action Plan

All citizens and other interested parties are hereby notified that the City of Berwyn has prepared its second PY 2019 CDBG Amended Action Plan which began on October 1, 2019. The City will now expend approximately \$1,491,720 of CDBG FY 19 funds and \$1,107,768 of CDBG-CV funds made available through the CARES Act. These funds will benefit persons of low and moderate income as well as all the Citizens of Berwyn. The PY 2019 Amended Action Plan lists priority needs for a viable community with decent housing, suitable living environment and expanded economic opportunity. The PY 2019 Amended Action Plan will address economic development, housing rehab, public services and public infrastructure and facilities. The CARES Act eliminates the cap on the amount of funds a grantee can spend on public services, removes the requirement to hold in-person public hearings in order to comply with national and local social distancing requirements and allows grantees to be reimbursed for COVID-19 response activities regardless of the date those costs were incurred.

Copies of the amended **2019 Amended Annual Action Plan** in draft form, will be available for review and comment beginning February 1, 2021 and ending on February 9, 2021. This will allow the public to make comments or suggestions regarding COVID-19 related needs and use of these funds. Copies are available on the City's Web site www.berwyn-il.gov, the amended PY 2019 Amended Annual Action Plan will be presented to the Committee of the Whole, and thereafter to the City Council for final approval, on Tuesday, February 9, 2021.

Loretto Hospital Begins Administering COVID-19 Vaccines

The Loretto Hospital in Chicago's Austin neighborhood began administering Phase 1B COVID-19 vaccines to eligible community members. This includes individuals age 65 and older, and frontline essential workers, such as first responders, teachers, and public transit, manufacturing, postal and grocery store personnel, among others. Vaccinations will be provided from 9 a.m. to 3 p.m., Monday through Friday, by appointment only. To register, eligible individuals must call Loretto's 24/7 vaccine scheduling hotline at (773) 996-7937 and complete both an appointment form and CDC pre-vaccination checklist. Rep. García Re-Introduces the New Way Forward Act

**NEW WAY FORWARD ACT
RE-INTRODUCTION**

On Tuesday, Representatives Jesús "Chuy" García (IL-04), Ayanna Pressley (MA-07), Pramila Jayapal (WA-07), Karen Bass (CA-37), and 35 Members of Congress introduced the New Way Forward Act, a piece of legislation designed to address the fractured U.S. immigration system. The New Way Forward Act rolls back harmful immigration laws that result in racial profiling, disproportionate incarceration, deportation, and separation of immigrant families and communities of color.

This legislation also aims to restore fundamental principles of due process and compassion to our immigration system. "The New Way Forward Act gives us a historic opportunity to end the criminalization of desperation and end the scourge of family separation. At this moment of reckoning with our nation's racist history, we must ensure Latino, Black, and AAPI communities, including immigrant families, are no longer criminalized for seeking a better future," said Congressman García. "Too many families in Chicago

and across our country are ripped apart by racist, anti-immigrant laws used to justify deportation and mass incarceration. It's time we reimagine an immigration system guided by justice and compassion, restore the fundamental principles of due process to keep families together, and dismantle the prison to deportation pipeline. It's time we chart a New Way Forward so that all immigrants are treated with the full dignity and respect we all deserve."

"As America begins a new presidential administration, we need to finally leave our country's long history of criminalizing immigration and separating families behind," said Congresswoman Jayapal. "As one of only 14 naturalized citizens in Congress, I am proud to co-lead the New Way Forward Act as an urgent effort to restore due process to immigrants, end detention without bail, separate policing from immigration enforcement and outright repeal laws that make migration a crime. New Americans not only deserve to live with dignity and without fear, but they also deserve the same rights as native-born Americans so they have the opportunity to make their own American dream a reality."

en la materia y apoyo al Grupo de Trabajo. Las recomendaciones incluyen: asegurar las opciones de visitas familiares en todas las instalaciones de detención del estado, involucrando a los jóvenes en el desarrollo de entrenamiento para aplicación de la ley e implementar políticas para reducir traumas en todos los puntos de contacto. "Ha sido un honor y una experiencia servir en el Grupo Trabajo para Hijos de Padres Encarcelados", dijo la Rep. Estatal Delia Ramírez, "Nuestra meta ha sido y continuará siendo, centrar las voces de las personas impactadas por la encarcelación de los padres. En el desarrollo de soluciones políticas que aborden estos problemas. Implementar las recomendaciones en este reporte nos ayudará a atender mejor las necesidades de los niños y las familias impactados por la encarcelación de los padres". Entre las recomendaciones hechas por la Rep. Ramírez se encuentran:

- Algo que pienso es integral a todos los elementos de las recomendaciones es la infraestructura tecnológica para hacer que esto ocurra. También quiero resaltar el problema de las guarderías de la prisión, que no acuden a todas nuestras conversaciones. Estoy pensando sobre la importancia de preservar a una familia en esta situación. Realmente no hablamos de los padres embarazados y que tienen contacto piel con piel antes de que nazca un niño. Creo que es muy importante destacar esto.

•Una pregunta que tuve

cuando miramos la colaboración entre las agencias estatales, es que noté que las escuelas no son mencionadas específicamente. No necesariamente compartiendo datos, pero cuando hablamos sobre entrenamiento y colaboración entre las agencias estatales, ¿No deberíamos incluir un juego de estrategias para que los educadores trabajen con niños que tienen a sus padres encarcelados?

- Yo creo que las guarderías de la prisión son verdaderamente importantes. Hay una investigación que sugiere que tanto los padres como los hijos se benefician con tal experiencia. Sé que hay algunos programas con una guardería en la prisión, pero ver como ampliarla para ponerla a la disposición a más mujeres embarazadas podría ser realmente importante y deberíamos hacer algo.

"El acta *New Way Forward Act* nos da la oportunidad histórica de terminar la criminalización de la desesperación y termina el flagelo de la separación de familias. En este momento en que se debe tener en cuenta la historia racista de nuestra nación, debemos asegurarnos que las comunidades latinas, negras y AAPI, incluyendo a las familias inmigrantes, no son criminalizadas por buscar un mejor futuro", dijo el Congresista García. "Demasiadas familias de Chicago y en todo nuestro país, están separadas por el racismo, las leyes anti-inmigrantes utilizadas para justificar la deportación y la encarcelación masiva. Es hora de que re-imaginemos un proceso para mantener las familias juntas y desmantelar la prisión a la línea de deportación. Es hora de que diseñemos un *Nuevo Camino a Seguir* como esfuerzo urgente de restauración debido al proceso a los inmigrantes, terminar la detención sin fianza, separar la vigilancia policial de la aplicación de la ley de inmigración y derogar por completo las leyes que tipifican la migración como delito. Los Nuevos Estadounidenses no solo merecen vivir con dignidad y sin temor, sino que merecen los mismos derechos que los estadounidenses nativos, para que tengan la oportunidad de hacer realidad su propio sueño americano.

Illinois Marks Worst Year for Jobs in 2020

Illinois saw its worst year for jobs on record, according to analysis from the Illinois Policy Institute. Recent data shows Illinois lost 423,300 jobs in total from December 2019 to December 2020, or about 6.9 percent decrease. Leisure and hospitality sector jobs were hurt the most during the year, down 198,100 jobs, or 31.7 percent. That job sector experienced nearly half or all job losses in the state during 2020. Every sector in the state economy saw a decline over the year, except for construction employment which rebounded in December 2020.

Illinois' monthly job numbers:

According to new Illinois Department of Employment Security data, Illinois lost 2,500 jobs from mid-November to mid-December, marking the second consecutive month of job losses for the state. Hardest hit was the leisure and hospitality sector, which lost 40,900 jobs during the first full



month of the reinstated ban on indoor dining. The only other sectors of the economy that shed jobs were the information sector with 1,300 job losses and

"other services" with 800 job losses. The national economy also stalled in December, shedding 140,000 total jobs. It was the first month of national

matter expertise and support to the Task Force. Recommendations include: ensuring family visitation options at all detention facilities statewide, involving youth in the development of training for law enforcement, and implementing policies to reduce trauma at all points of contact. "It has been an honor and a humbling experience to serve on the Task Force for Children of Incarcerated Parents" State Rep. Delia Ramirez stated, "Our goal has been, and continues to be, centering the voices of individuals impacted by parental incarceration in the development of policy solutions that address these issues. Implementing the recommendations in this report will help us

to better meet the needs of children and families impacted by parental incarceration." Among the recommendations made by Rep. Ramirez are:

- One thing I think is integral to all the elements of the recommendations is the technological infrastructure to make this all happen. I also want to raise the issue of prison nurseries, which didn't come up a lot in our conversations. I am thinking about the importance of preserving a family in this situation. We really didn't talk about pregnant parents and that they have skin-on-skin contact before a child is born. I think this is really important to highlight.

- One question I had is when we're looking at collaboration between state agencies. I noticed that schools aren't specifically mentioned. Not necessarily data sharing, but when we're talking about training and collaboration between state agencies, maybe it would include a set of tools for educators to work with children who have parents incarcerated?
- I think that prison nurseries are really important. There's research out there that suggests that both parents and children benefit from that experience. I know there are some programs with a prison nursery, but looking into how to expand that to be available to more pregnant women would be really important and something we should do.



1. Heat the olive oil in a medium saucepan over medium heat; add all the vegetables, garlic and onion. Season with the salt, and cook until tender, about 6 minutes. Add the pasta and cook until slightly toasted and golden, about 2 minutes. Add broth, and bring to a boil over high heat. Cook, covered, until pasta is just tender, about 8 minutes.

2. Stir in whatever herb suits you (or your young eater) and lemon juice. Season with pepper and additional salt, to taste. Fill thermos, pack in a lunch sack with crackers and cheese sticks and send off to school.
