Alivio Medical Center Expands COVID Efforts in Berwyn with Help from BOA Grant



Bank of America has awarded Alivio Medical Center a \$150,000 grant to enhance its coronavirus testing capabilities, launch contract tracing efforts and provide critical financial support as it collaborates with other nonprofit healthcare entities to distribute vaccines to underserved populations in the Berwyn community. The grant is part of Bank of America's \$1 billion,

four-year commitment to address economic and racial inequality exacerbated by the global pandemic. Alivio Medical Center is a bilingual, bicultural organization committed to providing access to quality low-cost health care to the Hispanic community, the uninsured, and the underinsured, and not to the exclusion of other cultures and races. The grant will

specifically support Alivio Medical Center's Berwyn community by providing assistance in the following categories: •**Testing:** The positivity rate of Alivio patients is currently at over 30 percent at the Berwyn location, much higher than the city's average of 13 percent. Bank of America's grant will allow the team to add a full-time contact tracer at 100 percent and a full

time mid-level provider at 50 percent.

•**Outreach:** The Alivio team recently launched a virtual platform called "Alivio Para La Comunidad" on Facebook to provide workshops and seminars about all services provided by Alivio and issues that affect the community, including coronavirus. Bank of America's funding will allow the team to purchase new video equipment,

which will allow them to quickly mobilize to record

messaging to keep up with the evolving guidelines.

Castro excited for new role as Chair of Executive Committee

The Senate Executive Committee for the 102nd General Assembly will have new leadership, as State Senator Cristina Castro (D-Elgin) was announced as its Chair. "I am honored to have been selected to Chair the Executive Committee, and I am excited to get to work solving some our state's most pressing issues," Castro said. "Some of the most influential and impactful bills come through that Committee, and the debate they inspire is always informative and often persuasive. It will be a challenging role, but it's one that I know I can handle and I'm looking forward to seeing what proposals my colleagues bring to the table." The Senate Executive Committee typically handles some of the more complex pieces of legislation that hit the Senate. The landmark



cannabis legalization package went through the Executive Committee, as did every pillar of the Black Caucus agenda during the closing days of the 101st General Assembly. "I want to thank President Harmon for the opportunity to Chair such an important committee, and I am confident that our work will help secure a brighter future for everyone in Illinois," Castro said. Castro has previously served as Chair of the Revenue Committee and the Veterans Affairs Committee.

CTA, CPS Announce Scholarship Fund



The Chicago Transit Authority (CTA), and Chicago Public Schools (CPS) on Monday announced that new applications are now being accepted for the "CTA Elevating Futures Scholarship Fund", an innovative program that provides a path for economically disadvantaged youth to pursue education and careers in construction

and engineering. The "CTA Elevating Futures Scholarship Fund" was created by CTA in 2019 and is now in its second year. Walsh-Fluor is funding the program with \$250,000 for 10 scholarships between 2020 and 2023. Students who are awarded scholarships are also eligible to apply for paid summer internships with Walsh-Fluor.

Program details and

timeline

- The application period opened Dec. 10, 2020 and applications will be due March 1, 2021. To apply, www.chicagoscholars.org/elevatingfutures.
- Up to three scholarships will be awarded of \$5,500 a year for four years per winner.
- Scholarship winners will be announced on April 15, 2021.
- Eligible students must be enrolled in a CPS or CPS-supported high school and currently part of the Chicago Scholars program. Chicago Scholars recruits from all 77 community areas of the city and has student representation from 75 CPS and CPS-supported high schools.
- Eligible students must be enrolled in STEM coursework, have a grade point average of at least 3.0, and have a good attendance record.

Shedd Aquarium Reopens



With the announcement that Chicago has now moved into Tier 2 mitigation standards, Shedd Aquarium is preparing to safely reopen its doors, after 70 days of closure, to the general public on Saturday, Jan. 30th. As Shedd welcomes

guests back to its 276,000 square feet of public space, staff will continue to employ the same stringent health and safety measures that allowed guests to come up close to everything from leopard sharks to sea turtles over the summer of 2020. This includes highly

limited building capacity, online purchasing of timed tickets to entry, mask requirements, hand sanitizer stations, one-directional pathways and enforcing any active travel advisories for the city and state. For those who aren't ready to make a visit to the building, there are still several ways to connect with the aquatic animals at Shedd. Virtual animal encounters and programs that allow guests to explore the aquatic animal world from the comfort and safety of their homes can be booked via Shedd's, www.sheddaquarium.org. Timed tickets may also be purchased on the Shedd's website.





Vegetable Noodle Soup



Ingredients

1.2 tablespoons extra-virgin olive oil
2.1 rib celery, sliced (about 1 cup)
3.1 medium carrot, sliced (about 3/4 cup)
4.1 clove garlic, smashed
5.1/4 medium onion, about 1/2 cup
6.1/4 teaspoon kosher salt
7.1/3 cup orzo or other small pasta or egg noodles or broken up spaghetti
8.4 cups low-sodium chicken broth (1-quart box, or 2 cans)
9.Small handful fresh parsley leaves, basil or dill, chopped (about 2 tablespoons)
10.1/2 lemon, juiced (about 1 tablespoon)
11.Freshly ground black pepper

Directions

1.Heat the olive oil in a medium saucepan over medium heat; add all the vegetables, garlic and onion. Season with the salt, and cook until tender, about 6 minutes. Add the pasta and cook until slightly toasted and golden, about 2 minutes. Add broth, and bring to a boil over high heat. Cook, covered, until pasta is just tender, about 8 minutes.
2.Stir in whatever herb suits you (or your young eater) and lemon juice. Season with pepper and additional salt, to taste. Fill thermos, pack in a lunch sack with crackers and cheese sticks and send off to school.


