

Parent Group Calls on CPS to Reopen

As the Chicago Teachers Union and Chicago Public Schools continue to clash over the return of in-person learning, a new group has emerged in an effort to give a platform for concerned parents. A newly-formed parent group in Chicago is calling on the Chicago Teachers Union (CTU) and Chicago Public Schools (CPS) to open as soon as

possible. During a virtual press conference, which included CPS parents and students, the Chicago Parents Collective insisted that in-school learning can be done safely.

"We're not dismissing safety concerns of teachers, but health experts say schools are not major spreaders and they can open safely. They've had a year to figure this out. Our children have waited long enough," said

founder of the Chicago Parents Collective Ryan Griffin. Several other parents and CPS children spoke and shared stories of stressed children overwhelmed by on-line learning and missing social interaction. They pointed out that many private schools and day care centers are open and are not experiencing surges in the number of infected people. CPS parent Anne-Laure Justeau, a teacher in a public

school in a Chicago suburb where she has been teaching in-person since October stated, "The first step for a teacher to teach hybrid is to go back to the school building. It was a little scary at the beginning to just go back to school but I got used to it. We practice social distancing, we wear masks. Now it's just routine."

A CPS 7th grader named Maddox said, "Remote

learning has been hard. Although my teachers are doing their best, a lot is lost in remote learning. It is hard to get feedback from teachers like you would in a classroom. I often feel lost during lessons and have to catch up later."

The parent group formed a few weeks ago when they started to hear talk of a teacher strike. Approximately 6 in 10 CTU members have voted to keep remote-only education unless their reopening conditions are met. Licensed Clinical Psychologist and CPS parent, Dr. Kati Wax added, "In my opinion there is just too much shaming of people and putting people against each other, so I would implore both teachers and parents to stop the bullying and blaming, especially in front of our kids."

In a statement to press in regards to an agreement between CTU and CPS, CTU shared the following, "It's heartening that the mayor and CPS have agreed to continue bargaining tomorrow, Tuesday, as our members continue to teach and work remotely. We are not locked out today or tomorrow because of our members' unity, their commitment to their school communities, and their fearless solidarity. "We don't want a strike. We want to keep working remotely as we bargain an agreement to return to our classrooms safely. And we're one step closer to that goal today, because management has agreed to stay at the table rather than escalating conflict or locking out educators."

Pritzker Tours Vaccination Center at Morton East High school

Illinois Gov. J.B. Pritzker toured a state designated vaccination site on Thursday, Jan. 28th located at Morton East High school, 2423 South Austin Boulevard, in the Town of Cicero. Pritzker announced during the tour that the state will receive \$45 million from the Federal Emergency Management Agency (FEMA) to increase local health departments' vaccination efforts. "The capacity to deliver, to administer vaccines across the state is significantly increasing," Pritzker said. The governor cited a drive-thru facility located in Lake County he said will administer 1,000 vaccines a day.

Joining Pritzker during the tour was Morton High School Supt. Dr. Tim Truesdale, Morton High School Board President Jeffrey Pesek, Cook County Board President Toni Preckwinkle, State legislators Lisa Hernandez and Michael Zalewski, and Cicero officials including Clerk Maria Punzo-Arias, Senior Director Diana Dominick and the Illinois Adjutant General Richard R. Neely.

Cicero's Health Department has administered 2,000 vaccinations during the past week at the Cicero Community Center. Individuals receiving the vaccination were required to schedule an appointment with the Health Department using the Town's website and completing a special vaccination form. But hundreds of people showed up hoping that vaccinations might be available to walk-ins and without an appointment. "It was important for the Governor to see how Cicero is doing everything it can to administer the vaccinations as efficiently as possible," Maria Punzo-Arias said. "The governor's presence here today shows that he wants to do everything he can to



get everyone in the state vaccinated."

Under the Illinois Department of Public Health guidelines only individuals listed in the Category 1A and 1B designations can receive the vaccine. That includes first responders, health care workers, employees and individuals 65 years of age and older.

Diana Dominick said that the Senior Center was helping to coordinate the vaccinations among the town's senior citizen community. "We are

helping seniors to schedule their appointments and as more vaccinations come in and are made available to the Town of Cicero, we will eventually be able to ensure that every senior gets their vaccination for the COVID-19 virus," Diana Dominick said. Also attending the tour with the governor were Cook County Health CEO Israel Rocha, Jr., and Cook County Director of External Affairs Sandra Lewis.

Comunitario de Cicero. Se requiere que las personas que reciban la vacuna hagan una cita con el Departamento de Salud, utilizando la red del Municipio y completando una forma de vacunación especial. Pero cientos de personas se presentaron esperando que hubiera vacunas disponibles sin previa cita. "Era importante que el Gobernador revisara todo lo que está haciendo Cicero para poder administrar las vacunas con la mayor eficiencia posible", dijo María Punzo-Arias. "La presencia del Gobernador aquí hoy muestra que desea hacer todo lo posible para que todos en el estado puedan ser vacunados".

Bajo las guías del departamento de Salud Pública de Illinois, solo las personas anotadas en las designaciones Categoría

1A y 1B pueden recibir la vacuna. Eso incluye a los socorristas, trabajadores de cuidado de salud, empleados y personas de 65 años en adelante.

Diana Dominick dijo que el Centro de Seniors está ayudando a coordinar la vacuna entre la comunidad de personas mayores del municipio. "Estamos ayudando a las personas mayores a programar sus citas y cuando lleguen más vacunas y estén disponibles para el Municipio de Cicero, podremos eventualmente garantizar que toda persona mayor recibe la vacuna para el virus del COVID-19", dijo Diana Dominick. En el recorrido con el gobernador estuvieron también el CEO de Cook County Health, Israel Rocha, Jr., y la directora de Asuntos Externos del Condado de Cook, Sandra Lewis.

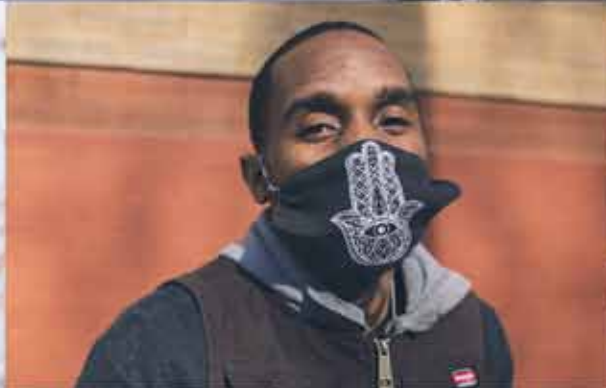
