City of Chicago Launches 2021 One Summer Chicago Application

The Chicago Department of Family and Support Services (DFSS) on Monday announced the launch of the 2021 One Summer Chicago (OSC) application. OSC 2021 will run from July 5 to August 13 and will include remote and socially-distanced, in-person job and life-skills training for youth ages 14 to 24. The application deadline is Friday, June 11 at OneSummerChicago.org. Over 21,000 slots are available. For Summer 2021, young people will be compensated for



participating in career exploration opportunities in fields such as coding and tech, healthcare, media and more. Returning this year under the OSC portfolio include the Chicago Youth Service Corps (CYSC), Everyone Can Code, Photography for all programs and more.



State to Provide Unprecedented Funding to Illinois Schools

On Wednesday, Governor Pritzker unveiled an ambitious plan for school districts K-12 across Illinois. Approximately, \$7 billion in federal funding will go to support students as they return to the classroom after distance and remote learning due to pandemic. Education experts were asked to share best practices and recommendations to best support students, “including academic and behavioral counseling; out-of-classroom experiences like high-value tutoring, after school programs and summer camps; and creating individualized student profiles to craft the best plans for all students.” The results are currently available online through the P-20 Council’s Learning Renewal Resource Guide. Recommendations are available online through the P-20 Council’s 180-page guide is filled with ideas from experts and stakeholders from across the state to help school districts renew learning and provide ongoing feedback. “If you’re a parent, I know you’ve spent most of this

pandemic worried about how your kids are learning – with all the screens and Zooms, sometimes you’re worried about whether they’re learning at all,” said Governor JB Pritzker. “My administration is taking a little bit of that worry off your plates. I’m committed to making sure that Illinois leads the nation in assisting schools to make this new \$7 billion count over the next several years to overcome the pandemic’s effects on our students, parents and educators.” The latest round of federal funding for schools, through the American Rescue Plan, allocates more than \$5 billion for pre-K through 12th grade education in Illinois, 90 percent of which will flow directly to school districts. Illinois’ education system has been awarded more than \$7.8 billion in federal pandemic relief funding in total over three rounds of the Elementary and Secondary School Emergency Relief Fund program, with \$7 billion flowing directly to school districts over the next three years.

The Learning Renewal Resource Guide details 12 strategies – each

supported by research, stakeholder feedback, and case studies – that districts and higher education institutions should consider to equitably address the pandemic’s short- and long-term impacts. Each of the 12 strategies contain underlying initiatives, implementation guidance, and estimated costs and impacts. Altogether, the guide serves as a tool to reinvigorate in-person learning opportunities for students through a reimagined school calendar and includes investments to identify and meet each student’s individual needs from preschool through college and career. “We have an unprecedented opportunity through this federal funding to transform the quality of learning opportunities for all our students,” said State Superintendent of Education Dr. Carmen I. Ayala. “This guide provides a roadmap for how our education system can emerge from the pandemic stronger, with even greater capacity to close gaps and achieve equity. That journey begins with getting students back into the classroom as soon and as much as possible.”

El Estado Dará Fondos sin Precedentes a las Escuelas de Illinois

El miércoles, el Gobernador Pritzker reveló un plan para distritos escolares K-12 en Illinois. Aproximadamente, \$7 mil millones en fondos federales serán para apoyar a los estudiantes cuando regresen al salón de clases después del aprendizaje remoto y la distancia debido a la pandemia. Se pidió a expertos en educación que compartan las mejores prácticas y recomendaciones para poder apoyar mejor a los estudiantes, “incluyendo consejería académica y de comportamiento; experiencias fuera del salón de clase, como tutoría de alto valor, programas para después de la escuela y campamentos de verano; y creando perfiles estudiantiles individualizados para lograr los mejores planes para todos los estudiantes”. Los resultados están actualmente disponibles en línea a través de P-20 Council’s Learning Renewal Resource Guide. Recomendaciones disponibles en línea a través de P-20 Council’s Learning Renewal Resource Guide, llena de ideas de expertos y partes interesadas de todo el estado para ayudar

a los distritos escolares a renovar el aprendizaje y proveer comentarios continuos.

“Si usted es un padre de familia, se que ha pasado la mayor parte de esta pandemia preocupado de como están aprendiendo sus hijos – con todas las pantallas y Zooms, algunas veces se preguntará si no están aprendiendo nada”, dijo el Gobernador JB Pritzker. “Mi administración está quitando un poco de esa preocupación de sus mentes. “Estoy comprometido a asegurarme que Illinois encabeza la nación en ayuda a las escuelas, para hacer que este nuevo fondo de \$7 mil millones cuente en los próximos años para vencer los efectos de la pandemia en nuestros estudiantes, padres y educadores”. La última ronda de fondos federales para las escuelas, a través del Plan de Rescate Estadounidense, ubica más de \$5 mil millones para educación de pre-K al 12º grado en Illinois, 90 por ciento de los cuales irán directamente a los distritos escolares. El sistema educativo de Illinois ha recibido más de \$ 7.8 mil millones en fondos federales de ayuda

pandémica en total durante tres rondas del programa del Fondo de Ayuda de Emergencia para Escuelas Primarias y Secundarias con \$ 7 mil millones fluyendo directamente a los distritos escolares durante los próximos tres años.

La Guía de Recursos Renovables de Aprendizaje detalla 12 estrategias – cada una de ellas apoyada por investigaciones, opiniones de partes interesadas y estudios del caso – que instituciones de distritos y educación superior deberían considerar para atender equitativamente los impactos de la pandemia a corto y largo plazo. Cada una de las 12 estrategias contiene iniciativas subyacentes, guía de implementación y costos e impactos estimados. En general, la guía sirve como una herramienta para revitalizar las oportunidades de aprendizaje en persona para los estudiantes a través de un calendario escolar reinventado e incluye inversiones para identificar y satisfacer las necesidades individuales de cada estudiante, desde el preescolar hasta la universidad y la carrera. Tenemos una oportunidad sin precedentes a través

de estos fondos federales para transformar la calidad de las oportunidades de aprendizaje para todos nuestros estudiantes, dijo la Superintendente Estatal de

Educación, Dra. Carmen I. Ayala. “Esta guía nos proporciona un mapa sobre cómo nuestro sistema educativo puede salir de la pandemia más fuerte, con

una capacidad aún mayor para cerrar brechas y lograr la equidad. Ese viaje comienza con hacer que los estudiantes regresen al aula lo antes posible”.

Two New Mass Vaccination Sites to Open in Chicago

The City of Chicago announced that two new mass vaccination sites will open in Chicago on April 5, with the city now in phase 1c of COVID-19 vaccine eligibility. The sites will be located at Chicago State University and the American Airlines Conference Center at Gallagher Way next to Wrigley Field. The City's new mass vaccination site at Chicago State University will be overseen by the Chicago Department of Public Health, with CORE (Community Organized Relief Effort) operating the site and vaccine administered by Howard Brown Health. At full capacity, it will serve 1,200 walk-up and 1,000 drive-thru vaccination appointments a day. The site is by appointment only, there is no on-site registration. The site will operate six days a week. Monday through Friday from noon through



6p.m. and Saturdays from 9a.m. through 3p.m. The mass vaccination site at the American Airlines Conference Center at Gallagher Way next to Wrigley Field will be operated by Advocate Aurora Health. It will have capacity to administer approximately 2,000 doses a day. The site is by appointment only, there is no on-site registration. Registration for vaccination appointments at both Chicago State University and the American Airlines Conference Center at Gallagher Way will be available on zocdoc.com/vaccine. Appointments for both mass vaccination

sites will be restricted to Chicago residents, and people will need to bring proof of residency to their appointment. Driver's license, Illinois ID card or REAL ID, City Key Card, library card, postmarked letter, utility bill, voter registration confirmation, Consular ID (Matricula Consular), and many other forms of identification will all be accepted. A complete list of eligible documents is available at Chicago.gov/COVIDVax. The vaccine will be offered at no cost, and insurance is not required. Documentation regarding immigration status is also not required.

City Council Passes 606-Pilsen Demolition Permit Surcharge Ordinance

City Council passed the 606-Pilsen Demolition Permit Surcharge Ordinance which places a surcharge on permits for the demolition of buildings with residential units in the area surrounding the Bloomingdale Trail (The 606) and Pilsen Pilot areas. This ordinance follows the Anti-Deconversion Ordinances for the same areas passed by City Council during the January 2021 meeting and together are designed to reduce displacement of low- to moderate-income residents while also maintaining the existing character and housing stock, specifically in two- to eight-unit buildings that often provide naturally occurring affordable housing units. The ordinance places a \$15,000 or \$5,000 charge



per residential unit, whichever is greater. Funds will support the Chicago Community Land Trust (CCLT), which provides working individuals and families with opportunities to purchase homes at affordable prices. In January, the Anti-Deconversion Ordinances

were passed with a 60-day extension to The 606-area demolition moratorium in order to allow time for passage of the demolition surcharge ordinance. The 606-Pilsen demolition surcharge ordinance will go into effect on April 1, 2021, following the end of the moratorium extension.

Dos Nuevos Sitios de Vacunación Masiva en Chicago

La Ciudad de Chicago anunció dos nuevos sitios de vacunación masiva en Chicago el 5 de abril, con la ciudad ahora en fase 1c de elegibilidad de la vacuna del COVID-19. Los sitios estarán localizados en la Universidad Chicago State y en el Centro de Conferencias de American Airlines en Gallagher Way, junto al Wrigley Field. El nuevo sitio de vacunación masiva de la Ciudad en la Universidad Chicago State será vigilado por el Departamento de Salud Pública de Chicago con CORE (Esfuerzo de Socorro Organizado por la Comunidad) operando el sitio y administrando la vacuna Howard Brown Health. A capacidad total atenderá a 1,200 de personas caminando y a 1,000 personas en auto al día. El sitio es solo con cita, no se puede inscribir en el lugar. El sitio opera seis días a la semana. De lunes a viernes, del mediodía a las 6 p.m. y el



sábado, de 9 a.m. a 3 p.m. El sitio de vacunación masiva en el Centro de Conferencias en American Airlines en Gallagher Way junto al Wrigley Field, será operado por Advocate Aurora Health. Tendrá capacidad para administrar aproximadamente 2,000 dosis al día. El sitio es con cita solamente, no se puede inscribir en el lugar. El registro para citas de vacunas, tanto en la Universidad Chicago State como en el Centro de Conferencias en American Airlines en Gallagher Way, estará disponible en zocdoc.com/vaccine. Las citas para ambos sitios de vacunación masiva estará restringida a los residentes

de Chicago y las personas necesitan llevar prueba de residencia para hacer su cita. La licencia de manejo, la tarjeta ID de Illinois o el REAL ID, la Tarjeta Key de la Ciudad, la tarjeta de la biblioteca, cartas selladas por el correo, cuentas utilitarias, confirmación de registro de votantes, ID Consular (Matricula Consular) y muchas otras formas de identificación, todas ellas serán aceptadas. Una lista completa de los documentos elegibles está a su disposición en Chicago.gov/COVIDVax. La vacuna será ofrecida sin costo alguno y no necesita tener seguro. No necesita documentación sobre su estado de inmigración.

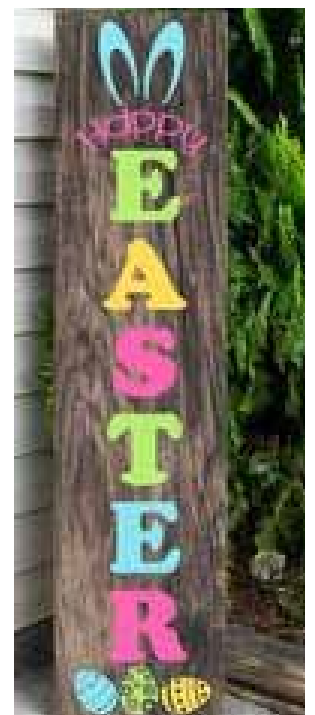
