


ComEd Welcomes New Students to Construction Workforce

Last week, ComEd held its ninth consecutive graduation ceremony celebrating the 90 students who partook in the ComEd CONSTRUCT Infrastructure Academy, an 11-week job training program that increases the number of diverse, skilled candidates for construction and related jobs in Chicagoland and northern Illinois. "As we round out CONSTRUCT's ninth consecutive year, we take great pride in the 11-week training program that we've put together to offer the needed information and guidance to diverse candidates to compete for good-paying, entry-level field and office jobs in construction-related sectors," Laticia Holbert, Workforce Development Manager at ComEd. Since 2013, nearly 600 students have completed the program with 70 percent of them securing employment shortly after graduating – many of them women, African Americans, and Latinos who historically have faced barriers to entering these industries. "CONSTRUCT was not only designed to provide participants with the opportunity to strengthen their job readiness and life skill sets, but it was also created to prepare them for industry-required testing that is often a prerequisite for employment – testing that many of these candidates would not have access to without the program." Lawndale Bilingual News interviewed one of ComEd's CONSTRUCT program newest graduates, Jesse Hernandez who shared his experience and what potential students can expect.

Lawndale Bilingual News:



What circumstances were happening in your life that led you to ComEd's CONSTRUCT program?

Jesse Hernandez: During the time I decided to apply to the program, I really had nothing going for myself. I had just gotten released from my job because of the winter season. I wasn't working and I really had no way to help my family. I had job offers here and there, but they didn't really meet the criteria I was looking for. Then I heard about the CONSTRUCT Infrastructure Academy from a close friend, so I decided to give it a try. A lot of thought came to applying for the program because I knew that it would truly get me closer to what I wanted to do.

Talk to me about your experience in ComEd's CONSTRUCT program? How do you feel it has helped to transform your career?

My experience was great, to be honest! I never knew programs like this existed in my community. So, knowing that it was in my community meant a lot because I didn't have to travel somewhere else

to get this opportunity. The program was always so helpful whenever we needed any kind of support. We eventually had the opportunity to safely meet in person while following COVID-19 safety protocols, which made a huge difference to a lot of us. It showed us

that they went out of their way to guide us through the process and offer a hand when needed.

The CONSTRUCT Infrastructure Academy helped me transform a lot in my career decisions, because I know that I don't always have to settle for



ComEd da la Bienvenida a Nuevos Estudiantes a la Fuerza Laboral de la Construcción

La semana pasada, ComEd tuvo su novena ceremonia de graduación consecutiva, celebrando a 90 estudiantes que tomaron parte en la Academia de Infraestructura CONSTRUCT de ComEd, programa de entrenamiento de empleo, de 11 semanas, que aumenta el número

de candidatos diversos y diestros en construcción y trabajos relacionados en Chicago y el norte de Illinois. "Al completar el noveno año consecutivo de CONSTRUCT, nos enorgullecemos del programa de capacitación de 11 semanas que hemos elaborado para ofrecer la información y orientación necesarias a diversos

candidatos, para competir por un campo y una oficina de nivel de entrada y bien remunerados puestos de trabajo en sectores relacionados con la construcción", dijo Leticia Holbert, Gerente de Desarrollo de Fuerza Laboral de ComEd. Desde el 2013, cerca de 600 estudiantes han completado el programa

con 70 por ciento de ellos consiguiendo un empleo poco después de graduarse – muchos de ellos mujeres, afroamericanos y latinos que históricamente han enfrentado muchas barreras para entrar en estas

industrias. "CONSTRUCT no solo fue diseñado para proveer participantes con la oportunidad de fortalecer su preparación de empleo y destreza en la vida, sino que fue creado también para prepararlos para pruebas

requeridas en la industria que muchas veces es un pre-requisito para empleo – probando que muchos de estos candidatos no habrían tenido acceso sin el programa". Lawndale



Lightfoot, CDPH Announce Request for Proposal to Address Inequities

Mayor Lori E. Lightfoot and the Chicago Department of Public Health (CDPH) announced a Request for Proposals (RFP) to address the impacts of COVID-19 through community-led strategies to promote health and racial equity, starting with targeted vaccine outreach. CDPH has allocated \$9.6 million in COVID-19 relief funding from the Centers for Disease Control and Prevention (CDC) to establish Healthy Chicago Equity Zones – six geographic areas covering the entire city that will be led by regional and community organizations. In 2021, the Healthy Chicago Equity Zones will focus on increasing vaccine uptake in the neighborhoods that have been most impacted by COVID-19. As the city continues to recover from the pandemic, these



coalitions will lead hyper-local strategies to confront factors that contribute to health and racial disparities, including healthcare and social service access, food access, housing

conditions, community safety, and the physical and built neighborhood environment. With this RFP, Healthy Chicago Equity Zones will scale these successful vaccine

equity partnerships across all of Chicago's hardest hit communities. The Healthy Chicago Equity Zones RFP is open for applications through May 28, 2021, at noon.

Lightfoot y CDPH Anuncian Solicitud de Propuesta para Atender Desigualdades

La Alcaldesa Lori E. Lightfoot y el Departamento de Salud Pública de Chicago (CDPH) anunciaron una Solicitud de Propuesta (RFP) para atender los impactos del COVID-19 por medio de estrategias comunitarias para promover la salud y la equidad racial, comenzando con la difusión de vacunas dirigidas. CDPH ha asignado \$9.6 millones en fondos de ayuda para el COVID-19 de los Centros para el Control y la Prevención de Enfermedades (CDC) para establecer Zonas de Equidad Saludables de Chicago [Healthy Chicago Equity Zones]– seis áreas geográficas cubriendo la ciudad entera, que serán conducidas por organizaciones regionales y comunitarias. En el 2021, las Zonas de Equidad Saludables de Chicago estarán enfocadas en aumentar la absorción de la vacuna en los barrios que han sido más impactados por el COVID-19. Mientras la ciudad continúa recuperándose de la pandemia, estas coaliciones conducirán estrategias hiper-locales para confrontar factores que contribuyen a la salud y a las disparidades raciales, incluyendo cuidado de salud y acceso a servicios sociales, acceso a alimentos, condiciones de vivienda, seguridad comunitaria y el entorno físico y construido del vecindario. Con esto, RFP y Healthy Chicago Equity Zones escalarán estas exitosas asociaciones de equidad de vacunas en las comunidades más afectadas de Chicago. La RFP de Healthy Chicago Equity Zones está abierta para solicitudes hasta el 28 de mayo de 2021 al mediodía.



Tips for Better Mental Health

30 minutes of daily aerobic exercise creates optimal cognitive, neurological and neurochemical states in the body and releases the BDNF (brain-derived neurotrophic factor) responsible for brain regeneration and protection. Strength or resistance training 2-3 times a week triggers brain cells to regenerate while stimulating muscle growth.

Good Sleep Can Melt the Stress Away

Villanueva Passes Legislation to Create Domestic Violence Commission

To protect women and children in Illinois, State Senator Celina Villanueva (D-Chicago) passed legislation the Illinois Senate that would establish the Domestic Violence Fatality Review Commission. “Incidents of domestic violence have increased dramatically since the start of the pandemic,” Villanueva said. “Families are counting on us to take proactive measures to prevent violence.” The commission would establish regional review teams by judicial court, conduct domestic violence fatality reviews and advise the Governor and General Assembly on domestic violence prevention policy. The commission would consist of four members of the General Assembly, one appointee by the Governor and various public members representing

survivors, support organizations and law enforcement. According to the Illinois Criminal Justice Information

Authority, 15 percent of all homicides in Illinois are connected to domestic violence. In 2020 nearly 30,000 people called the

Illinois Domestic Violence Hotline for help. The Illinois Domestic Violence Hotline (877-863-6338) is open 24 hours a day

with language assistance available. Senate Bill 685 passed the Illinois Senate and awaits consideration in the Illinois House.
