Advocates Demand Federal Relief Money on Mental Health, Not Police



The Collaborative for Community Wellness, Alderman Byron Sigcho, and Black Lives Matter activists held a press conference on Tuesday to demand the Mayor spend federal relief money on mental health not police. Activists are calling for American Rescue Plan

money to go towards increasing funding for a non-police mental health crisis response program and the re-establishing of mental health clinics. According to Cheryl Miller, an organizer with Southside Together Organizing for Power and the Collaborative for Community Wellness: "the City must proactively provide access to traumainformed mental health support, both in public clinics and a non-police mobile response. Chicago is poised to receive \$1.8 billion dollars of federal American Rescue Plan money. We are demanding

that the city use a portion of that \$1.8 billion dollars for Treatment Not Trauma by fully funding the nonpolice crisis response pilot based out of the public mental health clinics as well restore the public mental health clinics that were closed." Ms. Miller added that "what happened

with the last federal relief money cannot happen again. The Mayor putting most of the COVID relief money towards police is negligent and a deliberate starvation of our communities from needed resources." A small pilot of Treatment Not Trauma, a non-police mental health crisis program, was approved in the most recent City budget. The Collaborative for Community Wellness is calling for: expansion of the crisis response system to be based out of the 5

CDPH mental health clinics operating independent of the Chicago Police Department; allocation of at least \$25 million from the American Rescue Plan as a down payment on fully funding a comprehensive city-wide Treatment Not Trauma program; and reestablishing public mental health clinics. In the last round of federal COVID relief, the CARES Act, the Mayor spent two-thirds of the money, \$281M on the Chicago Police Department and \$68M went unspent.

Juegue


¿Ha usted visto anuncios para juegos de entrenamiento cerebral y se ha preguntado si son legítimos? de acuerdo a una

investigación reciente, la respuesta es sí. Un nuevo estudio descubrió que un entrenamiento cognitivo aumentaba la eficiencia energética del cerebro de los participantes. En las pruebas clínicas, hechas al azar, se les dio a los adultos de 56 a 71 doce semanas de entrenamiento cognitivo o fueron asignados a uno de dos grupos de control. Midiendo la actividad cerebral, los investigadores encontraron que quienes estaban en el grupo de entrenamiento cognitivo mostraban un considerable aumento en la asociación entre el tiempo de reacción y la actividad del lóbulo frontal, comparada a los grupos de control, lo que quiere decir que sus cerebros no tenían que trabajar tanto para ejecutar las tareas.

Socialice

Probablemente sea un hecho que la soledad afecta su salud mental, pero ¿sabías que puede realmente afectar tus genes su vida? Investigaciones sugieren que estar solos puede tener un impacto negativo en los telómeros, los segmentos de DNA al extremo de nuestras cromosonas que se acortan cada vez que una célula se divide y puede indicar que tiempo de vida le queda. Los telómeros más largos están asociados con un envejecimiento más lento, menos enfermedades relacionadas con la edad y generalmente mayor esperanza de vida. Have you seen ads for brain-training games and wondered if they were legit? According to recent research, the answer is yes. A new study found cognitive training increased the energy efficiency of participants' brains. In the randomized clinical trial, adults aged 56 to 71 were either given twelve weeks of cognitive training or assigned to one of two control groups.

Measuring brain activity, researchers found those in the cognitive training group showed a significant increase in the association between reaction time and frontal lobe activity compared to the control groups, meaning their brains didn't have to work as hard to perform tasks.

City Announces Return of the Chicago Auto Show



Governor JB Pritzker and Mayor Lori E. Lightfoot joined elected officials, tourism backers and labor leaders to announce the return of the annual Chicago Auto Show, a marquee event that draws tourists from around the world. While the Auto Show marks the first large convention to take place since the COVID-19 pandemic began, officials expect to welcome other conventions and tourist events this summer with safety precautions. The Chicago Auto Show will be held at McCormick Place from July 15 to 19 and will incorporate several innovative safety features – including being held indoors and outdoors for the first time since it was held in Chicago in 1901. It is the nation's largest and longest-running auto show. Among the safety measures in place: •a move to Hall F **Building** in West with 470,000 sq ft of indoor space and 100,000 sq ft of outdoor space;

- •timed entrance windows and staggered entry to prevent congestion on the show floor and at arrival;
- •requirement to wear face masks at all times;
- •sanitization stations throughout the event;
- •contactless delivery for tickets;
- •temperatures will be scanned, and a medical questionnaire must be filled out before entry is allowed into the event. For more information, www.chicagoauto show.com



IDPH Releases Maternal Morbidity and Mortality Report



On Tuesday, the Illinois Department of Public Health (IDPH) released the second edition of the Illinois Maternal Morbidity and Mortality Report, covering deaths occurring in 2016-2017. Among a number of other findings, the report found that Black women continue to die at disparately higher rates due to medical causes White women were more likely to die from pregnancyrelated mental health conditions. Using a variety of data sources, IDPH identifies women who died while pregnant or within one year of pregnancy (pregnancy-associated deaths). IDPH convenes two maternal mortality review committees (MMRCs), which review specific cases of maternal death to identify the causes of death, determine whether the deaths were pregnancy-related (cause of death is directly related

to pregnancy), determine whether the deaths were preventable, and develop recommendations to prevent future deaths.

Key **Findings:** An average of 75 Illinois women died while pregnant or within one year of pregnancy each year during 2008-2017, with the highest number recorded in 2017 (a total of 103 deaths). In 2016-2017: • Thirty-four percent of women who died while pregnant or within one year of pregnancy died from a cause related to pregnancy. • The leading cause of pregnancy-related death was mental health conditions, including substance use disorders, which comprised 40 percent of pregnancyrelated deaths. The next

three most common causes

of pregnancy-related death

were pre-existing chronic

medical conditions that

pregnancy, hemorrhage, and hypertensive disorders of pregnancy.

Highlights of Key Recommendations:

- Health insurance plans, including Illinois Medicaid, should reimburse for telehealth, including phone-based services, regardless of patient or provider location. • The state and collaborating programs should expand and facilitate coordination home of visiting programs for pregnant and postpartum women with complex medical or mental health conditions. The state should expand implementation

CPS Doubles High School Selective Enrollment Offers to Diverse Learners



Chicago Public Schools (CPS) announced that the number of selective enrollment offers extended to diverse learners has nearly doubled (from 262 in SY20 to 489 in SY21), which is part of the district's long-term High School Strategy—a comprehensive roadmap that outlines specific goals and commitments to increase opportunities, outcomes, and support for high school students.

In order to ensure diverse learners, have the support they need at selective enrollment high schools, the district has invested \$2.5 million in additional funds which includes a minimum of two additional positions per school as well as funds to support the work of school-based task forces. To ensure schools can successfully support diverse learners, selective enrollment high schools have been

provided \$2.5 million in additional funding in FY22 school budgets, which will provide each school with a minimum of 1 additional teacher and 1 case manager position, for a total of 22 additional positions. As part of the investment, schools were also provided funding to support the local school task force teams created to support the transition, and additional resources will be available depending on the needs of the diverse learners a school welcomes.




