



City Selects Dr. José Torres to Serve as Interim CEO at CPS

Mayor Lori E. Lightfoot and Chicago Board of Education President Miguel del Valle announced that veteran educator Dr. José M. Torres has been selected to serve as interim Chief Executive Officer at Chicago Public Schools upon CEO Dr. Janice K. Jackson's departure at the end of this month. Dr. Torres is a veteran educator with decades of experience who began his career as a teacher and most recently served as President of Illinois Math and Science



Academy (IMSA). Throughout his career, Dr. Torres has held a variety of prominent leadership positions including Superintendent of Elgin School District (U-46); Regional Superintendent at Chicago Public Schools for Englewood, West Englewood, Chatham, Grand Crossing and Auburn Gresham; and a variety of other educational leadership positions during

his decades of public service. Pending approval from the Chicago Board of Education at its meeting on June 23, Dr. Torres will begin serving as interim CEO on July 1, 2021. Dr. Torres will serve as CEO on an interim basis as the Chicago Board of Education and Mayor Lightfoot continue to engage stakeholders and search for a permanent replacement.

Illinois Businesses Still Closed as State Reopens with Phase 5

As Illinois fully reopened for business with Phase 5 yesterday, the state's economy had significantly fewer businesses than prior to the pandemic. Compared to highs in January 2020, Illinois had 39 percent fewer businesses this May, according to data from the Opportunity Insights Economic Tracker, a project of Harvard University. The biggest losses are in the food and accommodations sectors, where the number of small businesses that remained open fell by nearly 53 percent, the Illinois Policy Institute finds. The lei-

IBHE Announces Plan for Postsecondary Education for All

The Illinois Board of Higher Education (IBHE) released a new strategic plan for higher education institutions across the state. The plan, which passed with unanimous support from the board, was developed in cooperation with the Illinois Community College Board (ICCB) and the Illinois Student Assistance Commission (ISAC). *A Thriving Illinois: Educational Paths to Equity, Sustainability and Growth* is the product of a 9-month stakeholder engagement process and

is designed to address systemic inequities that have affected Illinois' postsecondary outcomes, the needs of the state's economy, and postsecondary attainment. After holding focus groups and organizing a 10,000-respondent survey, the IBHE board outlined three key goals for the state's higher education community:

- GOAL 1: Equity. Strategies will close the equity gaps for students who have been left behind. The plan outlines strategies

to close equity gaps that disproportionately impact Black, Latinx, and other students of color, low-income students, working adults, and students from rural communities. Stakeholders designed directives to close gaps in enrollment, retention, advancement, and completion rates for diverse and disconnected learners.

- GOAL 2: Sustainability. Strategies will build a stronger financial future. Addressing financial sustainability for both individual and higher

sure and hospitality sector saw a 52 percent decline in the number of surviving small businesses. For the retail sector, the number of small businesses fell by

nearly 39 percent. Unfortunately for those Illinoisans still out of work, the General Assembly passed a fiscal year 2022 budget that includes four of Gov.

J.B. Pritzker's nine new tax hikes, including ones that would reduce investment and hurt job creation efforts by removing key tax incentives and deductions.

education institutions, the plan recommends an expanded Monetary Award Program (MAP) and increased investment through a new equitable, stable, and sufficient higher education funding system.

- GOAL 3: Growth.

Strategies aim to increase talent and innovation to drive economic growth. The plan calls for tighter alignment between educational institutions and centers for entrepreneurship and innovation to build a

future-ready workforce. A new statewide Business and Employer Advisory Council will partner with higher education to strengthen pipelines of learners ready to engage an evolving economy. The full plan can be read at www.ibhe.org.

Illinoisans Still Able to Receive Stimulus Checks, Tax Credits

The May 17 tax filing deadline has passed, but it's not too late for many Illinoisans to file their taxes to receive funds from missing stimulus checks and other available tax credits. To help make the process easier, the Get My Payment IL Coalition is continuing to connect Illinoisans to free tax-filing

resources and working with them to understand which credits they are eligible for. The three main tax credits that Illinoisans may be able to claim to receive these funds include:

- **Recovery Rebate Credit (for missing stimulus checks)** – Eligible Illinoisans who haven't received their first and/or

second stimulus checks or didn't receive the full amounts, can still claim the Recovery Rebate Credit to receive up to \$1,800 (\$3,600 for married couples) and \$1,100 for each eligible dependent under 17. Additionally, if an individual with a Social Security number did not receive the first

two stimulus checks because their spouse had an ITIN, the individual may be eligible to receive them now by claiming the Recovery Rebate Credit.

- **Earned Income Tax Credit (EITC)** – Every year a little over one in five eligible Illinoisans don't claim the EITC, leaving millions of dollars in tax credits unclaimed. The EITC is a credit for workers, including those with children and those without children. Eligible low-income workers can qualify for tax credits ranging from \$538 to \$6,660 through the 2020 EITC. Workers without children must be between the ages of 25 and 64 to claim this credit this year. However, next year it will be available to childless

workers age 18 and higher.

- **Child Tax Credit (CTC)** – For the 2020 CTC, individuals who earned more than \$2,500 and who have children under age 17 may be eligible to receive up to \$2,000 per child. In 2021, the CTC will be expanding, increasing the amount of money per eligible child and removing the \$2,500 earnings minimum. Heal Your Trauma



Trauma comes in all shapes and sizes. No one person's trauma is the same. How those that have lived through, witnessed and experienced trauma perceive and cope with it varies from person to person. This trauma can impact lives in immeasurable and drastic ways, likely in the form of PTSD. With June being PTSD Awareness Month and June 27th

marking National PTSD Awareness Day, now is a crucial time to bring awareness to this complex disorder. To encourage conversations on the topic and to encourage leaders to find healthy solutions and offer support to those struggling with it every day.

Hypervigilance

Hypervigilance is a state of alertness. If you find yourself tense in public, scanning your surroundings

for threats or exits you might be experiencing hypervigilance. Avoiding people and places can also be a sign of hypervigilance. Notice what your body is telling you, do you tense up in public, does your heart race or do your hands get sweaty? This could be a hypervigilant response to your environment. Instead, engage in some guided positive relaxation prior to going out into public.

You can easily include some yoga stretches to help impact your vagus nerve (nervous system superhighway) and head out of the home in a more relaxed state to begin with.

Sleep Trouble

Having problems sleeping is a hallmark of PTSD. Sometimes, you can't turn your brain off to fall asleep, or you wake up from a nightmare or in a state of panic. There is a lot

of emerging research that suggests cortisol levels may be to blame for these kinds of symptoms. Cortisol (stress hormone) doesn't allow our bodies to fall asleep. Cortisol is trying to find the threat, even at night. Additionally, our minds are trying to process events and emotions during the night which can account for the nightmares. Try doing some breathing exercises before bed or when you wake up.

Validate Your Loved One's Emotions

If you support your loved one who has been through

trauma, it's important to validate their lived experience and emotions around that experience. Instead of telling that person to 'get over it' or engaging in argumentative behavior about it, take a step back and ask the person how you can assist them. Better yet, reflect back on how the person is feeling and support their emotional expression. Encouraging them to seek help in such a way that is supportive, not punitive and certainly not during an argument.

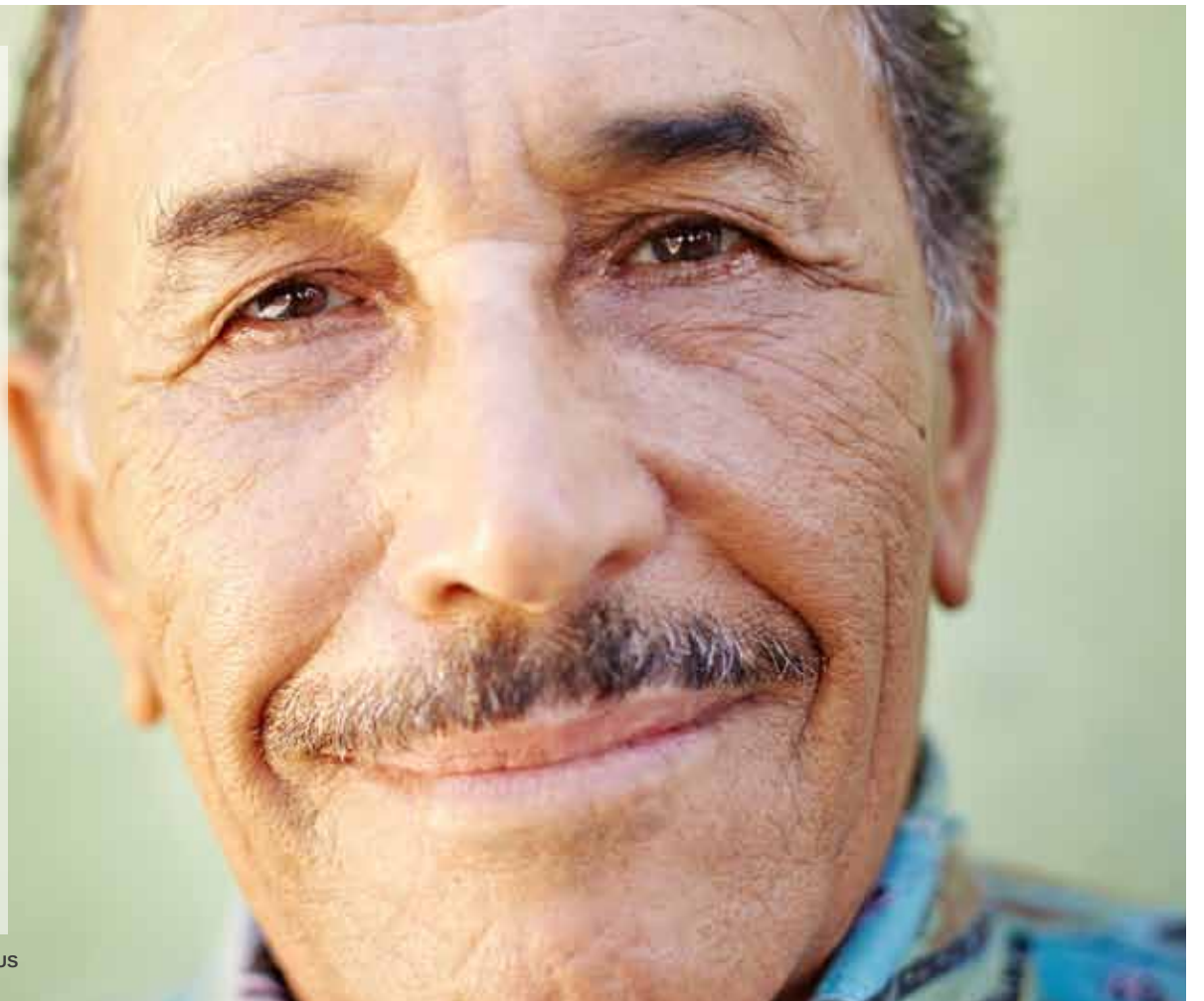

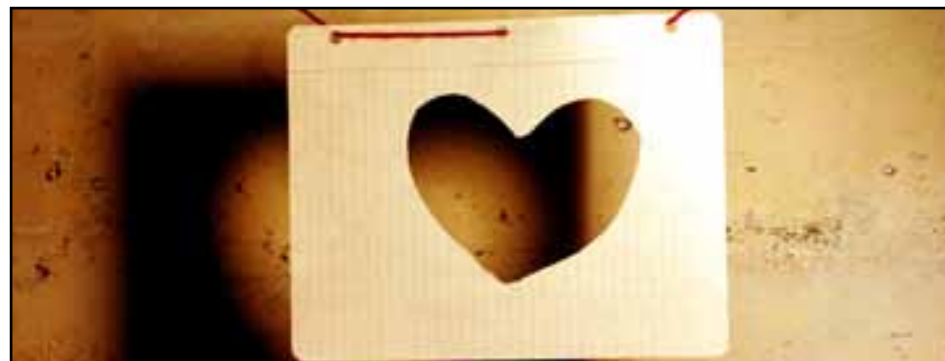

Violence Prevention Groups Announce Unique North Lawndale Collaboration



Organizations, funders and community groups working to reduce gun violence in Chicago gathered in a West Side park Tuesday morning to announce a new partnership focused on North Lawndale and to provide an update on a key violence prevention strategy. The event comes as gun violence is up for the year overall compared to last year, but down significantly in both

April and May. A rally in Douglass Park, 1401 South Sacramento, featured representatives from READI Chicago, which serves young men at risk in three west side and two south side neighborhoods, Communities Partnering 4 Peace (CP4P), which includes 15 different community anti-violence groups active in 28 neighborhoods, Chicago CRED, which is also

active on both the South and West Sides, and the Partnership for Safe and Peaceful Communities (PSPC), a coalition of Chicago funders. They spoke about the new collaboration, current gun violence trends, and also celebrated the passage of a new state law providing \$100M to help violence prevention programs go to scale.
