

Pappas Envía los Segundos Pagos de Impuestos de Propiedad

La Tesorera del Condado de Cook, Maria Pappas ha enviado cerca de 1.8 millones del segundo pago de Impuestos de Propiedad. Los pagos vencen el 1° de octubre. Los nuevos pagos subirán el monto total del condado para el año 2020 a más de \$16.1 mil millones, un aumento de más del 3.4 por ciento del año pasado. Vaccine Mandate Facing Backlash from Unions

Mayor Lori Lightfoot announced Wednesday that all Chicago employees will need to be fully vaccinated against COVID-19 by October 15th, joining other major cities across the country. "As cases of COVID-19 continue to rise, we must take every step necessary and at our disposal to keep everyone in our city safe and healthy," said Mayor Lightfoot. "Getting vaccinated has been proven to be the best way to achieve that and make it possible to recover from this devastating pandemic. And so, we have decided to join other municipalities and government agencies across the nation, including the U.S. military, who are making this decision to protect the people who are keeping our cities and country moving."

More than 30,000 people are employed by the city. Cook County Board President Toni Preckwinkle issued an executive order Friday mandating vaccines for county employees. Chicago Public Schools will also require teachers and other employees to be vaccinated unless they qualify for a religious or medical exemption. Both the county and CPS are giving employees until Oct. 15 to be vaccinated.

In a move that is already receiving significant pushback from four police unions representing Chicago police officers, met Lightfoot's team virtually to discuss the vaccine mandate. "If it's a mandatory condition, seven points that must be negotiated and that's pretty well settled in labor laws," said Lt. Michael Stiscak, president, Chicago Police Lieutenants Union. "So if they're going to make this a fireable offense or a mandate in order to maintain employment,



that's going to have to be negotiated by them. It just cannot be enacted Order of Police has by them." The Fraternal

El Mandato de Vacunas Enfrenta la Reacción de los Sindicatos

La Alcaldesa Lori Lightfoot anunció el miércoles que todos los empleados de Chicago necesitarán estar totalmente vacunados contra el COVID-19 para el 15 de octubre, uniéndose a otras importantes ciudades del país. “Como los casos de COVID-19 continúan elevándose, debemos dar todos los pasos necesarios a nuestra disposición para mantener sanos y salvos a todos en nuestra ciudad”, dijo la Alcaldesa Lightfoot. “Vacunarse ha probado ser la mejor forma de lograr eso y de hacer posible recuperarse de esta devastadora pandemia. Y así, hemos decidido unirnos a otras municipalidades y agencias gubernamentales de la nación, incluyendo el ejército de EU, que están tomando esta decisión para proteger a la gente que mantiene vivas nuestras ciudades y nuestro país”.

Más de 30,000 personas están empleadas por la ciudad. La Presidente de la Junta del Condado de Cook, Toni Preckwinkle expidió una orden ejecutiva el viernes haciendo



obligatoria la vacuna para los empleados del condado. Las Escuelas Públicas de Chicago pedirán también a los maestros y otros empleados que se vacunen a menos que califiquen para una exención médica o religiosa. Tanto el condado como CPS están dando a los empleados hasta el 15 de octubre para que se vacunen. En una medida que ya está recibiendo un rechazo significativo de cuatro sindicatos policiales que representan a los oficiales de policía de Chicago, el equipo de Lightfoot se reunió virtualmente para discutir

el mandato de la vacuna. “Si es una condición obligatoria se deben negociar siete puntos y eso está bien estipulado en las leyes del trabajo”, dijo el Tnt. Michael Stiscak, presidente del sindicato de Tenientes de Policía de Chicago. “Entonces, si van a convertir esto en una ofensa despedible o en un mandato para mantener el empleo, tendrá que ser negociado por ellos. Simplemente no puede ser promulgado por ellos”. La Orden Fraternal de Policía ya ha amenazado con presentar una demanda desafiando cualquier mandato con los sindicatos de sargentos, tenientes y capitanes que se espera se unan a la lucha. Actualmente los sindicatos están trabajando a través de negociaciones con la administración de Lightfoot esperando llegar a un acuerdo. La nueva política aplica a todos los empleados y voluntarios de la Ciudad. Los empleados pueden aplicar para exenciones médicas o religiosas de esta política. Tales peticiones serán revisadas por el Departamento de Recursos Humanos, caso por caso.

Más del 70 por ciento (más de 1.6 millones) de residentes de Chicago de más de 18 años han recibido por lo menos

una dosis de la vacuna del COVID-19. Las vacunas del COVID-19 están ampliamente disponibles en farmacias, oficinas de

cuidado de salud y a través de eventos especiales en la Ciudad sin costo alguno al público. No se necesita identificación

already threatened to file a lawsuit challenging any mandate with the sergeants, lieutenants and captains unions expected to join the fight. Currently, unions are working through negotiations with the Lightfoot administration in hopes to come to an agreement. The new policy applies to all City employees and volunteers. Employees can apply for medical or religious exemption from this policy. Such requests will be reviewed by the Department of Human

Resources on a case-by-case basis. More than 70 percent (more than 1.6 million) of Chicago residents over 18 have received at least one dose of a COVID-19 vaccine. COVID-19 vaccines are widely available at pharmacies, health care offices, and through special events across the City at no cost to the public. Notice is hereby given that Clyde Park District (the “Park District”) will receive sealed bids for the installation of a surge tank at the Manor Pool (the “Pool”) located at 5800 West Park Avenue, Cicero, Illinois.

The bidder must have a valid business license issued by the Town of Cicero and must provide proof of the same in its sealed bid. The bidder must also be bonded and insured and present proof of same. The bidder shall also submit a sworn notarized statement that they will comply with the Illinois Prevailing Wage Act. (820 ILCS 130/2, et seq.) The bidder shall also include the cost of obtaining all permits for the project. As a note, the successful bidder will need to begin work quickly after the bid is awarded.

The work to be performed and bid on includes:

- Fabrication and installation of surge tank.
- Installation of recessed Wedge (Ladder) Anchors and Escutcheon Plates (16 each) via core drilled holes into the existing concrete.
- Equipment must include eight (8) Ladders 3-Step and 4-Step to replace existing.
- Modifications to main drains in both Manor Pool and the wading pool, with piping runs to accommodate new surge tank.
- Modifications to Basement Filter Room Piping as new components need to be replaced, including location identification of rebar, vent piping, and fresh water fill Piping, and disconnects, reconnection points and new replacement parts.
- Piping diagram and new equipment installation as required in filtration equipment list.
- Reinstall existing safety rope and floats.
- Services should include all labor as required, including electrical grounding.
- Minimal concrete filler should be performed as needed to stabilize perimeter gutter following installation.

Prior work for the Manor Pool Membrane and Vinyl Gutter Project was awarded to RenoSys Corporation in March 2020 after due advertisement as the lowest responsible bidder. Due to Renosys being awarded the first portion of the scope of work, they will be identified on the Illinois Department of Public Health permit as the general contractor. For contracting and permitting purposes, the awarded contractor of this new project shall be required to cooperate with RenoSys and the Park District.

Architectural drawings that have been approved by IDPH through an architect contracted by the Park District will be made available by the Park District upon request.

Any bids received after the closing time will be rejected and returned unopened. Pappas Mails Out Second Installment Property Tax Bills



Cook County Treasurer Maria Pappas has mailed out nearly 1.8 million Second Installment property tax bills. Payments are due Oct. 1. The new bills will bring the total amount billed countywide for 2020 to more than \$16.1 billion, an increase of more than 3.4 percent from last year. A recent analysis by the Treasurer’s Office found the tax increase is hitting commercial property owners and Black and Latino suburban property owners the hardest. To make a payment online, go to the website:

- Select the blue box labeled “Pay Online for Free”
 - Search by property address or enter your Property Index Number (PIN)
 - There is no fee if you pay from your bank account
- Taxpayers also may use the website to search for \$72 million in available refunds going back 20 years and to verify property tax exemptions, which can lower the tax bill. Homeowners may be missing out on \$43 million in exemptions. To search for refunds or missing exemptions, visit cookcountytreasurer.com:
- Select the purple box labeled “Your Property Tax Overview”
 - Search by property address or enter your Property Index Number (PIN)
 - Or the results under “Have You Received Your Exemptions in These Tax Years?”
- Late payments are charged 1.5 percent per month, as required by Illinois law. For more information, visit www.cookcountytreasurer.com

Homeowners: Are you Missing Exemptions on your Property Tax Bill?

As homeowners in Cook County receive their 2020 Second Installment Tax Bills (tax bill) in the mail they are encouraged to look at the bottom left corner to ensure that the correct exemption(s) are applied. If a homeowner believes they are entitled to an exemption that is not reflected on their tax bill, they can apply for what is called a Certificate of Error. The Certificate of Error process provides homeowners an opportunity to redeem missing exemptions for up to three years in addition to the current tax year. Homeowners can now apply for the 2020, 2019, 2018, and 2017 tax years. Certificate of Error applications with copies of supporting documentation can be filed online, by mail, or in person. Please see the full list of property tax exemptions administered by the



Assessor's Office at www.cookcountyassessor.com/emptions.

This year, many exemptions auto-renewed to make the process more convenient for homeowners. In addition to the Homeowner and Senior exemptions, the Assessor's Office processed auto-renewals for the "Senior Freeze", Veterans with Disabilities, and Persons with Disabilities exemptions. In total, more than 1.1 million exemptions were auto-renewed, which

provided millions of dollars in tax relief to homeowners in Cook County. As a reminder, homeowners are responsible for paying the entirety of the tax bill to the Cook County Treasurer's Office by October 1, 2021. If the Certificate of Error application is granted, either a corrected tax bill or a refund for the difference will be issued. La Agresiva Respuesta de Cicero Frente a la Pandemia del COVID

El Municipio de Cicero implementó una respuesta agresiva ante la amenaza de salud que representa el COVID para los residentes, usando sus recursos existentes y manteniendo todos los servicios, suplementados únicamente por los Fondos de Ayuda para el Coronavirus.

La policía de Cicero y todos los socorristas, incluidos los bomberos, los paramédicos y el personal del Departamento de Salud, enfrentaron una exposición "100 veces mayor" a la infección por COVID que el ciudadano promedio, debido a la gran cantidad de contactos de persona a persona que realizaron para proteger la seguridad del público.

Por esto, los fondos de COVID se dirigieron en gran medida a respaldar los recursos de salud y seguridad que involucran principalmente a la policía, los bomberos, los socorristas y a nuestro Departamento de Salud para mantener el más alto nivel de seguridad para nuestros residentes.

La policía, los bomberos y los socorristas han tenido una tasa de infecciones por COVID más alta que el ciudadano promedio.

En el caso de la Policía, el Departamento de Policía experimentó debido al COVID en el 2020, 534 días libres (de ausencia) entre sus oficiales, por "Lesiones durante el servicio" (o sea 4.272 horas en total). Cuando el personal experimenta una gran cantidad de ausencias por 'lesiones', la cobertura de esos turnos a menudo la hace el personal que es llamado a trabajar en sus días libres de servicio, para mantener los niveles adecuados de agentes y garantizar la seguridad pública:

A. Las horas extras registradas en el Departamento de Policía durante el año calendario 2020 superaron el presupuesto en \$ 264,313.

B. Las horas extras registradas en el Departamento de Bomberos durante el año calendario 2020, excedieron el presupuesto en \$46,339. Los bomberos registraron 2.666 horas extraordinarias de tra-

bajo durante el 2020.

Para abordar estos desafíos, la ciudad de Cicero contrató policías, bomberos, paramédicos y empleados del Departamento de Salud adicionales en un esfuerzo por garantizar una respuesta efectiva frente al COVID. Cicero no quería disminuir sus obligaciones con el público. Además, el esfuerzo por enfrentar la amenaza de la pandemia resultó en grandes costos por las horas extra laboradas, ya que los socorristas trabajaron horas adicionales para responder a la creciente necesidad pública y a las llamadas de emergencia relacionadas con el COVID.

En segundo lugar, Cicero invirtió en 'COVID PPE' (Equipos de Protección Personal) que fue distribuido a empleados y residentes para reducir las infecciones y mantener seguros a los socorristas para que pudieran proteger a nuestros ciudadanos de la delincuencia y para responder en situaciones y llamadas de emergencia e incendios.

El año pasado, los departamentos de policía, de bomberos y de salud de Cicero estuvieron involucrados durante meses en monitorear y ayudar a mitigar la propagación del coronavirus en uno de los dos hogares de ancianos que operan en la ciudad.

Además, la ciudad de Cicero organizó y coauspició docenas de eventos de distribución de alimentos y de mascarillas para ayudar a los residentes afectados por la pandemia. Esto requirió que cientos de empleados participaran en la organización de los programas de distribución, incluida la asignación de policías para mantener el orden ante las grandes multitudes de residentes que buscaban comida, PPE (Equipos de Protección Personal) y mascarillas. En muchos casos, los vehículos se alineaban por más de una milla, mientras que los voluntarios y los empleados de la Ciudad atendían al público durante muchas horas en cada evento.

Finalmente, los fondos también apoyaron el agresivo programa de vacunación de la ciudad, organizado por el

Departamento de Salud de Cicero (CHD). CHD proporcionó 26,000 vacunas a los miembros del público, agregando personal y comprando equipos y computadoras para administrar los horarios. El programa de vacunación de Cicero fue uno de los más extensos de cualquier otra comunidad en el área suburbana de Chicago. CHD contrató personal adicional para enfrentar las infecciones por el COVID, para responder a las preocupaciones de los residentes, así como para financiar el agresivo programa de vacunación.

De marzo a diciembre del 2020, Cicero tuvo gastos totales estimados por el COVID-19 de \$ 343,549.00 dólares. Aunque el municipio ha solicitado la restitución de estos gastos directos de PPE (Equipos de Protección Personal) hechos hasta el 31 de diciembre de 2020 a través de una Subvención de Asistencia Pública de FEMA / IEMA (Agencia Federal para el Manejo de Emergencias y su similar de Illinois), hasta el 9 de agosto de 2021 Cicero no había recibido ningún reembolso.

Los fondos también se gastaron para comprar publicidad, para hacer llamadas automáticas e imprimir folletos para pedir la participación del público.

Según la ley estatal, Cicero debe aceptar citas de vacunación contra el COVID tanto de los residentes de la ciudad de Cicero como de las personas que vivan afuera de la ciudad de Cicero, por lo que a pesar de las afirmaciones y reportes de bajas cifras de vacunación entre la comunidad hispana en Cicero, esos reportes no incluyen las miles de las vacunas administradas por ley a las personas que viven fuera de la ciudad de Cicero.

A pesar de la oposición de algunos residentes a vacunarse, el programa de vacunación de Cicero dio como resultado que el 42,5 por ciento de la población (36,189 personas) recibiera ambas vacunas y que el 60,4 por ciento (50,650 personas) recibiera al menos una vacuna. Esto no incluye a

Illinois Inicia Grupo Especial para Explorar el Futuro del Trabajo

Un nuevo proyecto fue firmado el martes por la tarde para establecer un Futuro Grupo Especial de Trabajo en el estado de Illinois. El Acta del Grupo de Trabajo sobre el Futuro del Trabajo de Illinois (HB 645) fue patrocinada por el Senador Ram Villivalam y el Representante Marcus Evans JR. Crea un Grupo Especial de 29 personas para analizar cambios económicos importantes y emergencias tecnológicas y prepara recomendaciones de políticas que ayudan al estado a combatir las cada vez peores crisis de pobreza, desigualdad y cambio de clima. En los próximos nueve meses, el Grupo Especial conducirá siete reuniones públicas y por lo menos dos mesas redondas del ayuntamiento cubriendo temas como: nuevos desafíos y tecnologías que remodelan el trabajo; bajos salarios y desigualdad económica; desarrollo de destrezas y fuerza laboral; y, explorar políticas de soluciones a corto y largo plazo. Los miembros del Grupo Especial serán nombrados por el Gobernador, el Presidente del Senado, el Líder de las Minorías del Senado, el Vocero de la Cámara y el Líder de las Minorías de la Cámara, y escuchará a líderes estatales y nacionales en los sectores académico, tecnológico, empresarial, de fundaciones, laboral y sin fines de lucro. El Laboratorio de Economía Inclusiva de la Universidad de Chicago será el socio académico, responsable de redactar este informe que se presentará a la Legislatura de Illinois antes del 1° de mayo de 2022.

Illinois Begins Task Force to Explore the Future of Work

A new bill was signed Tuesday afternoon to establish a Future of Work Task Force in the state of Illinois. The Illinois Future of Work Task Force Act (HB 645) was sponsored by Senator Ram Villivalam and Representative Marcus Evans JR. It creates a 29 person Task Force to analyze major economic shifts and emerging technologies, and prepare policy recommendations that help the state to combat the worsening crises of poverty, inequality, and climate change. Over the next nine months, the Task Force will conduct seven public meetings, and at least two town hall roundtables covering topic areas including: new challenges and technologies reshaping work; low wages and growing economic inequality; skills and workforce development; and, explore short- and long-term policy solutions. The Task Force members



will be appointed by the Governor, the Senate President, the Senate Minority Leader, the Speaker of the House, and the House Minority Leader, and will hear from statewide and national leaders in the academic, tech, business, foundation, labor, and non-profit sectors. University of Chicago's Inclusive Economy Lab will be the academic partner, responsible for drafting this report that will be presented to the Illinois Legislature by May 1, 2022.

Background

Congress provided \$5 billion in the CARES Act for the Community Development Block Grant (CDBG-CV) program to states, metropolitan cities, urban counties, and insular areas.

At least 70 percent of every grant must be expended for activities that benefit low- and moderate-income persons by providing housing, a permanent job, a public service, or access to new or significantly improved infrastructure.
