## Guadalajara Trying to Preserve its History on Mexican Independence

In the City of Guadalajara, there are two places that preserve Mexico's fight for independence. The first one is the City Museum of Guadalajara. It should be mentioned that Guadalajara was the first Mexican city under the administration of the rebel leader Miguel Hidalgo y Costilla, the priest who tried to take Mexico City (then known as the City of New Spain) from the Spanish royalists. Leading a major revolt in 1810, had Hidalgo taken Mexico City it would have been the end of Spanish rule then. His failure to do so meant that he had to find another means to preserve his revolt. Hence, Guadalajara became the capital for his rebellion. Because of this, there are many official documents and books put out by the rebel government from the time period on display. Also, there are documents and personal letters by Hidalgo himself stating what he intended to do to make all of Mexico independent. Additionally, there are weapons and personal effects used by the rebels preserved at the museum.

A unique place that illustrates Mexico's history and the war for Mexican independence is the Wax Museum of Guadalajara. Similar to the Wax Museum in Mexico City, the museum has beautifully made life-like wax figures of historical personalities from all of Mexico's long history. Visitors can see wax figures of the Aztec emperors, the Spanish governors of New Spain (Mexico), the Mexican rebel leaders such as Hidalgo, Jose Maria Morelos y Pavon, and Vicente Guerrero, and all of Mexico's presidents since independence. The museum places emphasis on the War for Mexican Independence (1810-1821)





## Guadalajara Intenta Preservar su Historia Sobre la Independencia de México

En la Ciudad de Guadalajara, hay dos lugares que preservan la lucha por la independencia de México. El primero es el Museo de la Ciudad de Guadalajara. 
utilizados por los rebeldes conservados en el museo.

## **Woke Culture Reaches Mexico**

Mexico City's current Mayor Claudia Sheinbaum will replace the statue of Christopher Columbus in Paseo de la Reforma with a statue of an Olmec woman. The Columbus statue, which had been previously removed from its former location for cleaning and restoration, will not be put back in its original place. Instead, the statue will be put in Parque America---Mexico City's affluent Polanco district. According to Sheinbaum, the statue of the Olmec woman, being created by the famous Mexican sculptor Pedro Reyes, will serve as an example of "Mexico's indigenous culture." The Columbus statue, created by the French sculptor Charles Cordier, had stood in Paseo de la Reforma in the heart of Mexico City for almost 150 years.

It seems that woke culture has hit Mexico. Since the

election of the leftist president Andres Manuel Lopez Obrador to the presidency in 2018, Mexican politics has been veering to the left. For decades, there had been no argument with the statues of European explorers and conquerors for centuries even after Mexico had long gained its independence from Spain. Even after independence, when Mexico has tried to emphasize its indigenous cultures and roots, it has tried to both preserve the past before the Spanish conquest as well as tried to preserve the European and Asian heritage that also makes up the country. Like the United States, Mexico is also a multicultural state with both indigenous peoples as well as immigrants from so many other continents that have made Mexico what it is.

Sadly, as in the United States, this fact is now being lost on the political left in Mexico. For better or worse, Mexico's past is what it is. It is not solely an indigenous nation, and it is not a European one either. In fact, a lot of the indigenous peoples before the coming of the Europeans were at each others' throats just like the Europeans were. We have to remember that the Tlaxcalans allied themselves with the Spanish against the Aztecs

## La Cultura Despierta Llega a México

La actual alcaldesa de la Ciudad de México, Claudia

Sheinbaum, reemplazará la estatua de Cristóbal Colón en el Paseo de la Reforma con una estatua de una

muier olmeca. La estatua de Colón, que se había retirado previamente de su ubicación anterior para su limpieza y restauración, no se volverá a colocar en su lugar original. En cambio, la estatua se colocará en el Parque América, el próspero distrito de Polanco de la Ciudad de México. Según Sheinbaum, la estatua de la mujer olmeca, creada por el famoso escultor mexicano Pedro Reyes, servirá como ejemplo de la "cultura indígena de México". La estatua de Colón, creada por el escultor francés Charles Cordier, había estado en el Paseo de la Reforma en el corazón de la Ciudad de México durante casi 150 años.

Parece que la cultura del despertar ha golpeado a México. Desde la elección del presidente izquierdista Andrés Manuel López Obrador a la presidencia en 2018, la política mexicana se ha desviado hacia la izquierda. Durante décadas, no se había discutido con las estatuas de los exploradores y conquistadores europeos durante siglos, in-

## **Chicago Park District Announces Pilot Program** at Lakefront Swimming Locations




The Chicago Park District announced plans to install life preserver equipment at select waterfront locations as part of a pilot program to help mitigate risks of water related accidents and drownings. In addition to life preserver equipment, the District will also install increased signage along

the lakefront and conduct outreach with community groups to raise public awareness and enforce beach safety. Equipment will be installed prior to the 2022 beach season. The number of rings installed at each location will be determined by the size and configuration of the beach. Equipment will be

inspected and maintained by the District. Beginning in the Winter 2022 program session, all registrations will require patrons to acknowledge beach safety protocol. Regardless of the CPD program, whenever a participant registers online, or in-person for a program, the participant will be asked to review and acknowledge their receipt and viewing of a list of safeto-swim locations and lakefront rules and regulations including hours of operation.

With songs like Yo no creo en fronteras, (I don't believe in borders), and La Bamba rebelde, (The rebel bamba) and Trabajador, Trabajadora (Laborers), it's not hard to tell that this group of musicians and

friends, who love to dance and play to folk, *jarocho* and urban son, are also community activists.

As the group prepared to go on tour in early 2020, after finishing up a tour that took them to as far as Alaska, the pandemic stopped everything, as it did for many around the world. But instead of stopping the work, they pressed on. "It can be easy when you are on tour, to only focus on your tour, sell tickets, and stay relevant in the artist world," she added. This, they believe, helped them rewind and focus on what matters.

Whether they are performing, leading



in a march, or holding a community forum, Las Cafeteras always hold space for diverse audiences. In their new single, La Sirena, the group collaborated with Poder Latinx (www.poderlatinx. org) and the Human Rights Campaign (www.hrc. org). The video features a number of divas, dreamers and drag queens. The song celebrates diversity in trans and queer activists, and also celebrated the immigrant experience and Dreamers.

"I'm very careful about trauma bonding with the audience. When you are talking about hurtful things, you are going to be hurt over and over again, unless you can create you meaning for it. You can talk about very terrible things, but we sing, dance, and laugh. We have been able to embrace a traumatic communal past, but we have also understood there are nuggets of empowerment,

of resilience, of beauty, and of joy, and that we are here for a reason, she shared.

"The purpose of Las Cafetaras is to not hide those things but to say yes, that happened but we're here together as a family, and we don't have to identify with those hurtful things. In our shows, our playful selves come out to play," she said.

## Job Scams Surge During the Pandemic, BBB Study Finds

Employment scams are on the rise in the turbulent job market created by the COVID-19 pandemic, and people ages 25-34 are the most common targets, followed by people ages 35-44, according to a Better Business Bureau® (BBB®) study released. The largest group of reports, from people ages 25-34, accounts for 28.2 percent of the BBB Scam Tracker reports; people 35-44 were next at 21 percent and the thirdlargest group was people ages 45-54. With the recent winding down of many pandemic unemployment

benefits, some experts predict millions more will be on the hunt for new jobs, providing a perfect environment for more employment scams. The indepth investigative study -- Job Scams: BBB study finds job scams increased during the pandemic, warns job seekers to verify employment offers to avoid illegal jobs, identity theft, and fake checks -details the many forms employment fraud takes and the other scams that often result.

### BBB Tips to avoid job scams:

• Take time to find the job

listing on the company's website directly.

- Check on businesses offering jobs at BBB.org.
- If someone wants you to pay for the promise of a job, it's a "tip-off to the rip-off" that it is almost certainly a scam.
- Complete an internet search with the employer's name and the word "scam" to see if there are other complaints involving job scams.
- Examine the email address of those offering jobs to see if it matches the company's and sender's names.
- There are no legitimate

jobs that involve receiving and reshipping packages.

- Don't fall for a fake check scam. BBB is unaware of any legitimate job offers that send checks to applicants and ask them to send money to a third party.
- Do not click on links in texts and emails or respond to calls from unknown sources

## City Introduces New Plan to Combat Street Gangs

In a move that has many Chicagoans wondering how it will work, Mayor Lori Lightfoot introduced the Victims Justice Ordinance Tuesday, a new

ordinance that aims to hold streetgangs accountable. will allow the City to file a civil claim against those who engage in a pattern of criminal activity and permit the City to recover compensatory and punitive

damages, forfeiture of property, abatement, and injunctive relief when the defendant is found to have engaged in criminal gang activity.

"Today we are taking steps to expand the fight against

violent streetgangs by creating additional civil tools that will directly impact the profit motive used by these perpetrators terrorize communities," said Mayor Lightfoot. "Criminal gang activity imposes substantial costs on the City, residents, and the neighborhoods where they operate. If we are successful, we will seize their assets and disrupt the financial lifelines that support this criminal activity and fuels their dominance in our city.'

Victims Justice The Ordinance, modeled after the 1993 Illinois Streetgang Terrorism Omnibus Prevention Act, would allow the City to file a civil complaint against streetgang members who knowingly engaged in two or more gang-related criminal offenses within five years of each other. The ordinance allows the City to work with the Illinois Attorney General, Cook County State's Attorney, Cook County Sheriff, Illinois State Police Department, and other law enforcement agencies and officials to gather and share information relevant to an action under this ordinance. The ordinance would authorize courts to hold a defendant liable for compensatory and punitive damages or enter a fine up to \$10,000 for each offense. The proposal also stipulates that a minimum of 50 percent of any monetary fines recovered will be dedicated to supporting victims of, and witnesses to, gang-related activity.

Additionally, courts will have the discretion to order seizure and forfeiture of any property that is directly or indirectly used to facilitate streetgang-related activity and any property derived from gross profits or other proceeds obtained from gang-related criminal conduct.

"This ordinance will make major progress in the City's efforts to reduce violence caused by streetgangs," said Alderman Taliaferro, 29th Ward. "I am happy to be working on this with Mayor Lightfoot on this initiative and this will be an important tool to cut streetgangs off at the source and making the city safe for our residents again."





## Pappas: 36,000 properties are part of Cook County's first Tax Sale in more than two years, and 19,000 owe less than \$1,000



Cook County Treasurer Maria Pappas will conduct the first sale in more than two years of delinquent Cook County property taxes on November 5th, About \$163.4 2021. million in unpaid 2018 property taxes (that were to be paid in 2019) is due on 36,000 homes, businesses and land. Less than \$1,000 is owed on 11,744 properties in Chicago and 7,700 properties in suburban Cook County. Pappas is sending owners of those properties a certified mailing informing them that their unpaid taxes are scheduled to be sold. which would put a lien against their properties. It is the first step in a process that can end with the loss of a property. Owners can avoid the Tax Sale by paying the delinquent taxes and interest before the sale begins. To see if your taxes are delinquent – and to make a payment – visit cookcountytreasurer. com and select "Avoid the Tax Sale." You can search by address or by Property Index Number (PIN).

"About 75 percent of the taxes offered for sale are for properties in majority Black and Latino communities," Pappas said. "That's why Black and Latino Houses Matter, my program to help homeowners find refunds and apply for tax exemptions, is so important." Owners may be unaware the taxes on their properties are headed to the Tax Sale because the U.S. Postal Service has returned bills and subsequent notices on 17,702 properties. Also, as many as 207 seniors may be missing a senior exemption and 184 seniors may be eligible for a senior freeze – two exemptions that could reduce their tax bill. "Everyone should visit cookcountytreasurer.com for more information,' Pappas said. Per Illinois law, the annual Tax Sale traditionally is conducted 13 months after the due date but was delayed because of the COVID-19 pandemic. Pappas plans to conduct the sale for 2019 unpaid taxes in May and for the 2020 taxes in November 2022.



## Pappas: 36,000 Propiedades son parte de la Primera Venta de Impuestos en Más de Dos Años, y 19,000 Deben Menos de \$1,000

La Tesorera del Condado de Cook, María Pappas, conducirá la primera venta en más de dos años de impuestos de propiedad no pagados, el 5 de noviembre del 2021. Aproximadamente \$163.4 millones en impuestos de propiedad no pagados en el 2018 (que deberían pagarse el 5 de noviembre del 2019) vencen en 36,000 casas, comercios y terrenos. Menos de \$1,000 se debe en 11,744 propiedades en Chicago y 7,700 propiedades en suburbios del Condado de Cook. Pappas está enviando a los propietarios de estas propiedades un correo certificado informándoles que sus impuestos no pagados están programados para la venta. Esto sería un primer paso en un proceso que puede terminar con la pérdida de la propiedad. Los propietarios pueden evitar la Venta de Impuestos pagando los impuestos delincuentes y el interés antes de comenzar la venta. Para ver si sus impuetos son delictivos — y para hacer un pago — visite cookcountytreasurer.com y seleccione "Avoid the Tax Sale." Puede buscar por la dirección o por el Número de Index de la Propiedad (PIN).

"Aproximadamente 75 por ciento de los impuestos ofrecidos a la venta son propiedades en su mayoría de comunidades afroamericanas y latinas", dijo Pappas. "Por Esto es que las Viviendas de Afroamericanos y Latinos Importan, mi programa para ayudar a los propietarios, que encuentra reembolsos y la aplicación de exenciones de impuestos, es tan importante". Los propietarios pueden no saber que los impuestos de

sus propiedades van a ser puestos a la venta porque el Servicio Postal de E.U. ha regresado cuentas y avisos subsecuentes en 17,702 propiedades. También, tantos como 207 ciudadanos mayores pueden estarse perdiendo de la exención a ciudadanos mayores y 184 de estos ciudadanos pueden ser elegibles para el senior freeze dos exenciones que podrían reducir su cuenta de impuestos. "Todos deben visitar cookcountytreasurer. com para más información", dijo Pappas. Por la ley de Illinois, la Venta de Impuestos anual tradicional es conducida 13 meses después de la fecha de vencimiento. pero fue demorada por la pandemia del COVID-19. Pappas planea conducir la venta para los impuestos no pagados del 2019 en mayo y los impuestos del 2020 en noviembre del 2022.


