Drug Use, Mental Health Most Pressing Youth Health Concerns in Chicago Identified by Adults During Pandemic



During the COVID-19 pandemic, Chicago parents and other adults identified drug use and mental health as the most prominent health issues for Chicago's children and adolescents, according to results from a new survey developed by Ann & Robert H. Lurie Children's Hospital of Chicago and the Chicago Department of Public Health (CDPH). These were also leading concerns before the COVID-19 pandemic, but social isolation and major changes to daily routines during the pandemic further escalated the difficulties that youth experience. The study found that: •Drugs, tobacco and ecigarette use ranked as the top concerns

•Stress, depression and suicide were also major concerns

•Women were more likely to be concerned about each

issue than men

As in previous years, mental and behavioral health issues ranked high on the list of concerns for youth health in Chicago, with 62 percent of adults saying that stress and depression were big problems. Without question, the pandemic has intensified pediatric mental health concerns, to the point that there is a youth mental health crisis in Chicago and nationally. Youth-serving institutions in community and healthcare settings are working to address the increased need for pediatric mental and behavioral health support. Chicago adults were also concerned about the potential for youth suicide, with 57 percent of adults saying it was a critical problem. The survey found that Latinx and Black adults were far more concerned about youth suicide (64 and 61 percent respectively) than White adults (48 percent). The top-ranked youth health concerns identified by adults in the study were:

- 1. Drugs 65%
- 2. Tobacco and e-cigarettes
- 65%
- 3. Stress -62%
- 4. Depression 62%
- 5. Child Abuse and Neglect 60%
- 6. Suicide 57%
- 7. Childhood Obesity 57%
- 8. Teen Pregnancy 49%
- 9. Alcohol 46%
- 10. Unintentional Injuries
- 39%

Jesse White Reminds Motorists to Report Defective License Plates

Illinois Secretary of State Jesse White is reminding vehicle owners to report license plates to the Secretary of State's office that are peeling, chipping or rusting in order to receive replacement plates at no charge. Vehicle owners whose license plates are damaged or degraded can notify the Secretary of State's office by calling 800-252-8980 or visiting https://apps. ilsos.gov/defectiveplate/. A registration identification number and pin, found on the vehicle's registration card, are required to report the degraded license plates, which will then be replaced at no cost to the vehicle owner or the state of Illinois. Owners are

encouraged to recycle their old plates by taking them to a Secretary of State facility and disposing of them in the tamper-proof bin. The purpose of the replacement program is to ensure that older license plates on Illinois roads are replaced. License plates' reflectivity diminishes with age, which impacts law enforcement's ability to quickly and accurately identify license plate numbers.

Avocados Change Belly Fat Distribution in Women, Controlled Study Finds



Study by University of Illinois at <u>Urbana-Champaign</u>

An avocado a day could help redistribute belly fat in women toward a healthier profile, according to a new study from the University of Illinois Urbana-Champaign

and collaborators. One hundred and five adults with overweight and obesity participated in a randomized controlled trial that provided one meal a day for 12 weeks. Women who consumed avocado as part of their daily meal had a reduction in deeper visceral abdominal fat. Led by Naiman Khan, an Illinois professor of kinesiology and community health, the researchers published their study, funded by the Hass Avocado Board, in the Journal of Nutrition. "The goal wasn't weight loss; we were interested in understanding what eating an avocado does to the way

individuals store their body fat. The location of fat in the body plays an important role in health," Khan said. The participants were divided into two groups. One group received meals that incorporated a fresh avocado, while the other group received a meal that had nearly identical ingredients and similar calories but did not contain avocado. At the beginning and end of the 12 weeks, the researchers measured participants' abdominal fat and their glucose tolerance, a measure of metabolism and a marker of diabetes. Female participants who consumed an avocado a

day as part of their meal had a reduction in visceral abdominal fat -- the hardto-target fat associated with higher risk -- and experienced a reduction in the ratio of visceral fat to subcutaneous fat, indicating a redistribution of fat away from the organs. However, fat distribution in males did not change, and neither males nor females had improvements in glucose tolerance.



"La actividad criminal de pandillas impone substanciales costos a la ciudad, los residentes y los barrios donde operan. La Ordenanza Justicia para las Víctimas, hecha a semejanza del Acta Illinois Streegang Terrorism Omnibus Prevention de 1993, permitiría a la ciudad registrar una queja civil contra miembros de pandillas que se involucren, a sabiendas, en dos o más ofensas criminales relacionadas con pandillas, dentro de cinco años una de otra. La ordenanza permite a la Ciudad trabajar con el Procurador General de Illinois, el Procurador del Estado del Condado de Cook, el Alguacil del Condado de Cook, El Departamento de Policía Estatal de Iliinois y otras agencias de la ley y los funcionarios se reúnen y comparten información relevante a una acción bajo esta ordenanza.

La ordenanza autorizaría a las cortes a hacer responsable al acusado por daños compensatorios y punitivos o pagar una multa de hasta \$10,000 por cada ofensa. La propuesta estipula también que un mínimo del 50 por ciento de las multas en efectivo recuperadas serán dedicadas a apoyar a las víctimas de y testigos de una actividad relacionada con las pandillas. Adicionalmente, las cortes tendrán la discreción de ordenar la confiscación de cualquier propiedad que sea directa o indirectamente utilizada para facilitar actividades relacionadas con pandillas y cualquier propiedad derivada del ingreso bruto u otros procedimientos obtenidos con conducta criminal relacionada con las pandillas.

"Esta ordenanza hará u nmayor progreso en los esfuerzos de la ciudad por reducir la violencia causada por las pandillas, dijo el Concejal Taliaferro, del Distrito 29. "Me siento feliz de estar trabajando con la Alcaldesa Lightfoot en esta iniciativa y será un importante medio para acabar con las pandillas y hacer de la ciudad, una vez más, un lugar seguro para nuestros residentes"



City Introduces New Plan to Combat Street Gangs

In a move that has many Chicagoans wondering how it will work, Mayor Lori Lightfoot introduced the Victims Justice Ordinance on Tuesday, a new ordinance that aims to hold streetgangs accountable, will allow the City to file a civil claim against those who engage in a pattern of criminal activity and permit the City to recover compensatory and punitive damages, forfeiture of property, abatement, and injunctive relief when the defendant is found to have engaged in criminal gang activity.

"Today we are taking steps to expand the fight against violent streetgangs by creating additional civil tools that will directly impact the profit motive used by these perpetrators who terrorize our communities," said Mayor Lightfoot. "Criminal gang activity imposes substantial costs on the City, residents, and the neighborhoods where they operate. If we are successful, we will seize their assets and disrupt the financial lifelines that support this criminal activity and fuels their dominance in our city."

The Victims Justice



Ordinance, modeled after the 1993 Illinois Streetgang Terrorism Omnibus Prevention Act, would allow the City to file a civil complaint against streetgang members who knowingly engaged in two or more gang-related criminal offenses within five years of each other. The ordinance allows the City to work with the Illinois Attorney General, Cook County State's Attorney, Cook County Sheriff, Illinois State Police Department, and other law enforcement agencies and officials to gather and share information relevant to an action under this ordinance. The ordinance would authorize courts to hold a defendant liable for compensatory and punitive damages or enter a fine up to \$10,000 for each offense. The proposal also stipulates that a minimum of 50

percent of any monetary fines recovered will be dedicated to supporting victims of, and witnesses to, gang-related activity. Additionally, courts will have the discretion to order seizure and forfeiture of any property that is directly or indirectly used to facilitate streetgang-related activity and any property derived from gross profits or other proceeds obtained from gang-related criminal conduct.

"This ordinance will make major progress in the City's efforts to reduce violence caused by streetgangs," said Alderman Taliaferro, 29th Ward. "I am happy to be working on this with Mayor Lightfoot on this initiative and this will be an important tool to cut streetgangs off at the source and making the city safe for our residents again.
