# Spreading the Love: Hispanic Heritage Series Honors Maria Castro

They say leadership takes on many dimensions and encompasses many definitions; leadership is meant to inspire, motivate, and aspire to achieve a common goal. And while we may face the call to step into that role, few of us answer. Maria Castro, regional external affairs manager for Comcast, answered her call when a longtime friend approached her about the struggle to help the women at A Safe Haven in Chicago. "It was the beginning of COVID when my friend shared with me how she felt overwhelmed by the amount of women and families entering her doors due to the pandemic, women who experienced physical abuse, emotional and mental abuse, women who lost their jobs," said Castro. "These women needed tremendous help. They needed shelter. They needed a friend." While the world hunkered down during the pandemic, Castro rolled up her sleeves and got to work collecting essential supplies for the women at Save Haven. She collected toiletries, spread the word to her fellow colleagues, built a network of women ready to donate, and eventually turned her act of altruism into a legitimate project, called #LovePurse, an organization designed to collect and donate an array of purses filled with important toiletries, notepads, and most notably inspirational notes letting



the women at Safe Haven know they are not alone. "As women we carry everything in our purse, our lives. It holds our identification cards, it holds our money, and it holds personal items that we like to keep close. These women, who escaped from domestic violence left everything behind; their purse, their sense of self," said Castro. "I didn't want to collect these items and just hand them over in a plastic bag, I wanted this to be more personable; I wanted these purses to restore their identity, their sense of freedom in a way. So I scoured the Amazon

website to buy all the purses I could find. I also wanted to incorporate a special element to the bag, I wanted to leave letters to these women so they could feel inspired. So they could feel that there is someone in their corner rooting for them to succeed. The letters are written by all the women who have donated a purse, women from all over the country.

"My parents came from Mexico, they worked hard and we didn't exactly grow up with a lot of money, but we definitely had privilege. I went to great schools, I had a wonderful child, and most importantly there was

a lot of love in my family. I was constantly told that I could succeed, that I was loved, my parents always lifted me up so it breaks my heart to see these women never hearing the words, "I love you," or hearing that they matter," Castro said. "These women are truly the inspirational ones because they escaped a dangerous situation to start a new life." To date, Castro has collected over 100 purses and is now working with several non-for-profit organizations designed to help women experiencing homelessness and domestic violence. She has worked with Mutual Ground in Aurora, Community Crisis Center in Elgin, Las Casa Norte, and currently collecting purses for the Chicago Latina Expo at Macy's in October. "I am in sheer amazement just how many women in my life and men too that have answered the call to action and donated. Words cannot express how grateful and thankful I am to be able to grow this project and hopefully help the women from these organizations and beyond." María Castro, gerente regional de asuntos externos de Comcast, respondió a su llamada cuando una amiga de mucho tiempo se acercó a ella sobre la lucha para ayudar a las mujeres en A Safe Haven en Chicago. Recogió artículos de tocador, corrió la voz entre sus colegas, creó una red de mujeres listas para donar y, finalmente, convirtió su acto de altruismo en un proyecto legítimo. llamado #Love-Purse, una organización

diseñada para recolectar y donar una variedad de carteras llenas de artículos de tocador importantes, cuadernos de notas y, sobre todo, notas inspiradoras que les permiten a las mujeres de Safe Haven saber que no están solas.

"Como mujeres llevamos todo en nuestro bolso, nuestras vidas. Tiene nuestras tarjetas de identificación, nuestro dinero y objetos personales que nos gusta tener cerca. Estas mujeres, que escaparon de la violencia doméstica lo dejaron todo atrás; su bolso, su sentido de sí mismo", dijo Castro. "No quería recolectar estos artículos y simplemente entregarlos en una bolsa de plástico, quería que esto fuera más agradable; Quería que estas carteras restauraran su identidad, su sentido de libertad de alguna manera. Así que busqué en el sitio web de Amazon para comprar todas las carteras que pude encontrar. También quería incorporar un elemento especial al bolso, quería dejarles cartas a estas mujeres para que se sintieran inspiradas. Para que puedan sentir que hay alguien en su esquina alentándolos para que tengan éxito. Las cartas están escritas por todas las mujeres que han donado un monedero, mujeres de todo el país.

## Woman Charged with Human Trafficking

A Chicago woman who befriended and then sexually trafficked a runaway teen has been charged with involuntary sexual servitude and human trafficking, Cook County Sheriff Thomas J. Dart announced Monday. On Thursday, September 16, members of the Sheriff's Police Special Victims Unit were in the vicinity were in the vicinity of 5th Avenue and Cicero Avenue in Chicago, a known location for sex trafficking, when they came upon an 18-yearold victim and Kyla Hunter,

22, of the 5500 block of West Gladys Avenue. Due to a prior investigation, SVU members had reason to believe Hunter was trafficking the victim.

SVU members took both Hunter and the victim into custody, and investigators later learned that the victim was a 16-year-old runaway in October 2019 when she met Hunter, who complimented her on her appearance and invited her home. Hunter established a relationship with the victim, who she knew was a minor, and coerced her

to engage in prostitution, keeping the proceeds that the victim received. The abuse continued for about 1-2 weeks, after which the victim left Hunter. In August, the victim and Hunter reconnected, and Hunter again began to have the teen engage in prostitution. All the proceeds were kept by Hunter.

The victim was not charged with prostitution-related crimes but was instead connected with a Sheriff's Police Victims Service Specialist, who is assisting

her with specific needs that she has at this time. Hunter was charged with two counts of involuntary sexual servitude, a Class 1 felony, and one count of trafficking in persons, a Class 4 felony. She appeared for a bond hearing on Saturday. September 18, where she was issued a \$100,000 Deposit Bond. She is currently in custody at the Cook County Jail. The public is reminded that the defendant is presumed innocent until proven guilty by the government in a court of law.

# **Governor Announces New Household Assistance for Low-Income Families**

Governor JB Pritzker joined the Illinois Department of Commerce and Economic Opportunity (DCEO) and community partners to announce \$327 million in Help Illinois Families assistance now available through the Low-Income Household Energy Assistance Program (LIHEAP) and the Community Services Block Grant Program (CSBG). The program

offers expanded services to support Illinois' most vulnerable residents with rent, utilities, food and other household expenses regardless of immigration status. LIHEAP funds are available from now through May 31, 2022. To apply, please go to DCEO's website or visit helpillinoisfamilies. com. To qualify for LIHEAP, households must demonstrate if they

meet the expanded income requirements of 200 percent of the poverty level, regardless of immigration Recommended documents for application include Social Security Number, or I-TIN, or other identification, and proof of income. Applicants need to supply their utility bill for LIHEAP and lease for rental assistance. For more information about the relief programs, visit the DCEO website.
