City Announces Efforts to Reduce Violence

City leaders on Wednesday announced collaborative efforts designed to prevent and reduce crime and violence, including community safety town halls curated to each Chicago region that will provide an opportunity for residents to ask questions, share

feedback, and inform the City on violence prevention strategy. "The COVID-19 pandemic taught us that partnering with community leaders is key to our success to co-create and implement equitable and efficient strategies," said Tamara Mahal, CSCC Chief Coordination Officer. "The CSCC is designed around deep partnership with those

most impacted by violence and the mobilization of our city department resources in response."

Since the launch of Chicago's first-ever Community Safety Coordination Center (CSCC) in August, 2021, the City has worked with health care providers, c o m m u n i t y - b a s e d organizations and faith

leaders. Over twenty departments and agencies worked through a process to identify their role in violence prevention. As a result, the City is implementing targeted strategies, including

•People-based strategy: Connecting, coordinating, and organizing supports and opportunities around those at the highest risk for violence involvement.

•Crisis

response: Supporting law enforcement partners with deep engagement with community and strengthening collaborations to build stronger, coordinated pathways to resources for those who are justice-

involved.

"Making our city safer means ensuring every community has a voice,' said Chicago Police Department Superintendent David O. Brown. "The work of the Chicago Department, Police the Community Safety Coordination Center, and every city department go hand in hand because we all play an important part in preventing violence." Between March 9th and March 19th, the CSCC and CPD will host six virtual community safety town halls tailored to the needs of each Chicago region, with one town hall fully in Spanish. "La pandemia de El COVID-19 nos enseñó que afiliarse con líderes comunitarios es la clave de nuestro éxito para co-crear e implementar estrategias equitativas y eficientes", dijo Tamara Mahal, Funcionaria de Coordinación en Jefe de CSCC. "CSCC está diseñado en torno a una asociación profunda con los más afectados por la violencia y la movilización de los recursos del departamento de nuestra ciudad en respuesta".

Desde el lanzamiento del Centro de Coordinación de Seguridad Comunitario de Chicago (CSCC) en agosto del 2021, la Ciudad ha trabajado con proveedores de cuidado de salud organizaciones comunitarias y líderes religiosos. Attorney General Raoul, ISBE Announce Guidance to Combat School-to-Prison Pipeline



Attorney General Kwame Raoul, along with Illinois

State Board of Education (ISBE) Superintendent

of Education Dr. Carmen I. Ayala, announced the

state's first guidance for school districts to ensure that disciplinary policies do not violate civil rights laws. The guidance is aimed in part at addressing the connection between exclusionary school discipline practices and increased rates of incarceration, often referred to as the schoolto-prison pipeline. Illinois law requires school boards and the governing bodies of charter schools to conduct annual reviews of discipline policies and their implementation. Raoul

and ISBE are encouraging school boards to review disparities in discipline data and eliminate policies and practices associated with having a race-based disparate impact. During the 2019-2020 school year, 45 percent of students expelled from Illinois public schools were Black, despite comprising less than 17 percent of the state's student population. The Attorney General's Civil Rights Bureau enforces state and federal civil rights laws prohibiting discrimination. Attorney General Raoul

The Whole School Safety Steering Committee, an unprecedented partnership between the Chicago Public Schools administration and five community-based organizations, launched a survey to gather vital data from students, parents, teachers, administrators and community members on a reimagined approach to school safety. Governor Pritzker Issues Updated Executive Order with New Mask Guidelines



With COVID-19 positivity rates continuing to decline and the majority of eligible Illinoisans vaccinated, today Governor Pritzker released an updated executive order lifting the mask requirement in most indoor settings. In accordance with CDC guidance, the executive order also lifts the mask requirement

in K-12 schools and daycares. School districts and private businesses can continue to require masks at their discretion. Masks are currently required for all residents, staff, and visitors to long-term care facilities, congregate facilities (i.e. – correctional facilities and homeless shelters) and in healthcare settings, regardless

of vaccination status. Additionally, pursuant to federal mandates, all individuals over the age of two, regardless of vaccination status, must wear a face covering on public transportation including, but not limited to, planes, trains, and buses and while in transportation hubs such as airports and bus stations. Vaccines continue to be readily available at pharmacies across the state, many local health departments, doctor offices, federally qualified health centers, and other locations. Illinois DCFS Ofrece Becas Universitarias

El Gobernador Pritzker Emite una Orden Ejecutiva Actualizada con Nuevas Pautas Para el uso de Mascarillas

Con el índice de positividad del COVID-19 que continúa bajando y la mayoría de residentes de Illinois vacunados, el Gobernador Pritzker publicó una orden ejecutiva actualizada para retirar el requisito de las mascarillas en la mayoría de lugares bajo techo. De acuerdo con las guías de CDC, la orden ejecutiva retira también el requisito de las mascarillas en las escuelas K-12 v en las guarderías. Los distritos escolares y los comercios privados pueden continuar requiriendo las

mascarillas a su discreción. Actualmente se requieren mascarillas para todos los residentes, el personal y los visitantes a instalaciones de cuidado de salud a largo plazo, instalaciones congregadas (i.e. – centros correccionales y albergues para desamparados) y en lugares de cuidado de salud, sin importar el estado de vacunación. Adicionalmente, de conformidad con los mandatos federales. toda persona mayor de dos años, sin importar su estado de vacunación, debe usar una mascarilla en lugares

de transportes públicos, incluyendo, pero no limitando a aviones, trenes y autobuses y mientras se encuentren en lugares de transporte, como aeropuertos y estaciones de autobuses. Las vacunas continúan disponibles en farmacias del estado, muchos departamentos locales de salud, oficinas de los doctores, centros de salud calificados a nivel federal y otros lugares. Forty Days of Peace

In an effort to combat

Catholic Christian Churches in the Pilsen neighborhood called on community members to hold a ceasefire as the "40 Days of Peace" campaign kicked off on Ash Wednesday.

"This is an opportunity to pray for peace, not only for the people in our own communities but around the world," said Fr. Mike Enright, Pastor of St. Paul Catholic Church. "We are all children of a loving God, a God who weeps also for those who commit violence upon others. We, as His children, are called to bring peace through our words and our actions," he continued.

The coalition of faith based leaders, known as the Pilsen Faith Table Initiative, calls on all churches, businesses and neighbors of Pilsen to be peacemakers in the neighborhood and together seek an end to violence. The Pilsen Faith Table Initiative is made up of churches and organizations including St. Paul Catholic Church, St. Pius V Catholic Church, St. Procopius – Providence of God Catholic Church, New Life Community Church, Lincoln United Methodist Church, Bethel Temple, the Healthy Hood.

Ministers priests from the seven Pilsen churches offered prayers and ashes to residents on Wednesday morning and evening at the 18th Station (Pink Line) and the Damen Station (Pink Line). Neighbors gathered for prayer huddles, received ashes, and were encouraged to spread messages of peace throughout Lent.

"We are asking for prayers and peace from all the violence that is happening in our communities every day, taking the lives of our young kids," said Dalia Radecki, Pilsen resident and community leader with The Resurrection Project. asking parents to become more involved, to be more caring. We are losing a lot of young kids to violence, so we are asking parents and everyone to step up. Violence needs to stop." "We are promoting Forty

Days of Peace, but of course we are praying to God for 4,000 years of peace, but we have gotten together with other faithbased movements, our beliefs may be different, but we are together focusing on peace in Pilsen. We are here doing our thing and praying for those who allow us to pray for them," said Pastor Johnny Delgado of Bethel Temple.

The bidder is specifically advised that the City is a recipient of a grant made pursuant to the Housing and Community Development Act of 1974 as amended. Further, in compliance with the Stevens Amendment to the Department of Defense Appropriation Act of 1989, the estimated percentage of the total cost of this project to be funded with federal dollars is one hundred percent (100%) and the exact dollar amount of federal funds which will be set aside for this project will be based on the Contract amount awarded under this offering.

All laborers and mechanics employed by Contractor or Subcontractor(s) on construction work for this project shall be paid wages at rates not less than those prevailing on similar construction in the locality as determined by the Secretary of Labor in accordance with the Davis-Bacon Act as amended (U.S.C. 76-276a-5), and shall receive overtime compensation in accordance with and subject to the provisions of the Contract Work Hours and Safety Standards Act (40 U.S.C. 327-333) and the Contractor and Subcontractor(s) shall comply with all regulations issued pursuant to these Acts and other applicable Federal laws and regulations pertaining to labor standards. Mobile Payment App Scams on the Rise, ComEd and BBB Warn Utility Customers



The popularity of mobile payment apps like Cash App and Venmo is giving rise to incidents of scammers using these digital networks to bilk ComEd customers out of their hard-earned money. ComEd urges customers to be aware of these new scam attempts so they identify and avoid them. In January 2022, ComEd received more than 240 reports of scams from customers, a more than 150-percent increase from January 2021. Even worse, the amount of money reported lost to successful scams rose dramatically to more than \$27,000 in January 2022, 20 times more than January 2021. Scammers are contacting ComEd customers by phone, although some contacts can be made by text or email, demanding payment to a particular account under the threat of service immediate disconnection. The imposter will instruct the

customer to use a mobile payment app, which often have higher transaction limits than pre-paid cash cards.

Tips to Help Identify Scams

ComEd will never call or come to a customer's home or business to:

- Ask for direct payment with a prepaid cash card, cryptocurrency such as Bitcoin, or
- third-party payment app like Cash App, QuickPay, Venmo or Zelle.
- Demand immediate payment.
- Ask for a ComEd account number or other personal information, such as a Social Security number, driver's license number or bank information.

To identify an actual ComEd employee or communication, remember:

• All ComEd field employees wear a uniform with the ComEd logo and visibly display

a company ID badge with the logo and employee's name. ComEd recently changed its logo, so you may continue to see the former ComEd logo on uniforms.

badges and vehicles until it is phased out.

- Check the name on email or websites and make sure they match the name and address of the company you do business with. Look for misspellings or slight alterations.
- Make a call to verify the suspected email or website is from a trusted source. Use a

phone number from your personal business records or the company's official website and not the number provided in the email.

Baltimore and Ohio Chicago Terminal Railroad (B&OCT) is issuing an invitation to bid on the CREATE P3 – Stage II, B&OCT/CSXT Track, Earthwork, Retaining Wall and Bridge Construction project in Chicago, Illinois. (B&OCT/CSXT Milepost: DC 21.78 to DC 23.87)

The P3 project is a Public Private Partnership (PPP) implementing the 75th Street Corridor Improvement Project (CIP) in Chicago. The intent of the project is to improve mobility for rail passengers, freight, and roadway users by reducing rail-rail conflicts, reducing local mobility problems, and improving rail passenger transit service.

Generally, the project consists of heavy earthwork, ground improvements, drainage and erosion control, precast modular retaining wall construction, caisson installation, cast-in-place concrete pier construction, steel span manufacturing and erection, environmental compliance work, and railroad track construction including the removal of eight railroad crossing diamonds.

Additionally, this project will be funded in part by federal and/or state funds. Therefore, bidder will be required to comply with certain State and Federal policies, such as Buy America, Equal Employment Opportunity, Disadvantage Business Enterprise participation (30%), IDOT Training Program On-the-Job Training Special Provisions, and Davis-Bacon prevailing wage rates.

Insurance requirements (subject to change) are: Commercial General Liability combined single limit \$5M per occurrence and \$10M aggregate, Automobile Liability combined single limit \$1M per occurrence, Employers' Liability Insurance, Builder's Risk Insurance, and Workers' Compensation Insurance. B&OCT/CSXT requires that the railroad be named as an additional insured. Insurance coverage cannot be denied within 50 feet of a railroad.

Health and Safety Action Plan is required. Contractor safety orientation training and employee participation in ISN (www.isnetworld.com) program is required. All attendees must follow City of Chicago Public Health Order No. 2021-1 while attending this meeting and must provide and wear railroad approved PPE including but not limited to eye protection, hard hats, high visibility vests and lace up work boots with toe protection to participate in the site inspection.

DBE requirement on contracting is 30% for Phase III construction work. Illinois lawmakers must create legal balance between owners, renters of storage units

During and since my time as an active-duty officer in the Army, I have devoted much time and energy to protecting military service members from financial predators. Last year I focused on the passage of the Predatory Lending Prevention Act (PLPA), and the nationwide repeal of a Comptroller of the Currency rule that protected payday lenders using evasive schemes to get around stateimposed usury rate caps. While those efforts were successful, there is more to do.

Recently, I took notice of a bill in the Illinois Legislature, HB 4627, which would allow the owners of self-storage locker facilities to avoid altogether the required public notice of the auction of renters' items when his or her belongings have been confiscated. Those auctions often take place without the knowledge of the renter, who might be overseas defending our country or assisting fellow citizens falling victim to natural disasters. Illinois law requires owners to notify renters of an auction only by sending notice to the renter's "last known address."

A deeper look into Illinois' Self Storage Facility Act reveals a law that is astonishingly lopsided in favor of locker owners to the detriment of renters. It is a law in need of reform. Whether the renter is activeduty military, our neighbors in the military Reserve or National Guard called to duty, a victim of eviction, or a victim of a house fire, every effort must be made to locate the renter before selling what could be their worldly belongings. Public notice in newspapers and their attendant websites helps. California law requires owners to allow renters to submit the name and address of a second individual to whom all notices must be sent. In addition. California law also allows renters to formally object to an auction after which the owner must get a court's blessing before proceeding. Illinois law should do the same.

Locker rent increases and late fees should be examined. How many rent increases should a renter endure after their belongings are in storage? Active-duty military or reservists and Guardsmen called to duty might find it impossible to competitively shop or even receive notice once deployed. The current law should be viewed from the perspective of the transient and the vulnerable, not from only the point of view of owners.

I am all too familiar with real-life cases in which deployed service members have lost literally everything when storage facility owners sell off their possessions. I am sure that, given these difficult times, many other Illinoisans have suffered or will suffer the same. There are several other changes in Illinois law that could help protect the renters of storage lockers. Many of those changes have been proposed by my colleagues, including the Woodstock Institute, Chicago Urban League, Housing Action Illinois, and Legal Action Chicago. Those changes include several provisions that would benefit renters and help provide a balance between the rights of renters and owners. I urge legislators to not only reject HB 4627 but to reform Illinois' Self Storage Facility Act as soon as possible.

Los Legisladores de Illinois Deben Crear un Equilibrio Legal Entre Propietarios e Inquilinos de Unidades de Almacenamiento

Durante y desde mi época como oficial activo en el Ejército, he dedicado mucho tiempo y energía a proteger a los miembros del servicios militar de depredadores financieros. El año pasado me enfoqué en la aprobación del Acta de Prevención de Préstamos Abusivos (PLPA), y la derogación a nivel nacional de una regla del Contralor de la Moneda que protegía a los prestamistas de día de pago que usaban esquemas evasivos para eludir los topes de tasa de usura impuestos por el estado. Si bien esos esfuerzos tuvieron éxito, aún hay mucho por hacer.

Recientemente tomé nota de un provecto en la Legislatura de Illinois, HB 4627, que permitiría que los propietarios de instalaciones de casilleros de autoalmacenamiento evitaran por completo el aviso público requerido de la subasta de los artículos de los arrendatarios cuando sus pertenencias hayan sido confiscadas. Estas subastas muchas veces tenían lugar sin el conocimiento del inquilino, quien podía estar fuera del país defendiendo nuestro país o ayudando a ciudadanos víctimas de desastres naturales. La ley de Illinois requiere que los propietarios notifiquen a los inquilinos de una subasta, solo enviando un aviso a la "última dirección conocida" del arrendatario.

Una mirada más profunda a la Ley de Instalaciones de Autoalmacenamiento de Illinois revela una ley que está sorprendentemente desequilibrada a favor de los propietarios de casilleros en detrimento de los inquilinos. Es una ley que necesita reformarse. Si el inquilino está activo en el servicio militar, nuestros vecinos en la Reserva militar o la Guardia Nacional los llamó al deber, son una víctima de desalojo, o una víctima de un incendio en la casa, se debe hacer todo lo posible para localizar al arrendatario antes de vender lo que podrían ser sus pertenencias materiales. Una nota pública en los periódicos y sus redes asistentes avuda. La lev de California requiere que los propietarios permitan a los inquilinos enviar el nombre y dirección de una segunda persona a quienes lleguen los avisos. Además, la ley de California también permite que los inquilinos se opongan formalmente a una subasta, después de lo cual el propietario debe obtener la aprobación de un tribunal antes de proceder. La ley de Illinois debería hacer lo mismo.

Se deben examinar los aumentos de alquiler de casilleros y los recargos por pagos atrasados. ¿Cuántos aumentos de alquiler debe soportar un inquilino después de que sus pertenencias estén almacenadas? Los militares en servicio activo o los reservistas y los miembros de la Guardia llamados al servicio pueden encontrar imposible comprar de manera competitiva o incluso recibir un aviso una vez desplegados. La lev actual debe verse desde la perspectiva de los transeúntes y los vulnerables, no solo desde el punto de vista de los propietarios.

Estoy demasiado familiarizado con casos de la vida real en los cuales



miembros del servicio desplegados han perdido literalmente todo cuando los propietarios de casilleros de almacenaje venden sus posesiones. Estoy seguro de que, dado estos tiempos difíciles, muchos otros residentes de Illinois han sufrido o sufrirán lo mismo. Hay varios otros cambios en la ley de Illinois que podrían ayudar a proteger a los inquilinos de casilleros de almacenaje. Muchos de esos cambios han sido propuestos por mis colegas, incluyendo el Instituto Woodstock, Chicago Urban League, Housing Action Illinois y Legal Action Chicago. Esos cambios incluyen varias provisiones que beneficiarian a los inquilinos v avudarían a establecer un balance entre los derechos de los inquilinos y los propietarios. Exhorto a los legisladores a que no solo rechacen la HB 4627 sino que reformen la Ley de Instalaciones de Autoalmacenaje de Illinois lo antes posible.


