

Sixth Black, Latino Houses Matter Phone Bank May Give Cook County Property Owners \$3.3M in Refunds

More than 1,400 Cook County taxpayers may be eligible to receive \$3.3 million in property tax refunds and exemptions after calling in to the Black and Latino Houses Matter phone bank hosted by Cook County Treasurer Maria Pappas and ABC 7 Chicago Wednesday. A team of 50 researchers helped callers find refunds, apply for property tax exemptions and avoid the Tax Sale of delinquent taxes. During one particularly busy stretch at midday, there were more than 120,000 callers to the phone bank. "I said we would do this as long as people need money," said Pappas. "Wednesday's phone bank shows us that they do. We're both glad and humbled at the response." The last phone bank conducted by



the Treasurer's Office in December helped more than 1,500 taxpayers identify \$3.5 million in potential refunds and missing exemptions. The first phone bank was held over a three-day stretch in

March 2021. Over 6,000 thousand taxpayers were seeking \$12.7 million in potential refunds. Property owners who did not call the phone bank can visit cookcountytreasurer.com to:

• Check if you are eligible for \$34 million in missing property tax exemptions

El Banco Telefónico de Six Black, Latino Houses Matter Puede Otorgar a Propietarios del Condado de Cook \$3.3 Millones en Reembolsos



Más que 1,400 contribuyentes del Condado de Cook pueden ser elegibles para recibir \$3.3 millones en reembolsos y exenciones en impuestos de propiedad después de llamar al teléfono bancario de Black and Latino Houses Matter ofrecido por la Tesorera del Condado de Cook María Pappas y ABC 7 Chicago, el miércoles. Un equipo de 50 investigadores ayudaron a las personas que llamaron a encontrar reembolsos, aplicar por las exenciones de impuestos de propiedad y evitar la Venta de Impuestos de impuestos no pagados. Durante un tramo particularmente ocupado al mediodía, hubo más de 120,000 llamadas al banco de teléfonos. "Dije que haríamos esto siempre que la gente necesite dinero", dijo Pappas. "las llamadas por telé-

fono al banco el miércoles nos muestran que funciona. Estamos encantados con la respuesta". El último banco telefónico realizado por la Oficina de la Tesorera en diciembre ayudó a más de 1,500 contribuyentes a identificar \$3.5 millones en posibles devoluciones y exenciones faltantes. El primer banco telefónico tuvo lugar por tres días en marzo del 2021. Más de 6,000 mil contribuyentes estuvieron buscando \$12.7 millones en presuntos reembolsos. At this crucial moment, I am excited to serve my community and make North Lawndale a better place for all." Cook County Jail Reports the Highest Voter Turnout

As of June 14th, Chicago’s 24th ward, housing Cook County Jail, has the highest voter count of the 479 ballots in the 24th ward, 388 were cast in the jail in early election polling sites. This comes just two years after Senate Bill 2090 (SB 2090) became law. SB 2090 requires Cook County Jail to serve as an official polling location for those in custody and requires all other county jails throughout Illinois to facilitate a vote-by-mail chase program. In 2019, Chicago Votes, a non-partisan, non-profit organization working to break down barriers young people face to engaging in our democracy, wrote and advocated for Senate Bill 2090, Voting in Jails. In 2020, the first year the law was put into effect, voter turnout in Cook County Jail was approximately 32.9 percent in the primary, jumping to approximately 40.25 percent in the general.



“This is a dream come true for voter participation at the intersection of democracy and the American legal system,” says Jen Dean, co-executive director of Chicago Votes. “The goal was to build political power in the jail and we are doing that. The jail currently holds the most electoral power in the city of Chicago. This should be a wake-up call for elected

officials to listen to the needs of those in custody.” The low voter turnout throughout the remainder of Chicago is still a major concern for Chicago Votes. “We want to see high voter turnout everywhere. When more people vote, the needs of our community members are more accurately represented,” says Stevie Valles, co-

executive director of Chicago Votes. “To reach young voters throughout Chicago, we hosted Parades to the Polls™ with students from Orr and Hancock high schools; are hosting parties outside polling places in North Lawndale, Englewood, and Woodlawn; and we are out canvassing.”

La Cárcel del Condado de Cook Reporta la Participación Electoral más Alta

Hasta el 14 de junio, el Distrito 24 de Chicago, sede de la Cárcel del Condado de Cook tiene el mayor conteo de votantes de las 479 casetas en el distrito 24, 388 fueron depositadas en la cárcel en los sitios de votación de elecciones anticipadas. Esto sucede justo dos años después que el Proyecto 2090 del Senado (SB 2090) se convirtiera en ley. SB 2090 requiere que la Cárcel del Condado de Cook sirva como un lugar oficial de votación para quienes están en custodia y requiere que todas las otras cárceles

del condado en Illinois faciliten un programa de seguimiento de voto por correo.

En el 2019, Chicago Votes, organización no lucrativa que lucha por romper las barreras que enfrentan los jóvenes para participar en nuestra democracia, escriban y voten por el Proyecto del Senado 2090, Votación en las Cárcel. En el 2020, el primer año en que entró la ley en efecto, la participación de votantes en la Cárcel del Condado de Cook fue de aproximadamente 32.9 por ciento en las primarias, subiendo a 40.25

por ciento en general.

“Esto es un sueño hecho realidad de la participación de votantes en la intersección de la democracia y el sistema legal estadounidense”, dijo Jen Dean, director co-ejecutivo de Chicago Votes. “La meta era establecer un poder político en la cárcel y eso es lo que estamos haciendo. La cárcel tiene actualmente el mayor poder electoral en la ciudad de Chicago. Esto debería de ser una llamada de atención para que los funcionarios electos escuchen las necesi-
