

Designs for a New Saint Anthony Hospital Underway



Early June, HDR with partner Architrave Limited met with Saint Anthony Hospital leaders and department heads to kick off the programming for a new hospital that will be anchoring the Focal Point Community Campus at 31st and Kedzie. The cornerstone of the new design is innovation. Architectural programming includes the collaboration

of industry experts, medical professionals, and current hospital staff, to produce a refined definition of the future hospital operations, related space requirements, room sizes, department adjacencies, flow, equipment requirements, and staffing. The new hospital will be designed to improve quality outcomes and patient experience, while also reducing costs.

Saint Anthony also wants to maintain the welcoming and family-centric feel of a community hospital. HDR has been connected to the campus project from the beginning. They are a global engineering and architecture firm with over 200 offices around the world, with award-winning designs in health care and science and technology, spearheading

innovative concepts for major institutions ranging from The Shirley Ryan AbilityLab in Chicago and The Pavilion at the Hospital of the University of Pennsylvania in Philadelphia to many others around the world, including a new Cleveland Clinic in Abu Dhabi. Demolition on the campus site is complete with the

next phase being land remediation. Completion of the hospital is expected early 2026.

Ways to Promote Brain Health During Alzheimer's & Brain Awareness Month



During Alzheimer's & Brain Awareness Month in June, the Alzheimer's Association is encouraging all Americans to adopt healthy lifestyle behaviors that can help reduce the risk of cognitive decline. There are currently more than six million Americans age 65 and older living with Alzheimer's, including 230,000 Illinois residents. Age is the greatest risk factor for Alzheimer's disease. In fact, 1 in 3 seniors age 85 and older will have Alzheimer's disease. While some brain changes are inevitable as we age, there is a growing body of research to suggest that adopting healthy lifestyle behaviors, including healthy eating,

exercising regularly, not smoking and staying cognitively engaged may help us age healthier and help reduce the risk of cognitive decline. During June, the Alzheimer's Association offers these five tips to promote better brain health and help reduce the risk of cognitive decline:

Exercise regularly — Regular cardiovascular exercise helps increase blood flow to the body and brain, and there is strong evidence that regular physical activity is linked to better memory and thinking.

Maintain a heart-healthy diet — Stick to a meal schedule full of fruits and vegetables to ensure

a well-balanced diet. Some evidence suggests a healthful diet is linked to cognitive performance. The Mediterranean and DASH diets, which emphasize whole grains, green leafy vegetables, fish and berries, are linked to better cognitive functioning, and help reduce risk of heart disease as well.

Get proper sleep — Maintaining a regular, uninterrupted sleep pattern benefits physical and psychological health, and helps clear waste from the brain. Adults should get at least seven hours of sleep each night and try to keep a routine bedtime.

Stay socially and mentally active — Meaningful social engagement may support

cognitive health, so stay connected with friends and family. Engage your mind by doing activities that stump you, like completing a jigsaw puzzle or playing strategy games. Or challenge yourself further by learning a new language

or musical instrument.
Keep your heart healthy — Recent study shows strong evidence that a healthier heart is connected to a healthier brain. The study shows that aggressively treating high blood pressure in older

adults can help reduce the development of mild cognitive impairment (MCI).

Durante el Mes de Concienciación sobre el Alzheimer y el Cerebro en junio, la Asociación de Alzheimer alienta a todos los estadounidenses a adoptar comportamientos de estilo de vida saludables que pueden ayudar a reducir el riesgo de deterioro cognitivo. Mantenga su corazón saludable: un estudio reciente muestra una fuerte evidencia de que un corazón más saludable está conectado a un cerebro más saludable. El estudio muestra que el tratamiento agresivo de la presión arterial alta en adultos mayores puede ayudar a reducir el desarrollo del deterioro cognitivo leve (DCL). Renovated Pedestrian Tunnels Open at O'Hare Airport




The Chicago Department of Aviation (CDA) announced on Monday the reopening of seven renovated pedestrian tunnels beneath the Lower Level Roadway at O'Hare International Airport ahead of the busy Fourth of July travel season. The CDA's design and construction contractors performed remediation work for water infiltration that affected the original cast-in-place reinforced concrete tunnels, which were constructed in the 1970s. During periods of heavy rain, groundwater would leak into the tunnels, requiring frequent

maintenance over the past decade to repair damage to interior architectural features. Crews used 3D laser scans of the tunnels to facilitate the repairs, which were conducted in conjunction with interior renovation work. Large LED screens break up the linearity of the tunnels. The screens display vibrant scenes of the city, important travel information, and can be used to broadcast emergency notices if needed. The first three completed tunnels — PC5 in Terminal 3, PC3 in Terminal 2 and PC1 in Terminal 1 —

reopened in November 2021, the week before Thanksgiving. Tunnel PC7 in Terminal 3, which closed for construction in August 2021, reopened in February. Work on tunnels PC2 in Terminal 1, PC4 in Terminal 2, and PC6 in Terminal 3, which closed for renovations in November 2021, were completed in recent weeks. All tunnels have since been reopened to the public and are ready to connect travelers to O'Hare's terminals as summer travel heats up.

Se abren túneles peatonales renovados en el aeropuerto O'Hare

El Departamento de Aviación de Chicago (CDA, por sus siglas en inglés) anunció el lunes la reapertura de siete túneles peatonales renovados debajo de la calzada de nivel inferior en el Aeropuerto Internacional O'Hare antes de la ajetreada temporada de viajes del 4 de julio. Los contratistas de diseño y construcción de la CDA realizaron trabajos de remediación para la infiltración de agua que afectó los túneles originales de concreto reforzado construidos en el lugar, que se construyeron en la década de 1970. Durante los períodos de fuertes lluvias, el agua subterránea se filtraba en los túneles, lo que re-

quería un mantenimiento frecuente durante la última década para reparar los daños a las características arquitectónicas interiores. Los equipos utilizaron escaneos láser 3D de los túneles para facilitar las reparaciones, que se realizaron junto con el trabajo de renovación interior. Grandes pantallas LED rompen la linealidad de los túneles. Las pantallas muestran escenas vibrantes de la ciudad, información de viaje importante y se pueden usar para transmitir avisos de emergencia si es necesario. Los primeros tres túneles completados (PC5 en la Terminal 3, PC3 en la Terminal 2 y PC1 en la Terminal 1) reabrieron

en noviembre de 2021, la semana antes del Día de Acción de Gracias. El túnel PC7 en la Terminal 3, que cerró por construcción en agosto de 2021, reabrió en febrero. El trabajo en los túneles PC2 en la Terminal 1, PC4 en la Terminal 2 y PC6 en la Terminal 3, que cerraron por renovación en noviembre de 2021, se completaron en las últimas semanas. Desde entonces, todos los túneles se han reabierto al público y están listos para conectar a los viajeros con las terminales de O'Hare a medida que se intensifican los viajes de verano.

Erie Family Health Centers Leverages Technology to Provide Greater Access to Quality Healthcare



With the emergence of the COVID-19 pandemic, health equity gaps across the U.S. were exposed, bringing the need for quality healthcare for vulnerable populations to the forefront and
