## IDFPR Calls for Federal Student Loan Servicers to Prioritize the Public Service Loan Forgiveness Program

The Illinois Department of Financial and Professional Regulation (IDFPR) announced the Department has issued a letter to all federal student loan servicers encouraging them to immediately implement best practices to help alert and educate eligible student loan holders about the Public Service Loan Forgiveness (PSLF) program. As the primary contact for many student loan borrowers. servicers are in the best position to increase awareness about PSLF and help borrowers take advantage of the program. PSLF forgives the remaining student loan balance of fulltime government and certain non-profit employees after making 120 qualifying payments. In order for



more borrowers to qualify for forgiveness, President Biden announced temporary changes to the program, including waiving some past requirements. However, many borrowers are unaware of these changes and may miss out on loan forgiveness as a result. The temporary changes expire on October 31, 2022.

## Meals on Wheels Chicago Celebrates 35 Years of Service

On August 10th, Meals on Wheels Chicago celebrated an important milestone. For 35 years, the home meal delivery program has helped food-insecure seniors and individuals with disabilities stay health, nourished, and independent in their own homes. What started as a program serving 1,218 seniors a hot Thanksgiving meal in 1987 is now a program that serves over 13,000 people annually, making weekly deliveries that add up to 4.7 million meals each year to those struggling with food insecurity. In the 35 years since the program began in Chicago, the need has grown dramatically. With 1 in 5 Americans 60 or older, 12,000 more turning 60 each day, and 7.4 million seniors living on incomes below the poverty line, more people are at risk of hunger and isolation than ever before. This month also marks the official launch of Nourish Chicago,



A Meals on Wheels Pantry, in a continued effort to put *health on the pantry shelf* for seniors. Nourish Chicago Pantry advances Meals on Wheels Chicago's mission to improve quality of life and maximize independence for seniors in our community. The cost of food and limited transportation to fullstock grocery stores can limit a senior's access to fresh produce and pantry goods, and seniors living on a fixed income are often forced to choose between food, medicine, and the cost of housing. Cada residente vivirá en el centro, al que se le pondrá un nombre oficial un poco más tarde, por uno a tres años. Los fondos para



el centro de desarrollo de fuerza laboral residencial vienen de un subsidio del Estado de Illinois de \$7.5 millones; un subsidio federal de \$750,000; un subsidio de la Autoridad de Desarrollo de Viviendas de Illinois de \$475,000 y donaciones privadas. En el 2018, LCLC gastó \$30,000 para la compra de la propiedad de K-Town, que tiene 24,590 pies cuadrados y fue anteriormente una escuela católica. La construcción incluye tanto una rehabilitación total de la estructura existente como una nueva construcción que agregará un ala completa de espacio para oficinas y programas. El edificio de mampostería original tiene más de 100 años y necesita un importante trabajo de rehabilitación, como plomería, electricidad y HVCA. Se agregará un ascensor al edificio. Se espera que el centro abra en la primavera de 2024.

## Lawndale Christian Legal Center Announces Dormitory-Style Residence



Lawndale Christian Legal Center announced on August 6<sup>th</sup> the construction of a \$17 million center where clients will love and receive job skills to transition to homeownership. The K-Town residential workforce development center, 1441 S. Keeler Ave., will house 20 young men from North Lawndale who either have pending or completed cases in the Circuit Court of Cook County. The 20 housing units will feature a private bedroom bathroom, and kitchenette. There will be shared space for socializing and meetings, a commercial kitchen, dining area, a computer room and laundry room. Each resident will live at the center, which will be officially named at a later date, for one to three years. Funding for the residential workforce development center comes from a \$7.5 million State of Illinois grant; a \$750,000 federal grant; a \$475,000 Illinois Housing Development Authority grant; and private donations. In 2018, LCLC spent \$30,000 to purchase the K-Town property, which has 24,590 square feet and was formerly a Catholic school. The buildout includes both a gut rehab of the existing structure and new construction that will add an entire wing of office and program space. The original masonry building is over 100 years old and needs significant rehab work such as plumbing, electrical and HVAC. An elevator will be added to the building. The center is expected to open in the spring of 2024.

kindergarten is to "Define Consent," and "Define gender, gender identity, and gender-role stereotypes." Kids in the third grade are expected to be able to, "Explain common human sexual development and the role of hormones (e.g., romantic, and sexual feelings, masturbation, mood swings, and timing of pubertal onset)."

Another goal for third through fifth graders is to be able to, "Describe the role hormones play in the physical, social, cognitive, and emotional changes during adolescence and the potential role of hormone blockers on young people who identify as transgender."

The standards also expect sixth through eighth graders to be able to, "Define vaginal, oral, and anal sex."

In other words, the National Sex Education Standards go far beyond biology and seek to teach kids at young ages material that is clearly not age appropriate.

The good news is Illinois schools are not required to teach sex education and can opt out of teaching these obscene sex education standards. Local school boards have the authority to establish their own curriculum guidelines and do not have to comply with these standards because there is no law requiring schools to teach sex education in the first place. I have been sounding the alarm and urging parents to

get involved and stop this curriculum from taking hold in their local schools and numerous districts across the state are opting out.

These parents are asking questions about how schools can justify teaching radical sex education curriculum when so many of our students are not meeting basic standards of learning.

According to the most recent Illinois Assessment of Readiness text scores, fewer than one in five Chicago third graders met or exceeded Illinois' education standards in reading and math. And it is not just Chicago with low test scores. School districts across the state are having similar problems.

The focus in our schools should be on giving children the building blocks they need to learn. Our kids should learn how to read, write, add, subtract, and have a basic understanding of science and history. It is not the job of schools to teach graphic sexual content especially when our kids are not meeting our state's basic standards of learning. My colleagues and I tried to stop the National Sex Education Standards from becoming a part of our school curriculum, but we fell just short of defeating this legislation. Now, the battle is in the hands of Illinois families and local school boards. It is a battle we can and will win as long as parents stay engaged.
