# Know Before You Go: Parking Will Be Limited at Lot D at O'Hare Terminal 5



The Chicago Department of Aviation (CDA) is advising travelers and visitors about limited parking availability in Lot D at O'Hare International Airport's Terminal 5 starting this week, construction crews continue work on a new, six-story parking garage that

will serve the expanded terminal for domestic and international service. The existing pedestrian bridge connecting Lot D to Terminal 5 will close this week and a temporary walkway will be used to connect pedestrians to the terminal. Passengers traveling through Terminal 5, as well as locals picking up arriving passengers, should allow for extra time when parking, and consider additional options, including: •Other parking lots at O'Hare, such as Economy Lot F in the airport's Multi-Modal Facility (MMF), conveniently located just minutes from Terminal 5 on the Airport Transit System

•The Kiss 'n' Fly at the MMF, where you can drop passengers off and give them a farewell hug without looking for a parking spot

•Waiting in the free Cell Phone Lot until arriving passengers are ready at the curbside

•Go direct with public transport or taxi, limo or rideshare options

Changes in traffic patterns on airport roadways will be required to accommodate the construction, which will also include concrete work and improvements to sidewalks, pedestrian walkways and handrails. The work and increased congestion over the upcoming holiday travel period could cause delays, and travelers are encouraged to allow extra travel time.

## Chicago Latino Theater Alliance Names Jorge Valdivia New Executive Director



The Chicago Latino Theater Alliance (CLATA) announces the appointment of Jorge Valdivia as its new Executive Director. Valdivia comes to CLATA from the National Museum of Mexican Art (NMMA), where he served as the Director of Performing Arts, leading the museum in presenting a yearround calendar of events focusing on performing arts, literature, and film. There he also curated the *Sor Juana Arts Festival*, a multidisciplinary arts festival that he successfully expanded into seven cities. Valdivia will assume his leadership role on Tuesday, January 3, 2023 at CLATA, where he will continue to grow the organization's mission to propel the city's local Latino/a/e theater community to a more prominent level and increase Latino

representation in Chicago theater. Valdivia steps into CLATA's executive leadership previously held by Myrna Salazar, who passed away suddenly in August, 2022. Salazar cofounded CLATA in 2016 with the National Museum of Mexican Art (NMMA), the International Latino Cultural Center (ILCC),

and the Puerto Rican Arts Alliance (PRAA).

### **IDPH Announces Distribution of Free COVID-19 Rapid Tests for Vulnerable Illinoisans**



The Illinois Department of Public Health (IDPH) announced it will be distributing 1 million o v e r - th e - c o u n t e r (OTC) COVID-19 rapid antigen tests to residents in economically disadvantaged zip codes outside the City of Chicago through a partnership with the Rockefeller Foundation's public charity, RF Catalytic Capital and its Project ACT (Access COVID Tests) program. Through the Project ACT program, IDPH will be distributing one million at-home antigen tests to 200,000 Illinois families in zip codes outside the City of Chicago that are rated high on a Social Vulnerability Index (SVI). Households can find out if they are in an eligible zip code and request one package of five tests on a first-come-first-serve basis at the Project ACT website. The tests will be delivered to the home address. Free COVID-19 testing locations are available throughout the state, including in Chicago, and can be found on the IDPH website's testing locator page.

# Attorney General Raoul Urges FDA to Approve Country's First Over-the-Counter Birth Control Pill



Attorney General Kwame Raoul today announced joining a coalition of 21 attorneys general in urging the U.S. Food and Drug Administration (FDA) to approve overthe-counter birth control pills that meet applicable safety and efficacy standards, including a pending application for the nation's first overthe-counter (OTC) pill. If approved, safe and effective birth control pills will become available for purchase over the counter, removing barriers that currently keep many people from accessing timely reproductive care. In a letter submitted to the FDA, Raoul and the attorneys general argue that approval of the pill would allow individuals — especially those from vulnerable populations — to take greater control over their health, lives and futures. It would also help them avoid the health and economic perils that come with unwanted pregnancies. In the open letter to the FDA, Raoul and the attorneys general assert that the pill should be approved for OTC use because:

•It has been found to be safe and effective for most users. Studies show that progestin-only pills, like Opill, carry a much



lower risk of blood clots than traditional combination estrogen and progestin birth control pills. These pills have been used safely in the U.S. since 1973 with minimal side effects. Studies of progestin-only birth control pills show that they are over 90% effective in preventing unwanted pregnancies — more effective than methods such as spermicide, condoms or the sponge.

•It would provide critical help to people from vulnerable populations. Barriers to accessing birth control disproportionately impact people of color, low-income families and individuals living in rural areas, who are more often underinsured or uninsured, and thus find it harder to get the reproductive care they need. OTC options would go a long way in reducing these inequities and making the health care system fairer



and more accessible for all. The benefits of such a system include lower maternal mortality rates, less poverty, higher levels of physical and mental health, and more economic freedom and opportunity for vulnerable communities.

## **Property Tax Savings for Veterans from the Assessor's Office**

In honor of Veterans Day, the Cook County Assessor's Office (Assessor's Office) would like to express gratitude to those who have served our nation. By offering property-tax-saving exemptions for over 10,000veteran families this year, the Assessor's Office hopes to honor their sacrifice and service. The Assessor's Office administers both the Veterans with Disabilities and the Returning Veterans Exemptions, which can reduce the property tax bills of veterans.

The Veterans with **Disabilities Exemption** is

for veterans with a servicedisability connected as certified by the U.S. Department of Veterans Affairs. The exemption reduces the Equalized Assessed Value (EAV) on the primary residence of a veteran with a disability, very likely lowering the tax bill. The amounts of those EAV deductions depend on the percentage of disability. Veterans are required to apply annually.

The **Returning Veterans Exemption** is for veterans returning from active duty in armed conflict are eligible to receive a \$5,000 reduction in the equalized assessed value of their property only for each taxable year in which they return. Veterans are required to apply annually. The 2021 tax year exemption filing period is now closed, however veteran homeowners who believe they may have been eligible for exemptions in prior tax years can apply for a Certificate of Error. The Certificate of Error process provides homeowners an opportunity to redeem missing exemptions for the 2021, 2020, 2019, and 2018 tax years. 
