Resurrection ProjectCelebrates Opening of Casa Durango

The Resurrection Project (TRP) on Tuesday celebrated the grand opening of their new rental housing, Casa Durango, 1858 S. Racine Ave., a 53-unit multifamily affordable housing development across two properties: 1858 S. Racine Avenue (37 units) and 2010 S. Ashland Avenue (16 units). TRP broke ground in September 2020 and the buildings were completed in Fall 2022. The 53 units are for households earning 30 percent to 60 percent Area Median Income (AMI) – between \$27,950 and \$55,920 annual income for a family of four (2022)

City of Chicago, 548 Enterprise, Related Midwest Break Ground on New North Lawndale Site



City of Chicago, along with partners from 548 Enterprise and Related Midwest, broke ground on 4300 W. Roosevelt Road in North Lawndale as part of INVEST South/West, Mayor Lightfoot's signature economic development initiative. The \$68 million project will leverage the location's strengths in freight and logistics with four new

buildings, including two 181,760 square foot, solar-powered industrial warehouses with more than 50 dock spaces and two 5,000 square foot innovation centers and a public park for community use. The innovation centers will maximize opportunities for neighborhood groups to host community meetings and events as well as

workforce development programs. The project is expected to bring 250 temporary jobs and 250 permanent jobs to North Lawndale. City support for the project includes \$8 million in Tax Increment Financing assistance and the sale of 21 acres of City-owned land for \$1 per lot. The groundbreaking featured a solar panel demonstration, local



musical talent Bianca Shaw, and breakfast pastries and coffee provided by North Lawndale establishments Bee Love Cafe and Trini's Tasty Pastries. landscaping plan by Site Design Group (MBE) aims to reintroduce native biodiversity through replanting historic ground species. The 3-acre green space will offer three distinct public spaces, a circuitous fitness path, and over 300 shade trees throughout the site. The site is located in the Roosevelt/

Cicero Industrial Corridor, bounded by Roosevelt Road, and Kostner, Kildare and Fifth Avenues. The project is expected to be completed in Fall 2024.

New Legislation Introduced to Crack Down on Doxing in Illinois



Legislation introduced in the Illinois General Assembly by State Representative Jennifer Gong-Gershowitz (D-17) will give victims of doxing the ability to seek civil recourse from their attacker, something doxing victims are unable to currently do in Illinois. Doxing is the act of sharing an individual's personal information with the intent to cause the individual harm. Senator Julie Morrison (D-29) will carry the legislation in the Illinois State Senate. Supported by a diverse

coalition of civil rights, domestic violence and antihate groups, the legislation creates an important deterrent to doxing and gives victims a voice in the aftermath of immense harm. Similar civil anti-doxing bills were recently signed into law in Maryland, Nevada, and Oregon, and the Washington State Legislature recently advanced a similar bill during its current legislative session. ADL (Anti-Defamation League) Midwest has been working with Representative Gong-

Gershowitz and coalition members on the bill for the last six months in response to a dramatic increase in online hate in recent years. Other Anti-Doxing Coalition members include the Illinois Coalition Against Domestic Violence (ILCADV), Chinese American Service League (CASL), Chicago Urban League, Jewish United Fund/Jewish Federation of Metropolitan Chicago, Sikh American Legal Defense and Education Fund (SALDEF), and Access Living.



Closing the Digital Skill Divide

On Wednesday, the National Skills Coalition (NSC) in partnership with the Federal Reserve Bank of Atlanta released Closing the Digital Skill Divide, a real-time snapshot of demand for digital skills in the US labor market. The analysis finds that 92 percent of jobs analyzed require digital skills. Previous NSC research found one-third of workers don't have the foundational digital skills necessary to enter and thrive in today's jobs. Together, these findings point to a significant digital skill The findings divide. suggest that states that target resources toward digital skill building could generate measurable monetary benefits:

- •Workers that qualify for jobs that require even one digital skill can earn an average of 23 percent more than in a job requiring no digital skills. Moving from a job requiring no digital skills to one requiring at least three can increase pay by an average of 45 percent.
- •For the economy as a whole, these increased earnings could generate more state and federal tax revenue. Depending on the household size and composition, this could range from \$1,363 to \$2,879 in additional tax revenue per household per year.
- •For businesses, turnover costs (estimated at \$25,000 when a worker quits within the first year to over \$78,000 after five years) can be averted or delayed by ensuring that workers have upskilling opportunities.

Over the next year, National Skills Coalition will work with policymakers, its member state coalitions, and corporate partner Comcast NBCUniversal to ensure more local and national leaders are aware of and take advantage of public sector digital equity



funds to invest in the skill development programs that are critical to closing the digital divide. While the report focused on national data, it found that demand for digital skills is high in every state and analyzed extensive data for two states - North Carolina and Illinois - as examples. The data analysis for the report was carried out as a joint project between NSC and the Center for Workforce and Economic Opportunity at the Federal Reserve Bank of Atlanta.

Commissioner Miller, Heart Health Experts Highlight Importance of CPR/AED Training During American Heart Month

This week, 6th District Cook County Commissioner Donna Miller was joined by Derrick Cabrera of the American Heart Association, Michael K. Lall, President and COO of AED Professionals, and 9th District Cook County Commissioner Maggie Trevor to highlight the importance of CPR/AED training. As February is American Heart Month, spoke participants about why learning CPR techniques and how to use AED devices, as well as prioritizing cardiovascular health and wellness, are so crucial to the entire



community's health and wellness. Commissioner Miller is hosted a daylong CPR/AED training at the County building for County employees to help individuals learn how to perform life-saving intervention techniques in cardiovascular crises. Nearly 100 employees signed up to participate throughout the day.

CPR/AED training is particularly important for African Americans and Hispanics, who are 30-50 percent less likely to have bystander CPR performed when suffering from a cardiac event than white adults. Women are also less likely to receive bystander CPR because people fear accusations of inappropriate touching, sexual assault, or injuring the person, with only 39 percent of women receiving bystander CPR in public compared to 45 percent of men and men's chances of surviving a cardiac event are 23 percent higher than women. Having CPR initiated by a bystander when someone is suffering from cardiac arrest can almost double or triple the chances of survival. In 2022, Commissioner Miller released a report titled "Cardiovascular Health in the Southland," which examined the impacts of location and race on cardiovascular disease survival and outcomes in suburban Cook County. To increase access, Commissioner Miller's office also made the report available in Spanish earlier this month.

Cerrando la Brecha de Habilidades Digitales

El miércoles, la Coalición Nacional de Habilidades (NSC) en asociación con el Banco de la Reserva Federal de Atlanta lanzó Closing the Digital Skill Divide, una instantánea en tiempo real de la demanda de habilidades digitales en el mercado laboral de EE. UU. El análisis encuentra que el 92 por ciento de los trabajos analizados requieren habilidades digitales. Investigaciones anteriores de NSC encontraron que un tercio de los trabajadores no tienen las habilidades digitales fundamentales necesarias para ingresar y prosperar en los trabajos de hoy. Juntos, estos hallazgos apuntan a una importante brecha de habilidades digitales. Los hallazgos sugieren que los estados que destinan recursos hacia el desarrollo de habilidades digitales podrían generar beneficios monetarios medibles:

•Los trabajadores que califican para trabajos que requieren incluso una habilidad digital pueden ganar un promedio de 23 por ciento más que en un tra-



bajo que no requiere habilidades digitales. Pasar de un trabajo que no requiere habilidades digitales a uno que requiere al menos tres puede aumentar el salario en un promedio del 45 por ciento.

•Para la economía en general, estas mayores ganancias podrían generar más ingresos fiscales estatales y federales. Según el tamaño y la composición del hogar, esto podría oscilar entre \$1363 y \$2879 en ingresos fiscales adicionales por hogar por año.

•Para las empresas, los costos de rotación (estimados en \$25,000 cuando un trabajador renuncia dentro del primer año a más de \$78,000 después de cinco años) se pueden evitar o re-

trabajadores tengan oportunidades de capacitación. Durante el próximo año, National Skills Coalition trabajará con los legisladores, sus coaliciones de estados miembros y el socio corporativo Comcast NBCUniversal para garantizar que más líderes locales v nacionales conozcan y aprovechen los fondos de equidad digital del sector público para invertir en los programas de desarrollo de habilidades que son fundamentales para cerrar la brecha digital. Si bien el informe se centró en los datos nacionales, descubrió que la demanda de habilidades digitales es alta en todos los estados y analizó datos extensos

de dos estados, Carolina del Norte e Illinois, como ejemplos. El análisis de datos para el informe se llevó a cabo como un proyecto conjunto entre la NSC y el Centro para la Fuerza Laboral y las Oportunidades Económicas del Banco de la Reserva Federal de Atlanta.



CPS Partners with NASCAR and Chicago Street Race to Engage Students Through STEM/STEAM

As excitement builds for 2023 Chicago Street Race Weekend, NASCAR and Public Chicago Schools (CPS) on Tuesday announced a collaborative initiative that will engage and inspire more than 22,000 students with racing-themed STEM and STEAM learning experiences and curriculum. The partnership was announced by CPS and Chicago Street Race officials at the Field Museum in downtown Chicago with the help of 2023 DAYTONA champion Ricky Stenhouse Jr., fresh off the driver's victory at Daytona International Speedway on Sunday. Beginning in March, CPS students from all 43 STEM and STEAM schools will compete in an in-classroom design challenge culminating with the first-ever "STEAM Fest" in downtown Chicago on May 2. Nearly 500 student finalists will interact with NASCAR drivers, engineers and other industry STEM professionals at the Field Museum in the event's championship round for a chance to attend the Chicago Street Race Weekend.

In addition, CPS and NASCAR will work together to develop new STEM curriculum for eighth-grade students exploring fundamental science and engineering concepts within the sport. NASCAR-themed curriculum, designed to address Next Generation Science Standards (NGSS) Performance Expectations, will be finalized and introduced in middle schools during the 2023-2024 school year. General admission and reserved tickets are on sale for the Chicago Street Race. Twoday general admission ticket are on sale starting \$269. Reserved tickets that offer an array of opportunities including reserved seating and a wide variety of premium experiences start at \$465. To
