

New Of the Earth exhibition debuts May 26 at The Morton Arboretum

Five large-scale sculptures fashioned from reclaimed tree branches and other natural materials by Polish-American artist Olga Ziemka will debut May 26 in the newest outdoor exhibition at The Morton Arboretum. *Of the Earth*, the first major sculpture installation by a woman artist at the Arboretum, is Ziemka's largest exhibition to date

anywhere in the world. The exhibition will be free with advance purchase of daytime admission and will remain through spring 2025. All five sculptures — Strata, Oculus, Ona, Hear: With an ear to the ground and Stillness in Motion: The Matka series — pay homage to the Arboretum landscapes while exploring Ziemka's central and reoccurring theme, "We

are nature." The sculptures are made of both organic and man-made materials, including steel and glass-fiber reinforced concrete necessary to withstand the Midwest's weather variations, and range in size from 5- to 14-feet tall and 45 feet in length. Arboretum volunteers spent several weeks laying the groundwork for creation of the unique pieces by

collecting, pruning and preparing natural materials such as fallen tree branches from sugar maple, hackberry, linden, willow, elm and wild black cherry trees at the Arboretum. The exhibition will open to the public

'Suficiente Espacio' para los Migrantes Dice el Nuevo Alcalde

Juramentado como nuevo alcalde de la Ciudad de Chicago, el Alcalde Brandon Johnson empezó su término firmando un número de órdenes ejecutivas, incluyendo una orden para establecer un vicealcalde para inmigrantes, migrantes y refugiados. "No queremos que se cuente en nuestra historia que fuimos incapaces de albergar o proveer un lugar seguro a quienes buscan refugio aquí. Porque hay espacio para todos en la ciudad de Chicago, ya sea que busquen asilo o que busquen un barrio totalmente financiado", dijo Johnson durante su

'Enough Room' for Migrants Says New Mayor of Chicago Brandon Johnson

Sworn in as the City of Chicago's new mayor, Mayor Brandon Johnson hit the ground running signing a slew of executive orders, including an order to establish a deputy mayor for immigrant, migrant, and refugee rights. "We don't want our story to be told that we were unable to house the unhoused or provide safe harbor for those who are seeking refuge here. Because there's enough room for everyone in the city of Chicago whether you are seeking asylum or you are looking for a fully funded neighborhood," Johnson said during his inauguration speech on Monday.

The executive order will establish a Deputy Mayor for Immigrant, Migrant, and Refugee Rights and makes the new role responsible for the coordination and communication between all applicable City departments and officials related to the City's efforts to support newly arrived and established immigrants, refugees, and migrants. In addition, the order instructs all City



department heads to take direction from the Deputy Mayor for Immigrant, Migrant, and Refugee Rights to assist with efforts to address immediate needs and long-standing policy and programmatic goals to ensure the efficacy of Chicago's status as a welcoming and sanctuary city.

New migrants are expected to arrive in Chicago and increase now that pandemic-era Title 42 restrictions on border crossings have ended. Last week, outgoing Chicago Mayor Lori Lightfoot issued an emergency declaration in response to illegal immigrants being bussed to

her city by Texas Gov. Greg Abbott. Her office counted over 8,000 arrivals since August 2022.

"Speaking of the right thing to do, the soul of Chicago tells us that we will never close our doors to those who come here in search of a better life," the mayor said later on. "For as Scripture says, 'I was hungry, and you gave me something to eat, I was thirsty, and you gave me something to drink, I was a stranger, and you invited me in. I needed clothes and you clothed me. I was sick and you looked after me. I was in prison, and you came to visit me.' That has always been the soul of Chicago, and it will always be the soul of Chicago."

Over 8,000 migrants, most of them from Central and South America, have arrived in Chicago since last August. The City of Chicago received just \$5.5 million from the Federal Emergency Management Agency to care for immigrants. However, as Chicago continues to face "a humanitarian crisis" amid a wave of migrants, the Chicago City Council will be asked to spend \$53 million from the city's budget surplus to address the crisis. Recently, Chicago opened temporary shelters at police stations across the city over the weekend to accommodate busloads of nearly 600 migrants.

La orden ejecutiva establecerá un Vicealcalde para inmigrantes, migrantes y refugiados y hace al nuevo puesto responsable de la coordinación y comunicación entre todos los departamentos aplicables de la ciudad y funcionarios relacionados con los esfuerzos de la ciudad para apoyar a los recién llegados y establecer a los inmigrantes, migrantes y refugiados. Además, la orden instruye a todos los jefes de departamento de la ciudad que sigan las direcciones del Vicealcalde de Inmigrantes, Migrantes y Refugiados para que asistan con los esfuerzos para abordar las necesidades inmediatas y las políticas y objetivos programáticos de larga data para garantizar la eficacia del estatus de Chicago como una ciudad santuario y acogedora.

Se espera que nuevos inmigrantes lleguen a Chicago y aumenten



ahora que han terminado las restricciones del Título 42 de la era de la pandemia en los cruces fronterizos. La semana pasada, la alcaldesa saliente de Chicago, Lori Lightfoot, emitió una declaración de emergencia en respuesta a los inmigrantes ilegales que el gobernador de Texas, Greg Abbott, transportaba

en autobús a su ciudad. Su oficina contó más de 8000 llegadas desde agosto de 2022.

“Hablando de lo correcto, el alma de Chicago nos dice que nunca cerraremos nuestras puertas a quienes vienen aquí en busca de una vida mejor”, dijo más tarde el alcalde. “Porque como dice la Escritura:

‘Tuve hambre y me disteis de comer, tuve sed y me disteis de beber, era forastero y me invitasteis a entrar, necesitaba ropa y me vestisteis ‘Estaba enfermo y me cuidaste. Estaba en prisión y viniste a visitarme’. Esa siempre



ha sido el alma de Chicago y siempre será el alma de Chicago”.

Más de 8,000 migrantes, la mayoría de ellos de Centro y Sudamérica han llegado a Chicago desde el pasado agosto. La Ciudad de Chicago recibió solo \$5.5 millones de la Agencia Federal de Administración de Emergencias para atender a los inmigrantes. Sin embargo, como Chicago

continúa enfrentando una “crisis humanitaria” entre una onda de migrantes, se le pedirá al Concilio de la Ciudad de Chicago que gaste \$53 millones del superávit del presupuesto de la ciudad para atender la crisis. Recientemente, Chicago abrió temporalmente los albergues de las estaciones de policía de la ciudad el fin de semana para acomodar autobuses con cerca de 600 migrantes.

Triton College Education Department Hosted Education Symposium



Triton College's Education Department hosted an Education Symposium on Friday, April 14, in the Auditorium (R Building). "The symposium was geared towards current and prospective students who are interested in the education field," said Angela Staunton, the Education Department chairperson. The symposium began with keynote speaker Dr. Rebecca Pruitt of Lewis University, who debunked many current myths plaguing the education field. She discussed teacher burnout and statistics

regarding teaching positions in Illinois. "There are a booming number of teachers that are not leaving the teaching field," Dr. Pruitt explained. After remarks from Dr. Pruitt, there were breakout sessions from Dr. JoLynn McCray, a Triton Early Childhood Education faculty member, and Dr. Melissa Smith, an assistant professor coordinator of Early Childhood Education from Concordia University, among others. The breakout sessions taught students how to incorporate "self-care" into their lives along with incorporating reading

and social emotional learning techniques. "Approximately 40 high schoolers from East and West Leyden, and Proviso West were in attendance, as well as many current Triton students," said Staunton. "Triton has a variety of programs within the Education Department that prepare students to be teachers in the education field," she said.
