# Villa Insta a los no Ciudadanos a Registrarse para la Cobertura de Atención Médica Antes del 1 de Julio



Para evitar que los residentes elegibles en Illinois pierdan la oportunidad de inscribirse en la cobertura de atención médica, la senadora estatal Karina Villa está invitando a todas las personas que no son ciudadanos y que no tienen seguro o tienen seguro insuficiente a que vayan a la oficina de su distrito y se inscriban para obtener cobertura antes del 1 de julio. Esto viene en respuesta al anuncio del Departamento de Atención Médica y Servicios Familiares de Illinois de que se pausará la inscripción en el programa de Beneficios de Salud para Adultos Inmigrantes. Illinois ofrece dos programas para brindar atención médica a personas que no son ciudadanas: los Beneficios de salud para personas mayores inmigrantes (HBIS, por sus siglas en inglés) ofrecen un seguro de salud gubernamental similar a Medicaid para personas que no son ciudadanas de 65 años o más, y el programa Beneficios de salud para adultos inmigrantes (HBIA, por sus siglas en inglés) ofrece cobertura médica a adultos de 42 a 64 años sin importar su estatus migra-

torio. La inscripción en el programa HBIA se cerrará el 1 de julio; las personas mayores de 65 años aún podrán inscribirse en su programa después del 1 de julio. ## Fiscal Year 2024 Higher Education State Budget is Largest in Decades

The General Assembly passed and Governor JB Pritzker has signed a fiscal year 2024 state budget that includes a historic appropriation of \$2.53 billion for higher education, an increase of \$279 million (12.4 percent) compared to the previous fiscal year and the largest increase in over 20 years. Notable highlights from the budget include a \$100 million increase for the Monetary Award Program (MAP), an \$80.5 million (7 percent) increase for public universities, \$19.4 million (7 percent) increase for community colleges, a \$3.8 million increase to the Minority Teachers of Illinois Scholarship Program (MTI) to recruit retain minority teachers, and a \$15 million increase for the AIM HIGH program. The budget also includes an investment of \$6 million for Grow Your Own (an increase of \$3.5 million), \$15.75 million for Golden Apple (an increase of \$8.5 million) and \$975,000 for the Teachers Loan Repayment Program (an increase of \$535,000) all of which are key in helping address teacher workforce needs. The increase to MAP funding by \$100 million takes another giant step toward ensuring higher education



is affordable for students across Illinois, a crucial strategy in the state's strategic plan for higher education, A Thriving *Illinois*. The fiscal year 2024 state budget includes:

- •\$100 million increase for MAP
- •\$80.5 million (7 percent) increase for public universities
- •\$19.4 million (7 percent) increase for community

colleges

- •\$10 million for a new grant program to develop programs in Advanced Manufacturing Electric Vehicle Technologies
- •\$12.6 million for student mental health supports

## El Presupuesto Estatal de Educación Superior del Año Fiscal 2024 es el Mayor en Décadas

La Asamblea General aprobó y el Gobernador JB Pritzker firmó un presupuesto estatal para el año fiscal 2024 que incluye una asignación histórica de \$2,530 millones para la educación superior, un aumento de \$279 millones (12,4 por ciento) en comparación con el año fiscal anterior v el mayor aumento en más de 20 años. Los aspectos más destacados del presupuesto incluyen un aumento de \$100 millones para el Programa de Premios Monetarios

(MAP), un aumento de \$80,5 millones (7 por ciento) para las universidades públicas, un aumento de \$19,4 millones (7 por ciento) para los colegios comunitarios, un aumento de \$3,8 millones para los maestros de minorías del Programa de Becas de Illinois (MTI) para reclutar y retener a maestros de minorías, y un aumento de \$15 millones para el programa AIM HIGH. El presupuesto también incluye una inversión de \$6 millones para Grow Your



Own (un aumento de \$3.5 millones), \$15.75 millones para Golden Apple (un aumento de \$8.5 millones) y \$975,000 para el Programa de Pago de Préstamos para Maestros (un aumento de \$535,000) – todos que son clave para ayudar a abordar las necesidades de la fuerza laboral docente. Enrollment in the HBIA program will close July 1; seniors age 65 or older will still be able to enroll in their program after July 1. ## Forest Preserves of Cook County Offers Endless Summer Possibilities

The recreational, educational and peaceful activities available all summer in the Forest Preserves of Cook County encompasses virtually anything available at a lake getaway in Wisconsin or Michigan, and then some—just much closer to home. "From active uses like hiking, zipswimming, lining, boating, biking and golf, to more contemplative or relaxing activities like nature education, fishing, birdwatching and camping,

the Forest Preserves has it all," says Forest Preserves General Superintendent Arnold Randall. "No matter what age you are, and no matter where in the county you live, you will find something that suits you." With so many options, there are endless ways to create your own adventure in the Forest Preserves this summer. Here are just four ideas to get you started:

Camp at Camp Shabbona Woods in South Holland. This facility offers 16 mulched tent sites,

four small cabins, and 40-person organized group campsite. You can even rent the entire 159-person campground. There's a clearing for activities, it's a short walk to Sand Ridge Nature Center, and you can participate in weekend programming. Camping is available at four other Forest Preserve sites around the county as well. **Swim at Cermak Family** Aquatic Center in Lyons. This spot offers something for kids of all ages: play features, a water playground, children's slides, a lazy river, and zero-depth entry. Days and hours vary, and weather may prompt temporary closings, so call (708) 447-0715 or check the Facebook page beforehand. The Preserves also has two other aquatic centers: Green Lake in Calumet City, and Whealan Pool on the Northwest Side of Chicago.

Go boating at Skokie Lagoons near Winnetka. This 894-acre preserve features canoe and kayak rentals, or bring your own: The accessible Tower Road Boat Launch can accommodate anything from rowboats, to sailboats, to boats with electric trolling motors. There are many other boat launches and several rental sites in preserves throughout the

county

Zip-line at Bemis Woods near Western Springs. The Go Ape Zipline & Adventure Park includes the two- to three-hour-long Treetop Adventure Course, with five zip lines, a "double Tarzan swing," and a series of ladders, bridges, spider's webs and trapezes; the hour-long Treetop Journey Course, with two zip lines; an Axe Throwing Range; and Treetop Nets for the little ones.

Con tantas opciones, hay infinitas maneras de crear su propia aventura en Forest Preserves este verano. Aquí hay solo cuatro ideas para comenzar:

Campamento en Camp Shabbona Woods en Holanda Meridional. Esta instalación ofrece 16 sitios para carpas cubiertas con mantillo, cuatro cabañas pequeñas y un campamento para grupos organizados para 40 personas. Incluso puede alquilar todo el campamento para 159 personas. Hay un claro para actividades, está a un corto paseo del Sand Ridge Nature Center y puedes participar en la programación de fin de semana. También se puede acampar en otros cuatro sitios de Forest Preserve en todo el condado.

Nade en el Centro Acuático Familiar Cermak en Lyon. Este lugar ofrece algo para niños de todas las edades: funciones de juego, un parque acuático, toboganes para niños, un río lento y una entrada de profundidad cero. Los días y las horas varían, y el clima puede provocar cierres temporales, así que llame al (708) 447-0715 o consulte la página de Facebook con anticipación. The Preserves también tiene otros dos centros acuáticos: Green Lake en Calumet City y Whealan Pool en el lado

noroeste de Chicago.

Pasee en bote en Skokie Lagoons cerca de Winnetka. # Safer Foundation's New West Side Mural Honoring U.S. Rep. Danny Davis' Work for Formerly Incarcerated is Unveiled

The design of a new Safer Foundation mural honoring U.S. Representative Danny Davis and his work making the successful reentry of citizens with arrest and conviction records a national priority has been completed on Wednesday. The painting of the 3,500 square-foot, 30- foothigh mural, designed on the Safer Foundation's Community Office building, 808 S. Kedzie Ave. in East Garfield Park, was led by artist Janel Young who began working on the mural with her of four other artists on June 2<sup>nd</sup>. In the coming months, the Safer Foundation building will also get light renovations to its facade and lobby area and a new name - The Safer Foundation-Danny K. Davis - Second Chance Center. The Safer Foundation building, which offers a holistic



suite of reentry services, including education and training, employment, housing and behavioral health services, is located in the 7th district, which Rep. Davis has represented since 1997. Rep. Davis was chief sponsor of the national Second Chance Act of 2007, which

authorizes federal grants for vital programs and systems reforms aimed at improving the reentry process. The Second Chance Act was signed into law on April 9, 2008 and reauthorized in 2019. Since 2009, more than \$1 billion in grants have been issued to grantees, including

Safer Foundation, across 49 states. In turn, more than 100,000 returning citizens have accessed training, employment, treatment and other vital services to help them reintegrate into society.


