Cicero First Deputy Police Chief Names Head of West Suburban Chiefs of Police (WSCOP)

Town President Larry Dominick and the Town of Cicero Board of Trustees congratulated 1st Deputy Police Supt. Luis Gutierrez who was honored On September 6, 2023, and sworn in as the new incoming President of the West Suburban Chiefs of Police Association (WSCOP). Gutierrez is the first Command Officer from the Cicero Police Department to be sworn in as President of the WSCOP since its inception in 1960. "We are very proud of Deputy Gutierrez for all that he does and for this great honor to head the West Suburban Chiefs of Police association," said President Larry Dominick. "The Town of Cicero has many great professional police officers like Deputy Gutierrez, and I am proud of all of them. It's great to see other

outside agencies recognize the talent that we have."

Judge Jesse Reyes swore in the WSCPA Officers including Gutierrez. "This is a great opportunity, and we will work together to continue to move this organization forward," Gutierrez said after acknowledging attendees and former officers. CELEBRATING MEXICAN INDEPENDENCE

The Beginnings of Anthropology in Mexico

The beginnings of modern anthropology (the scientific study of non-western peoples) in what would become Mexico started in the 18th Century, and even then this work was the effort of foreigners outside of Mexico. The first best known researcher of New Spain's (Mexico's name during Spanish colonial rule) was an Italian named Lorenzo Boturini Benaducci (1698 to 1749) Born in the Italian peninsula of noble parentage, he was a subject of the Spanish Empire while living in the Holy Roman Empire (Austria). When war broke out between Spain and Austria, Boturini fled to New Spain. During his eight year stay in New Spain, Boturini became fascinated with the

native Amerindian peoples throughout the country. He traveled throughout much of the Spanish colony where he collected many artifacts, both from his present day as well as from centuries past of these peoples, and left his collection in the City of New Spain (now Mexico

This collection would eventually become known as the Royal and Pontifical University of Mexico, and was the beginning of anthropology in New Spain. During the Spanish colonial period, there was a growing interest in the study of native peoples in the colony; mostly by European explorers. Boturini wrote a book on the native peoples of New Spain which was published after his death in 1755. The collection BoMexico's attempt at establishing a national program of studying the peoples of

turini had started grew so much that in 1790 the collection became known as the Cabinet of Curiosities under the Spanish botanist Jose Longinos Martinez. The study of the peoples of New Spain took a back seat to the upheavals of the beginning of the 19th Century. When New Spain became the independent nation of Mexico in 1821, Mexico's first president, Guadalupe Victoria, established the first true museum of anthropology in Mexico City. Advised by then Mexican historian Lucas Alaman, President Victoria created the National Mexican Museum dedicated to the native peoples of Mexico. This was the beginning of



the country; peoples who had been an integral part of the country's history going back centuries and who distinguished Mexico as a heritage and culture distinct from the former colonial power of Spain.

But this early attempt at trying to study the early indigenous peoples of Mexico

was hampered by unstable governments, war, civil war, and invasion from Spain and then France. Another factor was the inherent prejudice in the social hierarchy against the native peoples. Even though successive administrations tried to highlight the unique native cultures of Mexico, the old social attitudes of the ruling elites still saw the native peoples as inferior to the European ways since Spanish colonial times. These attitudes began to slowly change after 1870 when Mexico was finally at peace after the end of the French colonial invasion of the country.

Anthropology as a Mainstay in Mexico's Search for its Roots

Despite the economic prosperity of Mexico under then President Porfirio Diaz, much of Mexico's population, especially its native peoples, remained deeply impoverished. Social and class inequalities were serious issues for most of Mexico's people. In the same year that the National Museum of Archaeology, History and Ethnography opened to the public, 1910 marked the beginning of the Mexican Revolution. For the next ten years, Mexican and rebel armies would fight many battles as the revolution impacted many aspects of the country's people. Millions of Mexicans were forced to flee from one region to the next, and many Mexicans even fled into the United Stated from the northern Mexican states

along the U.S.-Mexico border. The main focus of the revolution became the fight for the rights of Mexico's poor, especially the indigenous peoples, land rights, and a more stable political infrastructure and constitution where the people had a say in their government.


The amazing thing about the revolution was despite the widespread destruction, the vast collections of Mexico City's museum remained intact. When the revolution ended in 1920, the museum's vast collection had increased to over 52,000 items. By 1940, the museum was divided into two completely separate entities; the National Museum of History which dealt with the history of Mexico from the Spanish colonial period to the then current era, and the National Museum of Anthropology

which dealt with the period before the Spanish colonial era. The National Museum of Anthropology drew in many new artifacts that had been discovered over the decades. By 1963, the museum was no longer able to hold the vast collection it had, so a new had to be constructed. The new museum, designed by the great Mexican architect Pedro Ramirez Vazquez, took into consideration the most modern designs for the time and the indigenous architectural designs that had been part of Mexico's native people's past. The result was a beautifully designed museum that encompasses outside exhibits and gardens as well as 23 rooms dedicated to Mexico's indigenous past. Opened in 1964 under then Mexican President Adolfo Lopez Mateos, the museum

is the country's crowning

achievement in searching for its identity.

The National Museum of Anthropology is far from being the only museum dedicated to Mexico's Spanish colonial and indigenous past. There are state and local museums that have been founded over the decades equally dedicated to the native cultures and prehistories of the local areas. Anthropological and archaeological studies continue throughout Mexico, and even Mexico City which was once the capital of the Aztec Empire. Excavations are continually being carried out in an effort to learn more what the former Aztec capital Tenochtitlan might have been like. Even the local arts and handicrafts are influenced by the native people's cultures in their local areas. Likewise, many famous Mexican artists



have been influenced by the country's indigenous arts. Works by famous Mexican artists such as Diego Rivera (1886 to 1957), Frida Kahlo (1907 to 1954), David Alfaro Sigeuiros (1896 to 1974), Antonio Gonzalez Orozco (1933 to 2020), and Desiderio Hernandez Xochitiotzin (1922 to 2007)

among others, were influenced by the indigenous peoples of pre-Spanish Mexico. Today, Mexicans as well as tourists from other countries can see and come to understand the arts, cultures and architectural marvels of its indigenous peoples as well as the rich Spanish colonial heritage of Mexico.

Los Inicios de la Antropología en México

Los inicios de la antropología moderna (el estudio científico de los pueblos no occidentales) en lo que sería México comenzaron en el siglo XVIII, y aún entonces este trabajo fue esfuerzo de extranjeros fuera de México. El primer investigador más conocido de Nueva España (nombre de México durante el dominio colonial español) fue un italiano llamado Lorenzo Boturini Benaducci (1698 a 1749). Nacido en la península italiana de ascendencia noble, fue súbdito del Imperio español mientras vivía en el Santo Imperio Romano (Austria). Cuando estalló la guerra entre España y Austria, Boturini huyó a Nueva España. Durante su estancia de ocho años en Nueva España, Boturini quedó fascinado con los pueblos nativos amerindios de todo el país. Viajó por gran parte de la colonia española donde coleccionó

muchos artefactos, tanto de la actualidad como de siglos pasados de estos pueblos, y dejó su colección en la Ciudad de Nueva España (ahora Ciudad de México).

Esta colección llegaría a ser conocida como la Real y Pontificia Universidad de México, y fue el inicio de la antropología en la Nueva España. Durante el período colonial español, hubo un creciente interés por el estudio de los pueblos originarios de la colonia; principalmente por exploradores europeos. Boturini escribió un libro sobre los pueblos nativos de Nueva España que se publicó después de su muerte en 1755. La colección que Boturini había iniciado creció tanto que en 1790 la colección pasó a ser conocida como el Gabinete de Curiosidades del botánico español José Longinos Martínez. El estudio de los pueblos de la Nueva España quedó relegado a un segundo plano frente a las convulsiones de principios

del siglo XIX. Cuando Nueva España se convirtió en la nación independiente de México en 1821, el primer presidente de México, Guadalupe Victoria, estableció el primer verdadero museo de antropología en la Ciudad de México. Asesorado por el entonces historiador mexicano Lucas Alamán, el presidente Victoria creó el Museo Nacional Mexicano dedicado a los pueblos originarios de México. Este fue el comienzo del intento de México de establecer un programa nacional de estudio de los pueblos del país; pueblos que habían sido parte integral de la historia del país desde hacía siglos y que distinguían a México como un patrimonio y una cultura distintos de la antigua potencia colonial de España.

Pero este primer intento de estudiar a los primeros pueblos indígenas de México se vio obstaculizado por gobiernos inestables, guerras, guerras civiles e inva-

de Francia. Otro factor fue el prejuicio inherente a la jerarquía social contra los pueblos originarios. Aunque las sucesivas administraciones intentaron resaltar las culturas nativas únicas de México, las viejas actitudes sociales de las elites gobernantes todavía consideraban a los pueblos nativos como inferiores a las costumbres 1870, cuando México finalmente estuvo en paz después del fin de la invasión colonial francesa del país.


Navy Pier to Host Chicago Live! Community Engagement Program

Important safety information from Nicor Gas

Every day, underground pipelines safely transport natural gas — one of the most efficient, reliable and environmentally friendly fuels — to homes and businesses throughout the country. Nicor Gas operates, secures and maintains the pipelines in our service territories. We adhere to state and federal pipeline safety regulations, perform extensive quality-control checks, educate the public on how to recognize and prevent natural gas leaks, and work closely with officials to develop emergency response plans.

Call before you dig

Before digging on your property, state law requires you call **811** to have your utility lines professionally marked – for free! You must wait the required amount of time before you begin your project. Pipeline markers indicate the general area of the pipeline, but not its exact location or depth. A pipeline may not always be marked in all areas, so it is important to always "Call Before You Dig." If a pipeline right of way is adjacent to your property, you have a responsibility to ensure no new installations of landscaping or physical structures are placed in the right of way, which interferes with our ability to keep the pipeline safe through routine monitoring and maintenance.

Information about transmission pipelines operating in your community can be accessed online at **npms.phmsa.dot.gov**, courtesy of the National Pipeline Mapping System (NPMS).

Water heater safety

The U.S. Consumer Product Safety Commission urges all users to lower their water heaters to 120 degrees Fahrenheit.

Carbon monoxide

Incomplete combustion of any fuel produces carbon monoxide. Carbon monoxide is poisonous and has no odor, taste or color. Carbon monoxide detectors are helpful, but they are no substitute for using equipment safely. This includes having your appliances inspected once a year by a certified contractor.

Appliance safety

According to the Federal Emergency Management Agency:

- It is important that you have your furnace inspected by a qualified specialist.
- Be sure all furnace controls and emergency shut-offs are in proper working condition.
- Keep trash and other combustible materials away from your air, heating and water heating systems.

Pipeline integrity management is a process for assessing and mitigating pipeline risks to reduce both the likelihood and consequences of incidents. We have a comprehensive plan that fully addresses these processes, especially for locations deemed high-consequence areas.

If you smell gas, act fast!

Although natural gas pipeline incidents are uncommon, you can help prevent emergencies by knowing the signs of a potential problem. Even though you may not currently be a Nicor Gas customer, you can play an important role in natural gas safety. Below are some tips on how to identify a possible natural gas leak, and what to do in such a situation.

LOOK for blowing dirt, discolored vegetation or continued bubbling of standing water.

LISTEN for a hissing or roaring noise near a natural gas appliance or line.

SMELL for the distinctive, rotten-egg odor associated with natural gas. Natural gas is colorless and odorless, so we add a chemical odorant called mercaptan for easy detection of a suspected natural gas leak. This odorant has a distinctive "rotten egg" type odor. You should act any time you detect even a small amount of this odor in the air.

Note: Be aware that "odorant fade," while uncommon, can occur. Odorant fade occurs when a physical or chemical process causes the level of odorant in the gas to be reduced. This can happen in both existing gas pipe and new installations. Some individuals may not be able to detect the smell of the natural gas odorant because they have a diminished sense of smell, because the scent is being masked by other odors in the area or because the odorant has diminished so that it is not detectable. Some gas lines, due to their unique function, may not have odor at all.

If you detect even a small amount of this odor in the air:

DO NOT try to identify the source or to stop the leak yourself.

LEAVE the area immediately and move a safe distance away from the potential leak, while avoiding any action that may cause sparks.

AVOID using any sources of ignition, such as cellphones, cigarettes, matches, flashlights, electronic devices, motorized vehicles, light switches or landlines, as natural gas can ignite from a spark or open flame, possibly causing a fire or explosion. Natural gas is nontoxic, lighter than air and displaces oxygen. In severe cases, if not used properly, it can also lead to asphyxiation.

CALL Nicor Gas at **888.Nicor4U** (642.6748) or **911** once you are out of the area of the suspected leak and in a safe place. Stay away until Nicor Gas or emergency personnel indicate it is safe to return.
