From embracing storytelling at the Chicago International Latino Theater Festival and Goodman Theatre to learning the rich history of the Latino community with the help of the National Museum of Mexican Art and the National Museum of Puerto Rican Arts and Culture. To help you make the most of Hispanic Heritage Month, we have listed a few of our recommendations for you to enjoy.

•Destinos Chicago International Latino Theater Festival: Get ready for a theatrical, cultural experience at Destinos. From Sept. 28 to Nov. 12, this city-wide event will showcase the talent of Latino theater artists and companies from Chicago, the U.S., and Latin America. Immerse yourself in vibrant stories and perspectives that celebrate the richness of Latino theater.

•Latinx Heritage Month at the Field Museum: Through October 15, guests can embark on a cultural journey of Latin America through music, dance, and performances from Ballet Folklorico and La Escuelita Bombera de Corazon. Additional activities include bilingual storytime, exhibitions, and stories that showcase Latinx contributions from Chicago to the Amazon rainforest.

•Lucha Teotl at the Goodman Theatre: Step into the captivating world of Lucha Teotl, where prowrestling takes the stage starting Sept. 29 – Oct. 29. This 90-minute bilingual production promises a night of unforgettable theater that dives into the rich heritage of Lucha Libre through a tale about family, honor, tradition, and redemption.

•Hispanic Heritage Night with the White Sox: The Chicago White Sox hosts Hispanic Heritage Night at the ballpark every year. Fans can enjoy Latino music, performances, and food. This year's celebration takes

place on Saturday, Sept. 30. The first 10,000 fans will receive a bobblehead paying tribute to a Day of the Dead cultural icon, La Catrina.

•Visit The National Museum of Mexican Art, where you can immerse yourself in the richness of Mexican art and culture in Chicago.

•Pilsen Arts and Community House: This non-profit art gallery and community center in Pilsen provides art workshops, exhibits, film screenings, book clubs, panel discussions, music performances, and more to help the community

engage with the arts across mediums.

•The National Museum of Puerto Rican Arts and Culture is hosting a pop-up exhibit titled *Resistencia y Libertá* that celebrates the community expression of Afro-Puerto Rican Bomba music through fashion.

•The Mexican Cultural Center DuPage encourages and promotes Mexican heritage through cultural, ethnic and civic activities designed to educate the City of West Chicago's Mexican community and the community at large.

•The first itinerary,
"Immersed in Hispanic

showcases various ways to

 Hispanic Heritage Month in Chicago and Rockford over three days, covering 89 miles of travel.

•The second itinerary, "Community Treasures with a Latino Flavor," offers ways to celebrate Latin food, culture, and local businesses in Peoria and the Quad Cities over three days, covering 104 miles of travel.

Deadline Approaching for FEMA Assistance

Cook County residents impacted by this summer's storms and flooding have a window of opportunity to apply for FEMA assistance as the deadline quickly approaches. "Do not wait, the sooner you get the process started the better," said FEMA Media Relations Specialist Leyla Gulen. "We have DRC reps who speak multiple languages ready to assist you in the process, so we encourage anybody to come and get registered." FEMA Disaster Recovery Centers (DRC) opened all across Cook County late summer, so far with the help of loans provided by the U.S. Small Business Administration (SBA), more than \$125 million have been distributed

to families across Chicagoland and FEMA has received over 50,000 registrations.

"We can't do it without the support from town leadership, district leadership, town halls and events. It's a tremendous feeling to know how many we have helped, and we just want to make sure we don't miss anybody. Which is why it is crucial to apply before the deadline," said Gulen. DRC locations provides assistance which can include grants for temporary housing and home repairs, low-interest loans to cover uninsured property losses other programs to help individuals and business owners recover from the effects of the disaster. Federal funding is also available on a cost sharing basis for hazard mitigation measures in Cook County. When meeting with a DRC rep applicants must show proof of residence, then the initial registration process begins, the applicant will go through the SBA loan application process, and finally will set up an appointment with an The whole inspector. process, depending on the individual need, can take anywhere between seven to 10 days, according to Gulen.

In addition, a DRC location will also help the applicant learn their status, help the applicant understand any letters or contacts you get from FEMA, learn about additional disaster assistance programs, and get referrals to agencies and so much more. The



deadline to apply for FEMA assistance is on October 16th. If you have questions about FEMA assistance, visit a Disaster Recovery Center or call the FEMA Helpline at 800-621-3362. If you would like to visit a DRC, the following locations are available:

Se Acerca la Fecha Límite para la Ayuda de FEMA

Los residentes del Condado Cook impactados por las tormentas y las inundaciones del verano tienen una ventana de oportunidad para solicitar la ayuda de FEMA ya que la fecha límite se rápidamente. acerca No espere, mientras más pronto inicie el proceso, mejor", dijo la Especialista de Relaciones de Medios de FEMA, Leyla Gulen. "Tenemos representantes DRC que hablan múltiples idiomas, listos para avudarle en el proceso, por lo que aconsejamos a todos que vengan y se inscriban". FEMA Disaster Recovery Centers (DRC) abrió en todo el Condado de Cook el verano pasado, hasta ahora con la avuda de préstamos provistos por U.S. Small Business Administration (SBA), más de \$125 millones han sido distribuidos a familias en todo Chicago y FEMA ha recibido más de 50,000 inscripciones.

No podemos hacerlo sin el apoyo del liderazgo del poblado, el liderazgo del distrito, ayuntamientos y eventos. Es una sensación tremenda saber a cuántos hemos ayudado y sólo queremos asegurarnos de no haber pasado por alto a nadie. Por eso es crucial hacer su solicitud antes de la fecha límite", dijo Gulen, Los locales de DRC ofrecen ayuda que puede incluir subsidios para vivienda temporal y reparaciones en el hogar, préstamos a bajo interés para cubrir pérdidas de propiedad no aseguradas y otros programas para ayudar a personas y propietarios de negocios a recuperarse de los efectos del desastre. También hav fondos federales disponibles en forma de costos compartidos para medidas de mitigación de riesgos en el condado de Cook. Cuando se reúnan con los representantes de DRC deben mostrar prueba de residencia, y entonces comienza el proceso de inscripción inicial, el solicitante pasa por el proceso de solicitud de préstamos SBA y finalmente se hace una cita con un inspector. El proceso completo, dependiendo de las necesidades del individuo pueden tardar entre siete a 10 días, de acuerdo a Gulen.

Además, un local de DRC ayudará también al solicitante a conocer su estatus y le ayuda a entender cualquier carta o contacto que reciba de FEMA, aprenden sobre programas de desastres adicionales y reciben referencias a agencias y mucho más. La fecha límite para hacer su solicitud para la ayuda de FEMA es el 16 de octubre. Si tiene alguna pregunta sobre la ayuda de FEMA, visite Disaster Recovery Center o llame a la línea de ayuda de



Youth Employment Up 19 Percent through One Summer Chicago

This week, the City of Chicago announced that over 24,000 young people were employed through the One Summer Chicago (OSC) program during the summer of 2023, representing a 19 percent increase from the previous year. The OSC program is a partnership between the Mayor's Office, the Department of Family and Support Services, Chicago Public

Schools, Chicago Park District, Chicago Housing Authority, Chicago Transit Authority, City Colleges of Chicago, communitybased organizations, corporate partners, and local companies to offer employment and internship opportunities to young people ages 14 to 24. The total number of participants in this summer's program marks an increase of over 4,000 young people in

comparison to last year's total. Of the participants engaged in this summer's programs, 1,771 youth have disabilities, 13,903 are attending Level 2, Level 3, or Option schools, 2,698 are English as a Second Language Learners, 755 are young people who are experiencing homelessness or are unstably housed, 233 are in the foster care system, 219 are justice-involved, and 2,494 are



youth who are out of school and out of work. Across all OSC partners, youth completed 2.43 million hours of work experience and project-based learning. Youth earned over \$33.9 million in wages.
