Born and raised in the Little Village neighborhood, Associate Manager of Government and Corporate Citizenship at PepsiCo Rafael Hurtado Jr. fostered the skill to galvanize a community through his work with the Little Village Environmental Justice Organization (LVEJO) at 15 years old. His years

spent with LVEJO brought about policy changes that tackled environmental injustices and spearheaded the Clean Power Campaign, which was successful in the shutdown of both the Crawford & Fisk Coal power plants. Hurtado Jr., pursued a B.A. from the University of Illinois, Chicago with a major in criminology, law, and justice and we highlight

his work in our Hispanic Heritage Month series in hopes his message inspires the next wave of community activists.

Your altruistic path began with volunteering with the Little Village **Environmental Justice** Organization (LVEJO). How were you introduced to LVEJO and how did that experience help to shape you as a community organizer? Rafael Hurtado Jr.: I grew up in Little Village. When I was 12, my father and I attended a rally across the street from our house organized by LVEJO to raise awareness for their fight to open a new park on the East side of our neighborhood. They had selected the empty lot across the street as their ideal location. What 12-year-old wouldn't want a park across the street from their house? Well, it worked. I wouldn't walk through the doors of LVEJO again until my freshman year of high school to do my CPS-mandated service-learning hours. Looking back, that first LVEJO rally and knowing that struggle led to La Villita Park coming to life catapulted me into a career and I saw the process firsthand. The open space with athletic fields, a skate park, basketball courts, playgrounds, community gardens and lights for longer play time is a staple for the community. This was only possible because of the community organizations who rallied behind it and the process showed me how critical the work of community organizations is within a neighborhood. I knew I had to work in a field that would ensure efforts like

this continue. Lawndale Bilingual **News: Currently, you are** the Associate Manager of Government and Corporate Citizenship at PepsiCo. What aspect of your career do you enjoy the most? Rafael Hurtado Jr.: I appreciate my talented and passionate team members at PepsiCo. I'm proud to work for a company with deep Chicago roots that seeks ways to give back and support its neighbors. Creating and maintaining partnerships with local and national community partners is the part of my portfolio that I enjoy the most. Part of my job is to engage with elected

Lawndale Bilingual News: PepsiCo launched paid internship program as part of the Pathways to Readiness and **Empowerment** Program that offered leadership training and opportunities to Black and Latino youth on the South and West side communities. Can you expound on the significance of creating a program that invests underrepresented in communities? Rafael Hurtado Jr.: I owe my success to my exposure to community work at a young age. The Pathways to Readiness and **Empowerment Program** (PREP) PepsiCo launched in October 2021--after speaking with many South and West Side community organizations--is another example of the company doubling down on its commitment to the communities it serves. PREP is a more than \$5 million investment that aims to put nearly 3,000 young people from Chicago's South and West Sides on the path to highquality careers over the next five years. Since PREP launched, over 600 youth have been provided with career readiness resources. This investment includes dozens of career exposure events hosted by PepsiCo in partnership with local nonprofits, including Ladies of Virtue, Teamwork

support their constituents.

a paid summer internship program across PepsiCo's city operations and invested more than \$400,000 in scholarships for Black and Hispanic community members. I am incredibly proud of nearly a dozen PREP program participants who have decided to join our company as employees, and we intend to continue to invest in their development and career growth.

Lawndale Bilingual News: What advice do you have for youth who would like to follow in your footsteps? What should they be aware of and what skillset should they begin to foster? Rafael Hurtado Jr.: Growing up on the South and West Sides of Chicago can be tough. You learn to trust your intuition. Keep doing that, and don't doubt or second guess yourself. Many of us come from lowincome households—being resourceful and financial literacy are essential. Although intangible and easy to overlook in a corporate setting, "street smarts" will help you advance in your career. Speaking to a US senator or a CEO isn't as scary as growing up in a neighborhood with high levels of crime and violence. Keep an open mind when it comes to a career. I wasn't aware specific jobs existed until I was older. You might have a dream job that you don't yet know exists. Be comfortable taking on assignments outside your comfort zone because they may lead you down a path you didn't have exposure to. Nacido y criado en el barrio de La Villita, Gerente Asociado de Gobierno y Ciudadanía Corporativa de PepsiCo, Rafael Hurtado Jr., fomentó la habilidad de galvanizar a una comunidad a través de su trabajo con la Organización de Justicia

Ambiental de La Villita (LVEJO) cuando tenía 15 años. En sus años pasados con LVEJO provocó cambios de políticas que abordaron las injusticias ambientales y encabezó la Campaña de Energía Limpia, que logró el cierre de las centrales eléctricas de carbón Crawford y Fisk. Hurtado Jr., obtuvo un B.A. de la Universidad de Illinois, Chicago, con una especialización en criminología, ley y justicia y destacamos su trabajo en nuestra serie del Mes de la Herencia Hispana, esperando su mensaje inspire a la próxima onda de activistas comunitarios. Tu camino altruista comenzó como voluntario en la Organización de Justicia Ambiental de La Villita (LVEJO). ¿Cómo conociste a LVEJO y cómo te ayudó esa experiencia a formarte organizador como comunitario?

Rafael Hurtado Jr.: Crecí en La Villita. Cuando tenía 12 años, mi padre y yo asistimos a una manifestación en la calle frente a nuestra casa, organizada por LVEJO para concientizar su lucha para abrir un nuevo parque en el sector Este de nuestro vecindario. Habían seleccionado un lote vacío frente a la calle, como un lugar ideal. ¿Qué niño de 12 años no desearía tener un parque frente a su casa? Bueno, ocurrió. No tendría que atravesar las puertas de LVEJO más hasta mi año de primero de secundaria para hacer mis horas de aprendizajeservicio exigidas por CPS. Mirando hacia atrás, esa primera manifestación de LVEJO v saber que esa lucha llevó a que el Parque La Villita cobrara vida, me catapultó a una carrera en asuntos públicos. El parque es extremadamente importante para los

residentes del vecindario de La Villita y vi el proceso de primera mano. El espacio abierto, con campos deportivos, pista de patinaje, canchas de baloncesto, áreas de juegos infantiles, jardines comunitarios y luces para jugar durante más tiempo es un elemento básico para la comunidad. Esto sólo fue posible gracias a las organizaciones comunitarias que se unieron detrás de esto y el proceso me mostró cuán crítico es el trabajo de las organizaciones comunitarias dentro de un vecindario. Sabía que tenía que trabajar en un campo que garantizara que esfuerzos como este continuaran.

Lawndale Bilingual News: Actualmente eres Gerente Asociado de Gobierno y Ciudadanía Corporativa en PepsiCo. ¿Qué aspecto de tu carrera disfrutas más? Rafael Hurtado Jr.: Aprecio a mis talentosos y apasionados miembros del equipo en PepsiCo. Me enorgullezco de trabajar para una compañía con profundas raíces en Chicago que busca la forma de retribuir y apoyar a sus vecinos. Crear y mantener afiliaciones con asociados locales y comunidades nacionales es parte de mi portafolio y lo disfruto mucho. ofrecía capacitación en liderazgo y oportunidades a jóvenes afroamericanos y latinos en las comunidades del lado sur y oeste. ¿Puede explicarnos la importancia de crear un programa que invierta en comunidades subrepresentadas?

Rafael Hurtado Jr.: Debo mi éxito a mi exposición al trabajo comunitario a muy tierna edad. El Programa Pathways to Readiness and Empowerment (PREP) que PepsiCo lanzó en octubre 2021 – después de hablar con muchas organizaciones comunitarias del sector sur y oeste – es solo otro ejemplo de cómo la empresa duplica su compromiso con las comunidades a las que sirve. PREP es más que una inversión de \$5 millones que espera poner a cerca de 3,000 jóvenes de los sectores sur y oeste de Chicago en camino a carreras de alta calidad

en los próximos cinco años. Desde que PREP se inició, más de 600 jóvenes han tenido recursos para su preparación en carreras. Esta inversión incluye a docenas de eventos de exposición a carreras presentadas por PepsiCo en colaboración organizaciones con no lucrativas locales, incluvendo a Ladies of Virtue, Teamwork Englewood, Southwest Organizing Proyect, UCAN y otros. Adicionalmente, este pasado verano ofrecimos un programa de internado de verano pagado a través de operaciones de PepsiCo en la ciudad y de haber invertido más de \$400,000 en becas para miembros de la comunidad afroamericana e hispanos. Me siento increíblemente orgulloso de cerca de una docena de participantes del programa de PREP que han decidido unirse a nuestra compañía como empleados

e intentamos continuar invirtiendo en su desarrollo v crecimiento.

Lawndale Bilingual News: ¿Qué consejo le darías a los jóvenes que quisieran seguir tus pasos? ¿De qué deberían ser conscientes y qué habilidades deberían empezar a fomentar?

Rafael Hurtado Jr.: Creciendo en los sectores sur y oeste de Chicago puede ser dificil. Uno aprende a confiar en su intuición. Sigan haciendo eso y no duden o cambien de opinión. Muchos de nosotros venimos de familias de bajos ingresos – es esencial ser ingenioso y tener conocimientos financieros. Aunque es intangible y fácil de pasar por alto en un entorno corporativo, la "inteligencia callejera" le ayudará a avanzar en su carrera. Hablar con un senador estadounidense o un director ejecutivo no da tanto miedo como crecer



en un vecindario con altos niveles de criminalidad y violencia. Mantenga la mente abierta cuando se trata de una carrera. No sabía que existían trabajos específicos hasta que fui mayor. Es posible que tengas el trabajo de tus sueños y que aún no sepas que existe. Siéntete cómodo asumiendo tareas fuera de tu zona de confort porque pueden llevarte por un camino al que no estabas expuesto.

Lawndale Bilingual News: Ahora que destacamos los logros y contribuciones de la comunidad latina durante el Mes de la Herencia Hispana, ¿Que significa este mes para ti? Rafael Hurtado Jr.: El Mes de la Herencia Hispana es un momento para celebrar los logros y contribuciones de la comunidad latina. Edly-Allen Encourages Educators, Parents to Use Educational Tax Credits



State Senator Mary Edly-Allen is reminding taxpayers that they may be able to claim school expenses for their K-12 students on their 2023 Illinois individual income tax returns. The Illinois **Education Expense Credit** allows parents or legal guardians of a full-time K-12 student to take a 25 percent tax credit on qualified education expenses over \$250 this year, up to \$750 per household. Qualified educational expenses include tuition, book rental, and lab fees in excess of \$250 paid to the school where the student is enrolled on a full-time basis. For homeschooled students, book rental, and lab fees greater than \$250 are eligible when attending a qualified home school program. The K-12 Instructional Materials and Supplies Tax Credit allows eligible teachers of full-time K-12 students to receive

a tax break for qualified expenses on classroom materials paid during the taxable year. To qualify, taxpayers must be teachers, instructors, counselors, principals, or aides for at least 900 hours during a school year. Increasing from last year, they can now claim a credit up to \$500 for qualified expenses they paid in the current taxable year. If spouses are both educators and are filing jointly, the maximum credit is \$1,000. To learn more about the Illinois Education Expense Credit, visit IDOR's website at tax.illinois. gov.

Through this RFP, the City will select community and economic development organizations that will be responsible for identifying vacant storefronts in their respective community areas, negotiating short-term leases with landlords, sourcing local small businesses for storefront activations, managing preparation and operations for the space, and providing ongoing support to small businesses operating pop-up stores. These activations will boost local spending and draw additional foot traffic to commercial corridors across all 77 neighborhoods. RFP grantees will negotiate short-term leases for move-



in ready vacant storefronts, and partner with local small businesses to launch pop-up stores, community markets, or other commercial activations that support local businesses. The grantees will also assist the businesses with business coaching and support them in managing a storefront. For

ComEd Encouraging 75 Latino Students to Pursue Careers in STEM During ComEd STEM Labs



As part of its annual Hispanic Heritage Month celebration and to help diversify the pipeline of students pursuing careers in science, technology, engineering and math (STEM) fields, ComEd hosted an event in which local Latino high school students worked alongside ComEd engineers to learn about batteries and STEM careers while building their own Bluetooth speakers. The event, part of ComEd's STEM Labs program, engaged seventyfive Latino high school students from across Chicagoland and northern Illinois on Saturday, Sept. 30, at ComEd's Chicago North facility. The students worked with ComEd mentors and special guest, Dr. Kate Biberdorf, a renowned author, chemist and science educator to explore a variety of STEM activities including learning about batteries and building their own Bluetooth speakers. In addition to building Bluetooth speakers and networking with ComEd mentors and executives, each student received a \$250 scholarship upon completing the program. Latino Americans make up 17 percent of the U.S. workforce, but only eight percent of STEM workers. ComEd STEM Labs is one example of how ComEd is



Como parte de la celebración del Mes de la Herenia Hispana, para ayudar a diversificar la línea de estudianes que persiguen carreras en los campos de ciencias, tecnología, ingeniería y matemáticas (STEM), ComEd ofrece un evento en que los estudiantes de secundaria latinos trabajaron junto con ingenieros de ComEd para aprender sobre baterías y carreras STEM mientras construyen sus propios parlantes Bluetooth. Cicero Police Dept. Arrest Minor in Connection to a Vehicular Hijacking, Armed Robbery Spree

The Cicero Police Department (CPD) announce the arrest of a 13 year old minor, of Chicago, Illinois, for Attempted Armed Robbery, Armed Robbery, Aggravated Hijacking Vehicular and Unlawful use of a Weapon which occurred on September 28, 2023. Officers responded to two (2) separate Vehicular Hijackings which occurred on the 1400 Block of 61st Avenue. Victims stated that a White BMW with

no registration stopped when three (3) armed male black offenders exited the vehicle and demanded their vehicles. The armed offenders then committed four (4) additional robberies and fled the scene. Shortly thereafter, the same armed offenders committed two (2) additional robberies in the area of the 1500 Block of 61st Avenue. Officers quickly gathered information on the last known direction of travel, at which time Tactical

Officers observed the White BMW and our two (2) vehicles which were stolen. A pursuit ensued, at which point one of the stolen vehicles crashed in the City of Chicago. After a short foot pursuit, Officers were able to place one of the offenders into custody without incident. A weapon was recovered in the stolen vehicle. The other two (2) vehicles made good on their escape and the investigation is still ongoing. The Cook County State's Attorney




Office Juvenile Screening reviewed the investigation which approved one count of Attempted Armed
