A Chicago delegation of city, state, faith and philanthropic leaders, led by Deputy Mayor of Immigrant, Migrant, and Refugee Rights, Beatriz Ponce de Leon, visited the southern border this last week. La fecha límite solicitar ayuda para federal para la Agencia de Administración de Emergencia Federal es el 30 de octubre si sufrió pérdidas por la inundación y las tormentas que azotaron el estado el 29 de junio y el 2 de julio. Registrarse con FEMA es tan fácil como una llamada por teléfono a la línea directa de FEMA, 800-621-3362, o visite el Centro de Recuperación de Desastres cercano, que puede encontrar en el Localizador de Recuperación de Desastres de FEMA. Los usuarios de un servicio retransmisión de video, servicio telefónico subtitulado u otros servicios de comunicación deben proporcionar a FEMA el número específico asignado para ese servicio. Los sobrevivientes pueden registrarse también a través de DisasterAssistance.gov, o en la aplicación de FEMA en sus teléfonos. Si ya se registró, puede mantenerse en contacto con FEMA vía la Línea de Ayuda 800-621-3362, para cambiar su información de contacto, obtener respuestas o seguir el progreso de su solicitud. Ya sea que sea un propietario, inquilino o propietario de negocio, puede ser elegible para un subsidio de FEMA y/o un préstamo en desastres

El propósito de este viaje es revisar las operaciones en los centros de procesamiento federales y los sitios de tránsito municipales y dirigidos por ONG, y comenzar discusiones con las partes interesadas locales sobre la forma de aliviar los desafíos financieros y operativos, tanto en Chicago como en la frontera.

Un punto de énfasis fue establecer mejores líneas de comunicación y recoger datos de migrantes para agilizar el procesamiento de autorización de trabajo y la transición a la autosuficiencia. La delegación de Chicago compartirá

también pertinente información sobre las condiciones extremas de vivienda y protección al clima que enfrentan quienes buscan asilo en Chicago y los inmensos retos que enfrentan los que no tienen patrocinadores verificados.

Hall y sus compañeros concejales Byron Sigcho-Lopez (distrito 25) y Lamont Robinson (distrito 4) estuvieron entre la delegación que hizo el viaje al sur, donde pudieron ver de primera mano la crisis migratoria que ocurre en la frontera de Texas. "Cuando la gente llega al final de los puntos de control, está



realmente confundida sobre cuáles son los próximos pasos", dijo Sigcho-López. "Realmente hay poco apoyo o coordinación sobre cuál es el punto de destino".



El Alcalde, juntos con ayudantes senior y personal de operaciones claves, permanecieron en Chicago para atender la urgencia inmediata de agregar espacio para albergar a miles de nuevos recién llegados que actualmente duermen en estaciones de policía, aeropuertos, o en la calle. Ahora mismo hay 11,000 migrantes en los albergues de la ciudad y 3,600 más esperando colocación.

and Illinois residents," Johnson's office said in a statement.

The purpose of this trip is to review operations at federal processing centers, and municipal and NGO-led transit sites, and begin discussions with local stakeholders about ways to alleviate the financial and operations challenges in both Chicago and at the border.

A point of emphasis was to establish better lines of communication and collecting migrant data to expedite work authorization processing and the transition to self-sufficiency. The Chicago delegation will also be sharing pertinent information about extreme housing and weather conditions currently facing asylum seekers in Chicago, and the immense challenges awaiting those



without verified sponsors. Hall and fellow aldermen Byron Sigcho-Lopez (25th Ward) and Lamont Robinson (4th Ward) were among the delegation that made the trip South, where they gained a firsthand look at the migrant crisis happening at the Texas border. "When people

are entering the end of checkpoints, they are really confused about what the next steps [are]," Sigcho-Lopez said. "There is really little support or coordination on what is the destination point."

The Mayor, along with senior aides and key operations personnel, stayed in Chicago to address the immediate urgency of adding shelter space to house thousands of new arrivals currently sleeping in police stations, airports or outside. Right now, there are 11,000 migrants in city shelters and 3,600 others awaiting placement.

Time is Running Out to Apply for FEMA Assistance

The deadline to apply for federal assistance the Federal from **Emergency Management** Agency is October 30 if you suffered losses from the flooding and storms that struck the state June 29 – July 2. Registering with FEMA is as easy as a phone call to the FEMA Hotline, 800-621-3362, or a visit to a nearby Disaster Recovery Center, which you can find at FEMA Disaster Recovery Locator. Users of a video relay service, captioned telephone service, or other communication services need to provide FEMA the specific number assigned for that service. Survivors can also register through DisasterAssistance.gov, or on the FEMA app on their phones. If you have already registered, you can keep in touch with FEMA via the Helpline, 800-621-3362, to change your contact information, get your questions answered or to track the progress of your application. Whether you are a homeowner, renter or business owner, you may be eligible for a FEMA grant and/or an SBA disaster loan that may help get you on the way to recovering from disaster losses. Parkholme Pool Project 2023 Due: No later than 10:00 a.m. on November 6, 2023

Notice is hereby given that Clyde Park District (the "Park District") will receive sealed bids for leak repairs and liner replacement at the Parkholme Pool (the "Pool") located at 1820 S. 51st. Street, Cicero, IL 60804.

The bidder must also be bonded and insured and present proof of the same. The bidder shall also submit a sworn notarized statement that they will comply with the Illinois Prevailing Wage Act, including but not limited to reporting as required by law. (820 ILCS 130/2, *et seq.*) The bidder shall also include the cost of obtaining all permits for the project.

A bidder may choose to bid on work associated with both the "Leak Repair" and "Liner Replacement" projects, or bidder may bid on each project individually. Descriptions of the requested projects are set forth below:

Leak Repair

- 1) Sawcut, demolish, and remove concrete at the pool's main drain line located in a tunnel;
- 2) Repair the main drainpipe and test the line to ensure proper flow and use; and
- 3) Prepare areas for new concrete, including, but not limited to:
 - Ensuring the ground is level and properly graded to facilitate proper drainage away from the pool;
 - ii. Excavating the area;
 - iii. Compact the soil to create a stable and even base;
 - iv. Constructing formwork:
 - v. Laying compacting a subbase layer of gravel or crushed stone;
 - vi. Installing expansion joints or isolation joints along the edges of the concrete area;
 - vii. Coating existing reinforcement and adding reinforcement, if necessary;
 - viii. Ensuring proper curing to keep concrete moist and prevent cracks; and
 - ix. Applying sealing, if determined necessary.
- 4) Clean up the site and dispose of any waste materials.

Liner Replacement

Remove and replace the pool liner for the entire pool. Steps include, but are not limited to:

- Completely draining the pool to expose the existing liner;
- ii. Removing the old pool liner, making sure to detach it from any coping or track systems that hold it in place;
- iii. Inspecting the pool's structure for any damage or repairs;
- iv. Patching and repairing any cracks, holes, or imperfections in the pool's surface and ensure pool is free of debris;
- v. Ordering and providing a new liner;
- vi. Installing the new liner into the pool and smoothing out any wrinkles and ensure a snug fit; and
- vii. Cleaning up the site and disposing of any waste materials.

How Mayor Johnson Can Advance Homeownership and Equity in Chicago

Dear Mayor Johnson,

Chicago should be a place where everyone has an equal opportunity to thrive and succeed. Instead, Black families in our city today have just one cent for every dollar that White families have in net worth, and our racial homeownership gap exceeds those of Los Angeles, New York, and Washington, DC.

Homeownership builds family and neighborhood wealth, builds community, supports local businesses, and creates jobs. Homeownership is also an affordable option for many families. A mortgage is a more stable housing cost over time than the ever-rising cost of rent, and in Chicago, a family with a household income at 60% of the area median income will pay up to \$1,700 in rent for an "affordable" 3 bedroom Tax Credit apartment, but will pay the same for the mortgage on a home worth up to \$250,000, from which that same family will be able to build equity.

The City has historically allocated few resources to homeownership. In 2021, for example, the City Department of Housing (DOH) spent \$290.5 million in resources to create or preserve rental units in Chicago, but only 13% of that amount (\$37.8 million) for affordable homeownership. As we continue to heavily subsidize critical affordable rental units, we must apply the same thinking and resources to subsidies for creating new low-moderate income homeowners and homeowners of color.

NHS is uniquely positioned to assist your administration with correcting this situation and to support your efforts to pursue a bold agenda of revitalization for Chicago's low-moderate income neighborhoods and communities of color. Our experience has shown us that there are three (3) critical homeownership strategies that should be part of an effective housing strategy for the City of Chicago to address the racial wealth gap and improve neighborhoods:

- Flexible purchase subsidies for owner-occupant buyers of 1-4 unit homes
- Creative financing tools to support more equitable and affordable mortgages
- Improving City contract procedures to better support community-based organizations

Flexible Purchase Subsidies

Rising interest rates, home values and construction costs have made homeownership harder to access for more and more Chicagoans, especially in formerly redlined neighborhoods. There are many renters who could otherwise become homeowners, but for the rising appraisal and affordability gaps. Current purchase assistance programs don't go nearly far enough in helping aspiring homebuyers cover these rising costs. Deep, flexible subsidies of up to \$100,00 or more per buyer are needed in today's market to help expand affordable homeownership, especially for residents of color in Chicago.

Creative Financing Tools

Traditional lenders have not equitably provided the mortgages that are needed to expand homeownership in our disinvested communities. Home Mortgage Disclosure Act (HMDA) data shows a persistent disparity in the ability of people of color to get mortgages to buy homes. HMDA data shows that applicants of color are denied loans to buy homes 2x - 3x more than White applicants, regardless of home price, downpayment amount *or credit profile*.

Nonprofit affordable housing Community Development Financial Institutions (CDFIs) have been providing mortgage and counseling services to Black and Brown homebuyers for decades. Over 90% of our borrowers are people of color. If CDFIs like NHS are provided with loan loss reserves and other flexible and creative financing tools for lending, we can leverage millions of dollars in private capital to provide fairly-priced mortgage loans to borrowers of color and low-moderate income borrowers.

City Contracts with Community Organizations

Community organizations like NHS are deeply rooted in the neighborhoods we serve and work to deploy City services, programs, and resources to uplift and respond to residents and their housing needs. NHS is a delegate agency and program administrator for a number of important City programs that assist existing and aspiring homeowners. Currently, organizations like ours are required to cover the costs of City contracts upfront, including all grants that are disbursed to Chicago residents and our own operating costs for administering and deploying the programs. This adds up to millions of dollars of our own funds that we must spend each year, while we await the City's lengthy contracting and reimbursement process, which can take 6 months or more. In addition, the organizational funding received through



these city contracts doesn't even reimburse delegate agencies for interest costs we incur to front-fund these programs. A re-examination and overhaul of the systems by which the City leverages, contracts with, and supports community-based organizations is definitely in order, and something we are hoping your administration will address.

Mayor Johnson, we appreciate the opportunity to share our expertise and recommendations. We have a shared goal of addressing the racial wealth and homeownership gaps, and we believe these are the most effective ways to make our city a place where everyone can thrive and succeed. NHS stands ready to partner with you and your administration to build thriving neighborhoods and opportunity for all Chicagoans.
