The President of Latino Art Beat, Don Rossi Nuccio has traveled to Cuba many times over the years, but in 2016 when he was part of the Obama White House Delegation to Cuba during former President Barack Obama's historic trip to Cuba, his involvement with Cuba

has become a formal humanitarian outreach for youth in the arts. Rossi-Nuccio started the 'Cuba Latino Art Beat' initiative in collaboration with the Cuban Ministry of Culture and their community arm, the Consejo Nacional de Casas de Cultura ("Casas

Tras las denuncias de acoso, el Concejal Carlos Ramírez-Rosa renunció el lunes como líder del pleno del Concejo Municipal y como presidente del Comité de Zonificación.

Ramírez-Rosa fue acusado de acoso y de asaltar verbalmente a la Concejal Emma Mitts durante una junta el pasado jueves, para discutir una oferta de preguntar a los votantes durante la primaria de marzo, si Chicago debería mantener su estado de ciudad santuario. Por lo menos 26 concejales deben estar presentes para que se lleve a cabo el voto del referéndum, pero tras varios intentos, la asistencia fue insuficiente.

El Concejal Rosa Renuncia tras Acusación...

del líder del piso Ramírez-Rosa a la presidenta Emma Mitts, la mujer con más años en el cargo en el Concejo Municipal, fue poco profesional e impropia de su función. Las acciones de acoso físico y verbal del Concejal Ramírez-Rosa han defraudado a nuestro consejo y al pueblo de Chicago. En nuestras funciones, debemos defender los valores de respeto y colaboración", compartió el Chicago Aldermanic Black Caucus en una declaración a los medios.

anunció que renunciaría, en una declaración publicada el lunes. "Las tensiones crecieron a un punto caótico en la junta y me dejé llevar, llevándome a actuar de una manera impropia de un líder. Sinceramente me disculpo con mi colega la Concejal Emma Mitts, por la irrespetuosa interacción fuera de las Cámaras del Conceio. También me disculpo con otros colegas que escuché sintieron que les falté al respeto y dañé con mis acciones - Los concejales Lee, Cardona, y Taliaferro", dijo Ramírez-

De todas sus teatralidades y mala conducta presenciadas hoy, estoy completamente disgustado y enfurecido por el hecho de que el líder de piso Ramírez-Rosa acosara y maltratara a mi colega del West Side, la Concejal Emma Mitts. Ningún hombre tiene derecho a ponerle las manos a nadie, y mucho menos agarrar a una mujer y bloquearla físicamente para que no salga, tratando de intimidarla", dijo el Concejal Raymond López en la plataforma X, antes Twitter.

Ald. Carlos Ramirez-Rosa Steps Down Following Harassment Accusation of Fellow Colleague

Following harassment claims, Ald. Carlos

Ramirez-Rosa stepped down at City Council Floor Leader and as Chairman of the Zoning Committee on Monday.

Ramirez-Rosa was accused of harassing and verbally assaulting Ald. Emma Mitts during a meeting last Thursday to discuss a bid to ask voters during the incoming March primary if Chicago should maintain its sanctuary city status. At least 26 alderpeople must be present for the referendum vote to take place, but after several attempts, the attendance was insufficient.

"The bullying by Floor Leader Ramirez-Rosa to Chairwoman Emma Mitts, City Council's current longest-serving woman, was unprofessional and unbecoming of his role. Alderman Ramirez-Rosa's actions of physical and verbal harassment have let down our council and the people of Chicago. In our roles, we must uphold

the values of respect and collaboration," shared the Chicago Aldermanic Black Caucus in a statement to media.

After a weekend

of calls for Ramirez-Rosa's resignation and a protest held on Sunday, Ramirez-Rosa announced he would be stepping down in a statement released on Monday. "Tensions were high at a chaotic meeting, and I let that get the best of me, leading me to act in a way unbecoming of a leader. I sincerely apologize to my colleague, Alderman Emma Mitts, for the disrespectful interaction outside of Council Chambers. also apologize to other colleagues who I have heard also felt disrespected and harmed by my actions – Alderpeople Lee, Cardona. and Taliaferro," RamirezRosa said.

"Of all his theatrics and antics witnessed today, I am thoroughly disgusted and infuriated by Floor Leader Ramirez-Rosa harassing and manhandling my colleague from the West Side, Ald. Emma mitts. No man has the right to lay hands on anyone, let alone grab a woman and physically block her from exiting trying to intimidate her," said Ald. Raymond Lopez on the platform X, formerly Twitter.

"Over the weekend, I spoke with Alderwoman Emma Mitts and Alderman Carlos Ramirez-Rosa. Yesterday, Alderman Ramirez-Rosa and I agreed he should step down from his positions as Chicago City Council Floor Leader and Chair of the Committee on Zoning, Landmarks, and Building Standards," said Mayor

Brandon Johnson.

"Alderwoman Mitts is a venerable leader and woman of abiding faith, who is committed to public service and the principles of accountability and mercy. Alderman Ramirez-Rosa has acknowledged his transgressions, apologized to his colleagues and committed himself to rebuilding trust. It is not lost on me that Thursday's events occurred during a time of heightened tension at City Hall. In recent months, the forces of division have preyed on our city, pitting us against each other in the most destructive ways. I am confident we will find a way to move forward and regain the trust and respect necessary to have a functioning legislative body."

The City Council will meet again on Tuesday.





Experiencing a life filled with adversities from an early age would leave anyone collapsing into a state of perpetual negativity, but not for Union League Boys and Girls Clubs Senior Vice President Hector Perez who overcame the obstacles with unwavering determination. Born in the projects of Puerto Rico, Perez, one of 13 siblings, moved to Chicago with his family after his father, who suffered from alcoholism, passed away. "We moved for the opportunity to have a better life, that's what we believed we

start," said Perez. "Unbeknownst to me, we would be facing another challenge. I learned that were gangs in Humboldt Park, there were boundaries and there were limits. I left the projects thinking our lives would be better, but it was difficult. I lived in a two-bedroom apartment with 13 of my siblings, we didn't understand the language, we were worried to leave our house because of the gangs, it was a new world, and we were terrified." While Perez's mother worked tirelessly to provide for her family as a single mother, Perez struggled not to succumb to the would have here, a fresh pull of the gangs promising a water fountain. a sense of brotherhood and the lack of a father figure was apparent leaving him to search for the meaning of family.

As luck would have it, Perez's life would change when he entered the doors of the Union League Boys and Girls Club in search of water. "I heard about the Club once before, but never walked in. It just so happened that it was a particularly hot day, and I was searching for

walked through those doors my life changed. I saw kids playing soccer, I saw the staff taking care of the kids, I noticed there were male mentors and me not having a father, it was im-

In 1981, Perez joined the Union League Boys and Girls Clubs and hit the ground running becoming the youngest junior staff member at 14 years old to then becoming the youngest program director, and at the age of 17 was given a full-time position. Continuing to rise through the ranks, Perez is now senior vice president overseeing 21 locations across Chicago, which includes sites in Englewood, Humboldt Park, Pilsen, and South Lawndale as well as oversee the Club's collaboration with the Cook County Juvenile Detention Center and the 247-acre

ComEd, HIRE360 Celebrate First Graduating Class of New EV Pre-Apprenticeship Program



ComEd and HIRE360 joined members of the community to recognize the first class of graduates of the Take Charge: Pre-Apprenticeship program, a first-of-its-kind program to prepare local residents for careers supporting the fast-growing electric vehicle (EV) industry in Illinois. A diverse class of

17 graduates from across the Chicagoland area has completed the 8-week training program, preparing them to meet entry-level trades roles at ComEd and at the International Brotherhood of Electrical Workers (IBEW) Local 134. The new program is part of ComEd's plan to grow the workforce to meet

evolving demands facing the grid, with EV adoption quickly accelerating in Illinois. Today, there are 80,000 registered statewide, and 70,000 registered in ComEd's service territory alone, up from just over 19,000 statewide in 2019. The shift toward EVs and a clean energy economy is expected to create a

significant number of jobs in the ears ahead, with a recent study estimating that as many as 150,000 new clean energy jobs coming to Illinois by 2050. The inaugural Take Charge program featured a diverse class of trainees from across Chicago, with 16 individuals of color, and four women, and with ages

spanning from 18 to 51. As part of a commitment to ensuring more women and people of color can be represented in training for the trades, HIRE360 prioritized recruitment of diverse candidates from

Young adults who are in the custody of the Illinois Department of Juvenile Justice (IDJJ) are investing in their futures by taking advantage of vocational training certification opportunities offered by Greater West Town Project (GWTP). In mid-October, three members of the inaugural cohort of IDJJ youth completed the National Safety Council's forklift operator training, earning three-year certifications that also include a ten-hour Occupational Safety and Health Administration (OSHA) certification. The program graduates also completed a career exploration course, basic computer training, and a digital literacy course during their 12-week program. Approximately 25 IDJJ staff members and a dozen representatives from GWTP, along with

several family members of youth graduates, gathered at Greater West Town Academy on October 23 to celebrate the cohort's achievements and present certificates and words of encouragement. As part of the new partnership with IDJJ, Greater West Town Project will be offering subsequent opportunities to upcoming cohorts in their shipping and receiving program. The program prepares trainees with a broad base of skills needed to be highly qualified for entry-level employment in positions such as a shipping & receiving clerk, forklift operator, warehouse associate, material handler, traffic agent, stocker, order picker, or dock worker. The next cohort begins in January of 2024.
