innovative approaches to community reporting. Yet, many of these outlets are underfunded or lack the resources necessary to ensure continued success and adaptability. A local coalition of public and private sector funders has committed to supporting Press Forward Chicago. 
## Press Forward Chicago Se Lanza Con \$10 Millones En Compromisos Para Revitalizar Las Noticias Locales




## IDPH Announce \$3.5M to Boost Mental Health Services for Youth Across Illinois

Governor JB Pritzker and the Illinois Department of Public Health (IDPH) announced today that the State of Illinois has awarded \$3.5 million in funding to 19 different applicants across the state to support post-pandemic child and adolescent health. The size of the grants ranges from \$92,000 to \$200,000. The new round of grants follows \$9.5 million in grants that were primarily federally funded to 40 organizations around the state announced last week. Of the new round of grants, 41 percent are awarded to behavioral health treatment centers, 21 percent to schools, 21 percent to healthcare

groups, 11 percent to local health departments and five percent to colleges. The grants are funded by the state of Illinois and are intended to strengthen post-COVID-19 recovery efforts for school-based health needs and for preventing Adverse Childhood Experiences in the post-pandemic era. "The last few years have been a difficult time for all of us, and this is especially true for our youth," Governor

Pritzker said. "The state of Illinois is stepping up and providing this vital support that will strengthen school-based programs and local agencies that serve the mental health needs of young people across Illinois." The funding opportunity was overseen by IDPH's Office of Women's Health & Family Services. More than 50 percent of the applicants for the funding opportunity are receiving funding.



## Chicago Teens in After School Matters Visit Atlanta-Area Colleges



Thirty Chicago teens participating in After School Matters, Chicago's largest and a leading national provider of out-of-school programs, recently returned from a trip to Atlanta to visit colleges and universities as part of the organization's After School Matters University (or ASMU) program. The trip was free for the teens and underwritten by After School Matters, with flights provided by United Airlines. The whirlwind 48-hour trip took place October 26-27, with visits to Georgia Institute of

Technology, Morehouse College and Spelman College, Emory University, Georgia State University, along with time spent at The King Center and Dr. King's birth home before departing for the airport. ASMU provides Chicago high school students with an opportunity to prepare for post-secondary goals and encourages youth to break down barriers to their college or career goals. A program offered through After School Matters, ASMU creates a safe, supportive space for teens to explore their

passions, prepare for college and career success, and connect to networks like the After School Matters Alumni Network. There is no cost to apply to After School Matters, and teens earn money for their participation. The application for Spring programs (running late February - mid-May) will open in late November. ## Communities in Schools of Chicago Renews Youth Mental Health First Training for Parents, Teachers and Staff



Amid a new and growing body of research about the mental health crisis facing youth and their families, Communities In Schools of Chicago (CIS)

is encouraging the public to register for Youth Mental Health First Aid Training classes, the next of which is scheduled for Tuesday, December 5, 2023. Any

interested and caring adult will acquire the skills and tools to recognize and respond when a young person is experiencing a mental health crisis.

The need for increased mental health resources is undeniable, underscored by a 2021 Youth Risk Behavior survey, which found that 42 percent of high school youth in the state reported feeling sad or hopeless almost every day for two or more weeks in a row, and more than 20 percent seriously committing suicide in the 12 months prior. A 2023 advisory from the Surgeon General's Office further emphasizes that social media use is contributing

to the mental health crisis. Youth Mental Health First Aid is a nationally recognized practice supported by the U.S. government's Substance Abuse and Mental Health Services Administration. The five-hour course enables learners to

determine the difference between "normal" adolescent behavior and what might be common mental health challenges. It also teaches participants a five-step action plan on how to intervene. For more information, visit [www.ciscofchicago.org](http://ciscofchicago.org).



## IDPH Anuncia \$3.5 Millones para Impulsar los Servicios de Salud Mental para Jóvenes en todo Illinois



El Gobernador JB Pritzker y el Departamento de Salud Pública de Illinois

(IDPH) anunciaron hoy que el Estado de Illinois ha otorgado \$3.5 millones

en fondos a 19 solicitantes diferentes en todo el estado para apoyar la salud de ni-

ños y adolescentes después de la pandemia. El tamaño de las subvenciones oscila entre 92.000 y 200.000 dólares. La nueva ronda de subvenciones sigue a \$9,5 millones en subvenciones que fueron financiadas principalmente con fondos federales para 40 organizaciones en todo el estado anunciadas la semana pasada. De la nueva ronda de subvenciones, el 41 por ciento se otorga a centros de tratamiento de salud conductual, el 21 por ciento a escuelas, el 21 por ciento a grupos de

atención médica, el 11 por ciento a departamentos de salud locales y el cinco por ciento a universidades. Las subvenciones están financiadas por el estado de Illinois y están destinadas a fortalecer los esfuerzos de recuperación posteriores al COVID-19 para las necesidades de salud escolares y para prevenir experiencias infantiles adversas en la era pospandémica. "Los últimos años han sido tiempos difíciles para todos nosotros, y esto es especialmente cierto para nuestra juventud", dijo el

Gobernador Pritzker. "El estado de Illinois está intensificando y brindando este apoyo vital que fortalecerá los programas escolares y las agencias locales que atienden las necesidades de salud mental de los jóvenes en todo Illinois". La oportunidad de financiación fue supervisada por la Oficina de Servicios Familiares y de Salud para la Mujer del IDPH. Más del 50 por ciento de los solicitantes de la oportunidad de financiación están recibiendo financiación.

## HFS announces next steps for Health Benefits for Immigrant Seniors program



The Illinois Department of Healthcare and Family Services (HFS) announced

that as the Health Benefits for Immigrant Seniors program nears 16,500

individuals, a temporary pause on new enrollees took effect on November

6<sup>th</sup>. HFS previously announced that new HBIS enrollment would be temporarily paused at 16,500 individuals, an enrollment benchmark the program is expected to reach in the coming weeks. Anyone who is already enrolled in the HBIS program and remains eligible for coverage will stay covered. The Department will not be removing any current enrollees who remain eligible for HBIS coverage. The HBIS program provides Medicaid-like

health care coverage to individuals aged 65 and older who would be eligible for Medicaid but for their immigration status, which launched in late 2020. The Department also operates the Health Benefits for Immigrant Adults program (HBIA), which provides similar coverage for individuals aged 42 to 64. Through the end of September, nearly 69,000 individuals are covered across the HBIA and HBIS programs. HFS announced in June that new HBIS enrollment


would be capped at 16,500 individuals, when the Department filed emergency and regular rules outlining a range of HBIA and HBIS program changes the state has implemented to bring program costs within the amount the General Assembly budgeted for State Fiscal Year 2024, which began July 1. The Department will continue to monitor the costs associated with the program and is committed to preserving this nation-leading program for the future.

## HFS Anuncia Los Próximos Pasos Para El Programa De Beneficios De Salud Para Inmigrantes Mayores

El Departamento de Atención Médica y Servicios Familiares de Illinois (HFS) anunció que a medida que el programa de Beneficios de Salud para Inmigrantes Mayores se acerca a 16,500 personas, el 6 de noviembre entró en vigor una pausa temporal para los nuevos inscritos. HFS anunció previamente que la nueva inscripción de HBIS se suspendería temporalmente en 16,500 personas, un punto de referencia de inscripción que se espera que el programa alcance en las próximas semanas. Cualquiera que

ya esté inscrito en el programa HBIS y siga siendo elegible para la cobertura seguirá estando cubierto. El Departamento no eliminará a ningún afiliado actual que siga siendo elegible para la cobertura HBIS. El programa HBIS brinda cobertura de atención médica similar a Medicaid a personas de 65 años o más que serían elegibles para Medicaid si no fuera por su estado migratorio, que se lanzó a fines de 2020. El Departamento también opera el programa de Beneficios de Salud para Adultos Inmigrantes

(HBIA), que proporciona una cobertura similar para personas de 42 a 64 años. Hasta finales de septiembre, casi 69,000 personas están cubiertas en los programas HBIA y HBIS. HFS anunció en junio que la nueva inscripción de HBIS tendría un límite de 16,500 personas, cuando el Departamento presentó reglas regulares y de emergencia que describen una variedad de cambios en los programas HBIA y HBIS que el estado ha implementado para llevar los costos del programa dentro del monto presupuestado por la Asamblea General para



el presupuesto fiscal estatal. Año 2024, que comenzó el 1 de julio. El Departamento

continuará monitoreando los costos asociados con el programa y está com-

prometido a preservar este programa líder a nivel nacional para el futuro.

## Convicted Sex Offender Charged with Multiple Felonies for Sexual Acts with Minor Victim and Gun Offenses



A Glenview man is facing multiple felony charges after Sheriff's Police detectives learned he groomed and travelled to engage in sexual acts with an underage victim over the last year, Cook County Sheriff Thomas J. Dart announced late October. Sheriff's Police detectives received a tip from law enforcement in the Boston, Massachusetts area regarding a missing juvenile who was linked to the offender, Weston Opas, 42, of the 10300 block of Michael Todd Terrace, in unincorporated Glenview.

Detectives learned that Opas made initial contact with the victim last year through an online gaming app and continued his contact via text messaging. During this time, Opas traveled to the Boston area numerous times to meet with the victim and engage in sexual acts. An analysis of the victim's phone revealed Opas had knowledge of the victim's age. On Oct. 26, detectives identified that the victim was residing at the offender's home and attempted to make contact but were met with

negative results. Sheriff's Police patrol officers and detectives immediately requested, obtained, and executed a search warrant at the residence, where they recovered the victim and arrested Opas. At the residence, detectives also found Opas, a convicted sex offender, was in possession of a firearm, ammunition, and body armor. The victim was temporarily placed into the care of the Illinois Department of Child and Family Services until relatives arrived in Chicago to take custody. In 2004, Opas

was convicted in a child pornography case out of Orange County, Florida. In September of this year, he was charged in Cook County with violating sex offender registration laws after he was found in a school zone. On Oct. 28, the Cook County State's Attorney's Office approved

felony charges of one count each of Traveling to Meet a Child, Grooming, Felon in Possession/Use of a Firearm with Body Armor, and Failure to Report Annually/Sex Offender Registry. He was ordered held in custody at the Cook County Jail at his initial appearance on Sunday.
