State Provides Update on Shelter Site for Migrants

On Wednesday morning, the State of Illinois provided an update on the location for the new shelter site for migrants and also provided new landing zone and services. "The State is determined to use its limited resources as efficiently as possible, helping asylum seekers settle in Illinois and achieve independence," said Governor JB Pritzker. "We will continue to ensure that they are

met with dignity and compassion, while we call for increased coordination and funding from the federal government to provide a federal solution to this federal challenge."

The State announced its new intake center will

be co-located with the City of Chicago's bus landing zone to maximize efficiency, with six heated tents now under construction at the site and expected to open in the coming weeks. The site will connect new arrivals

with services and help those with sponsors or an alternate final destination along on their journey. The State has been funding New Life Centers of Chicagoland and Catholic Charities of the Archdiocese of Chicago

to provide support at the bus landing zone, outside, as of early November.

In terms of the shelter site, the State of Illinois continues this week on the 220-person

shelter located in Little Village at the site of a former CVS. Meanwhile, the State is also partnering with New Life Centers to operate a temporary shelter at a Chicago hotel to support families that arrived during the recent holiday uptick. Those staying at this temporary shelter will transition to the shelter in Little Village, which is expected to open this month. The State is continuing to work with the City to determine where State resources can best be targeted to support additional shelter capacity.

In December, the State and the Greater Chicago Food Depository



announced a \$4 million investment to provide meals to asylum seekers at City of Chicago shelter sites through the end of the calendar year. The funds were announced as the City worked through delays in its procurement process. On January 15, the City will assume responsibility for feeding asylum seekers in City

Busses have been sent outside of Chicago, to Northern Illinois cities, such as Aurora and Elgin. The State has partnered with the City to provide guidance to impacted municipalities and support transportation of new arrivals to the landing zone in Chicago. Over the New Year weekend, Texas

sent a plane to Rockford with more than 350 new arrivals. "At IDHS — we have a message for all Illinoisans — no matter how long they have lived here: Help is here. We take that message very seriously and we are on the frontlines to provide wraparound services and support to our new arrivals," said Dulce M. Quintero, IDHS Secretary Designate.

Año Nuevo, Nuevas Leyes: Entran en Vigor las Leyes Iniciadas por Giannoulias

Varias nuevas leyes iniciadas por el Secretario del Estado de Illinois, Alexi Giannoulias, entraron en efecto el lunes. Las iniciativas fueron aprobadas en el 2023 por la Asamblea General de Illinois antes de ser convertidas en ley. En un esfuerzo por combatir la conducción distraída, el Proyecto 2431 de la Cámara convierte en Ilegal el Zoom, ver o mandar videos, o tener acceso a sitios de los medios sociales mientras maneia. Esta legislación garantizará

los conductores mantienen sus ojos y su atención en el camino, haciendo más seguras las carreteras de Illinois para todos los motoristas de Illinois. Ahora es más fácil para los jóvenes residentes de Illinois garantizar que son elegibles para votar cuando cumplen 18 años. Bajo el Proyecto 2123 del Senado, los adolescentes que obtengan su licencia de conducir o tarjeta ID estatal pueden registrarse para votar en las instalaciones de Illinois Driver and Motor Vehicle (DMV). Esta legislación aumenta la participación y el acceso del votante, garantizando que los jóvenes tienen una voz en los temas que tienen un impacto directo y tangible en sus vidas, especialmente las deudas de préstamos estudiantiles, la economía y la educación. Las personas que buscan un aborto y los inmigrantes indocumentados se sentirán mejor mientras viajan por las carreteras de Illinois sabiendo que el uso

de lectores automáticos de matrículas (ALPR) ahora está regulado en el estado. El Proyecto de Ley 3326 prohíbe el uso de datos recopilados con ALPR para rastrear a personas inocentes o criminalizar comportamientos legales. Aunque los ALPRs pueden ser una valiosa herramienta para el cumplimiento de la ley, esta regulación evitará el abuso, el acoso y la vigilancia ilegal

El Estado da Información Actualizada Sobre Sitio de Refugio para Migrantes

El miércoles por la mañana, el Estado de Illinois proporcionó una actualización sobre el sitio del nuevo albergue para migrantes y proporcionó también nueva zona de llegada v servicios. "El Estado está determinado a utilizar sus limitados recursos tan eficientemente como sea posible, ayudando a quienes buscan asilo a establecerse en Illinois y lograr su independencia", dijo el Gobernador JB Pritzker. "Continuaremos asegurando que sean tratados con dignidad y compasión, mientras pedimos una mayor coordinación y fondos del gobierno federal para proveer una solución federal a este reto federal".

El Estado anunció que su nuevo centro de admisión estará ubicado

junto con la zona de llegada de autobuses de la ciudad de Chicago para maximizar la eficiencia, con seis tiendas de campaña con calefacción actualmente en construcción en el sitio y que se espera que abran en las próximas semanas. El sitio conectará a los recién llegados con servicios y ayuda a quienes tienen patrocinadores o un destino final alterno en su viaje. El Estado ha estado patrocinando New Life Centers of Chicagoland v Caridades Católicas de la Arquidiócesis de Chicago para brindar apoyo en la zona de llegada del autobús, desde principios de noviembre.

En cuanto al lugar de albergue, el Estado de Illinois continúa esta semana trabajando en el albergue de 220 personas localizado en La Villita que era antes un antiguo CVS. Mientras tanto, el Estado se está asociando también con New Life Centers para operar un albergue temporal en un hotel de Chicago para apoyar a las familias que llegaron durante las recientes fiestas. Los que están en este albergue temporal pasarán al albergue de La Villita, que se espera abra este mes. El Estado continúa trabajando con la Ciudad para determinar donde pueden dirigirse mejor los recursos del Estado para apoyar capacidad adicional de albergue.

En diciembre, el Estado y Greater Chicago Food Depository anunciaron una inversión de \$4 millones para dar más comidas a los que buscan asilo en los albergues de la Ciudad de Chicago hasta el fin de año. Los fondos se anunciaron mientras la Ciudad solucionaba



retrasos en su proceso de adquisiciones. El 15 de enero, la Ciudad asumirá la responsabilidad de alimentar a los solicitantes de asilo en los refugios de la Ciudad.

Se han enviado autobuses fuera de Chicago, a ciudades del Norte de Illinois, como Aurora y Elgin. El Estado se asoció con la Ciudad para dar guía a las municipalidades impactadas y apoyo en el transporte de los recién llegados a zonas de llegada en Chicago. El fin de semana del Año Nuevo, Texas envió un avión a Rockford con más de 350 recién llegados.

"En IDHS – tenemos un mensaje para todos los residentes de Illinois – no importa cuanto tiempo hayan vivido aquí: La ayuda está aquí. Tomamos ese mensaje muy en serio y estamos en primera línea para brindar servicios integrales y apoyo a nuestros recién llegados", dijo Dulce M. Quintero, Secretaria Designada del IDHS.

Attorney General Raoul Urges Illinois Residents to Be Alert for Phone Scammers

Attorney General Kwame Raoul urged Illinois residents to be aware of phone scammers potentially using Artificial Intelligence (AI) to mimic the voice of a loved one. Scammers have long used the ploy of claiming a loved one is in trouble to convince targets to send a payment or share personal information. In a new and unnerving twist on this scam, criminals are using AI technology to mimic the voice of a target's family

entities already have your information and don't need you to provide it. If they are legitimate, they have specific and familiar ways to contact you or request payment.

 Scammers Want You to Pay in Unusual Ways. They may ask you to buy a gift card and read the numbers, wire money, set up a cryptocurrency account, or use a peer-topeer app to send money directly to them. Once you read the numbers from the



member, so it sounds like the person is calling seeking help. Attorney General Raoul identified some red flags consumers should be on the lookout for to avoid common scams:

•Scammers Come to You. They may send you an unsolicited email or text message, call you or knock on your door. Be wary if someone you didn't contact is reaching out to sell you something or asking for personal information.

•Scammers Pressure You to Act Quickly. Their goal is to get you to send payment before you get a chance to think about it or discuss it with a trusted family member or friend.

•Scammers Want Your Personal Information. They may claim to be the IRS, the Social Security Administration, the U.S. Postal Service, your electric provider, a bank, or anyone you might trust. If you are a customer, these

card, wire the money, or hit send on that peer-to-peer app, it is nearly impossible for you to get that money

New Year, New Laws: Giannoulias Initiated Laws Take Effect

Several new laws initiated by Illinois Secretary of State Alexi Giannoulias took effect on Monday. The initiatives were passed in 2023 by the Illinois General Assembly before being signed into law. In an effort to combat distracted driving, House Bill 2431 makes it illegal to Zoom, watch or stream videos, or access social media sites while driving. This legislation will ensure drivers keep their eyes and attention on the road, making Illinois roadways safer for all Illinois motorists. It is now easier for young Illinoisans to guarantee that they are eligible to vote when they turn 18. Under Senate Bill 2123, teens obtaining their driver's license or state ID card may register to vote at an Illinois Driver and Motor Vehicle (DMV) facility. This legislation increases voter participation and access, ensuring that young people have a voice on the issues that have a direct and tangible impact on their lives, especially student loan debt, the economy and education. Individuals seeking abortion care and undocumented immigrants will feel more at-ease while traveling on Illinois roads knowing that the use of automatic license plate readers (ALPRs) is now regulated in the state. House Bill 3326 prohibits the use of data collected with ALPRs to track innocent people or criminalize lawful behavior. While ALPRs can be a valuable tool for law enforcement, this regulation will prevent abuse, harassment and unlawful surveillance.

Roosevelt University Receives \$5M Grant to Expand STEM Doctoral Programs

Roosevelt University is proud to announce that it has received a nearly \$5 million grant to expand STEM education access to minority students. With these funds, the University will continue to expand educational and research opportunities to its diverse class of graduate students. Awarded by the U.S. Department of Education and given to only nine institutions nationwide, the grant is part of a national effort to assist historically underserved student populations pursue a career in STEM fields and improve graduation rates. Roosevelt is one of only three Hispanic-Serving Institutions (HSI) in the country out of over 500 to receive one of these very competitive grants, and the only one located in the Midwest. The University will use this grant to support PRIME (Producing Research and Innovation through a Mentoring Ecosystem), an initiative to make Roosevelt a Research 2 (high research activity) level institution and create more direct pathways for undergraduates to earn a doctorate degree. The funds will create doctoral programs for integrated biomedical sciences and information technology, and graduate programs for data science, information technology and biomedical sciences.
