Carillo, Black, Morgan, and Mudasar-Asghr families. "The plunge itself is so much fun, but what we are most proud of is that we can help families in need. I feel very lucky and honored that several times I have been able to give the first check to these families. They've cried and I have cried," said Marchal. "We feel so blessed that we are able to help them pay their bills, to help eliminate stress, we are lucky that we can do so." To date, CPBC has raised close to \$650,000 and has helped over 50 families since its inception. "When we first started we were raising \$5,000 to \$6,000 a year for our first few years. I am proud of what has become of the fundraising." Two of the four families that will benefit from this year's Annual Polar Plunge include: **The Carillo Family** Meet the Carillo Family: Victor, Karina, and their daughter, Arabella, are a loving family facing significant challenges. Arabella, born prematurely at 27 weeks, battles Bronchopulmonary Dysplasia and Tracheo Bronchomalacia, relying on a ventilator to breathe and requiring round-the-clock medical attention. Frequent hospital visits strain the family emotionally and financially, with both parents having to accompany her due to the inherent risks associated



with her conditions during travel.

If you are interested in participating in this year's polar plunge, but are nervous, Marchal offered up a few tips on how to have a successful first plunge. "There are a few things people can do to help prepare themselves for their first plunge.

If you can take a few cold showers that would help. It's all about acclimatizing the best you can before the event. If it's cold outside, walk down the street with your coat open. Really take it in and get used to that cold. Once you're down at the beach, it's about being safe. Everyone who participates must wear something on their feet. We tell people to make sure they have two towels, a towel to dry off with and a towel to stand on in case of snow. If you dry your hair and put a hat on, and dry off your feet and put socks on, to me that's the absolute key," said Marchal. "This is a great event, it's about community, everyone is there to have fun, and I think that's what makes the day special."

¿Estás listo para sumergerte en las aguas heladas del lago Michigan para una causa digna? El Chicago Polar Bear Club (CPBC) regresa para su 23.^a inmersión polar anual el sábado 27 de enero, donde cientos de almas valientes se reunirán en Oak Street Beach para pasar una tarde de diversión con otros buceadores. "Estamos muy emocionados; Creo que vamos a tener otro evento increíble y recaudar mucho dinero para cuatro familias que realmente lo merecen", dijo el fundador Brian Marchal. La Inmersión Polar Anual tiene una larga tradición de recaudación de fondos para beneficiar a las familias locales necesitadas; el primer evento de recaudación de fondos tuvo lugar en 2003, y este año CPBC pretende recaudar \$60,000 para apoyar a las familias locales de este año, los Carillo, Black, Morgan y Mudasar. -Familias Asghr. "La inmersión en sí es muy divertida, pero de lo que estamos más orgullosos es de que podemos ayudar a las familias necesitadas. Me siento muy afortunada y honrada de haber podido entregar varias veces el primer cheque a estas familias. Ellos han llorado y yo he llorado", dijo Marchal. "Nos sentimos muy bendecidos de poder ayudarlos a pagar sus cuentas y ayudarlos a eliminar el estrés; tenemos suerte de poder hacerlo". Hasta la fecha, CPBC ha recaudado cerca de \$650,000 y ha ayudado a más de 50 familias desde su inicio. "Cuando empezamos, recaudábamos entre 5,000 y 6,000 dólares al año durante los primeros años. Estoy orgulloso de lo que ha sido de la recaudación de fondos". Dos de las cuatro familias que se beneficiarán de la inmersión polar anual de este año incluyen:

Las visitas frecuentes al hospital ejercen presión emocional y financiera sobre la familia, y ambos padres tienen que acompañarla debido a los riesgos inherentes asociados con sus condiciones durante el viaje.

Le decimos a la gente que se asegure de tener dos toallas, una toalla para secarse y una toalla para pararse en caso de nieve. Si te secas el cabello y te pones un sombrero, te secas los pies y te pones calcetines, para mí esa es la clave absoluta", dijo Marchal. "Este es un gran evento, se trata de comunidad, todos están ahí para divertirse y creo que eso es lo que hace que el día sea especial". Property Owners Urged to Pay Late Taxes to Avoid Annual Tax Sale

Cook County property owners are running out of time to pay taxes that were due in 2022 and avoid the Annual Tax Sale. To find out if your property is on the Annual Tax Sale list:

- Go to cookcountytreasurer.com
- Use the purple box on the home page labeled “Your Property Tax Overview” and search using an address or Property Index Number (PIN)
- A banner with an urgent warning will appear if your property is on the Annual Tax Sale list. You may also use the website to correct your mailing address. Each year the U.S. Postal Service returns thousands of certified notices sent to owners of properties on the Annual Tax Sale list because property owners

have not kept their mailing addresses up to date. The Annual Tax Sale will occur through January 12th for properties with unpaid 2021 property taxes due in 2022. Delinquent tax bills will be re-offered for sale on Jan. 16. The Annual Tax Sale occurs 13 months after the due date. Payment can be made in five ways:

- Online for free at cookcountytreasurer.com
- In person at any Chase Bank location in Illinois.
- In person at any of more than 100 community banks where you have an account
- By mail
- In person at the Treasurer’s Office
