El Departamento de Ser-w vicios Humanos de Illinois (IDHS) anunció \$17 millones en fondos adicionales para que los municipios apoyen a los migrantes. Esto es en respuesta a los más de 38,000 recién llegados enviados a Illinois por Texas desde 2022. Estos fondos se utilizarán para crear recursos más sólidos con los municipios fuera de Chicago que están dando la bienvenida a inmigrantes. "Este nuevo financiamiento se basa en nuestro compromiso de apoyar a las ciudades de Illinois que están dando un paso adelante para ayudar a los solicitantes de asilo", dijo el Gobernador JB Pritzker. "A medida que continuamos pidiendo más apoyo federal, y mientras Illinois adopta una postura contra las formas insensibles en que el gobernador de Texas Abbott está utilizando a seres humanos como peones políticos, estas subvenciones brindarán apoyo donde sea necesario en todo el estado".

sión estatal adicional para apoyar la respuesta de los solicitantes de asilo. Los fondos permitirán que los municipios brinden servicios directos a los recién llegados que han huido de sus hogares para escapar de la violencia, la inestabilidad política y otras amenazas. Los fondos se utilizarán para necesidades de emergencia, como alimentos y ropa de invierno, así como para apoyo que oriente a los recién llegados en el camino hacia la independencia. La gran cantidad de servicios que cubrirá esta financiación incluye alojamiento temporal, clasificación de emergencia, gestión de casos, servicios legales, incluida la presentación de solicitudes de permiso de trabajo y estatus de protección temporal, exámenes de salud e inmunizaciones, servicios de interpretación y traducción, preparación para el lugar de trabajo, inscripción escolar, orientación básica. sobre opciones de autosuficiencia y estrategias sobre cómo volverse autosuficiente.

Otra ronda de fondos de Apoyo a Municipios para Servicios para Solicitantes de Asilo (SMASS), por un total de \$11 millones, estará disponible exclusivamente para municipios fuera de Chicago para dar la bienvenida y apoyar a los recién llegados que viven en sus comunidades. Los fondos deben usarse para apoyar a los solicitantes de asilo dentro del municipio solicitante y no pueden usarse para transportar a los recién llegados a otro municipio. De la inversión de \$17 millones, \$4 millones apoyarán 13 Centros de Bienvenida de Illinois, permitiéndoles ampliar servicios vitales, como administración de casos, intervención en crisis y orientación para residentes actuales y nuevos de Illinois. Además, \$2 millones se destinarán a proveedores del Programa de Recursos para Familias Inmigrantes (IFRP), para ofrecer apovo adicional para ayudar a satisfacer las necesidades existentes y desarrollar capacidad para necesidades futuras. announced \$17 million in additional funding for municipalities to support migrants. This is in response to the more than 38.000 new arrivals sent to Illinois by Texas since 2022. These funds will be used to build stronger resources with municipalities outside of Chicago that are welcoming migrants. "This new funding builds on our commitment to support Illinois cities that are stepping up to help asylum seekers," said Governor JB Pritzker. "As we continue to call for further federal support, and as Illinois takes a stand against the callous ways Texas Gov. Abbott is using human beings as political pawns, these grants will lend support where it is needed throughout the state."

The funds will come from the previously announced \$160 million in additional State investment to support the asylum seeker response. Funds will make it possible for municipalities to provide direct services to new arrivals who have fled their homes to escape violence, political instability, and other threats. The funds will be used for emergency needs - such as food and winter clothing – as well as supports that guide new arrivals on the path to independence. The plethora of services this funding will cover includes temporary shelter, emergency triage, case management, legal services - including work-permit and temporary protective status application submission, health screenings and immunizations, interpretation and translation services, workplace readiness, school enrollment, basic orientation on selfsufficiency options, and strategies on how to become self-sufficient.

Another round of Supporting Municipalities for Asylum Seeker Services (SMASS) funds, totaling \$11 million, will be available exclusively to municipalities outside of

Chicago to welcome and support recent arrivals living in their communities. Funds must be used to support asylum seekers within the applicant municipality and cannot be used to transport new arrivals to another municipality.

Of the \$17 million investment, \$4 million will support 13 Illinois Welcoming Centers, allowing them to expand vital services, like case

management, crisis intervention, and guidance to current and new resident of Illinois. In addition, \$2 million will go to Immigrant Family Resources Program (IFRP) providers - to offer additional support in helping meet existing needs and building capacity for future needs. IFRP partner organizations provide new arrivals with interpretation and translation services, information about public benefits, and advocacy as they settle into their new communities.

"We at the Illinois

Department of Human Services are so grateful for the ongoing work being done in local communities throughout the state to support immigrants and help them be self-sufficient," said Dulce M. Quintero, IDHS

# Little Village Shelter for Asylum Seekers Begins Accepting Families

shelter is beginning to serve asylum seekers in Chicago. The location is the site of a former CVS in the Little Village neighborhood. The shelter will be part of the City of Chicago's existing asylum seeker shelter system and will house approximately 220 people as they transition to independent living. The shelter development is part of Governor JB Pritzker's investment of an additional \$160 million, via the Illinois Department of Human Services (IDHS), to address the ongoing humanitarian crisis presented by the arrival of over 34,000 asylum seekers from the U.S. southern border. The



State saw an uptick of new arrivals over the holidays and created a temporary shelter at a Chicago hotel. Those new arrivals are now transitioning to the shelter in Little Village.

With the cold weather

and continued arrival of asylum seekers, the State is committed to partnering with the City of Chicago to take the necessary actions to keep people safe and help them on their path to self-sufficiency. "This new location will offer dignity and respite to asylum seekers who have travelled thousands of miles to find safety," said Governor JB Pritzker. Available beds at the Little Village shelter will be prioritized for families and individuals with disabilities. The site will offer sleeping spaces as well as meals, hygiene facilities, and wrap-around services. Along with IDHS and its partners, New Life Centers is supporting communitycare services including conflict resolution, onsite communications, community engagement, and connection with local resources. "A large part of meeting our new arrivals with dignity involves meeting them where they are at – and that involves a variety of supports. Traveling great distances and overcoming adversity to make it to the U.S. often involves trauma, which can be detrimental to mental and physical well-being," said Matt DeMateo, Executive Director, New Life Centers of Chicagoland.

# El Refugio Little Village para Solicitantes de Asilo Comienza a Aceptar Familias

Un nuevo refugio financiado por el Estado está comenzando a atender a los solicitantes de asilo en Chicago. La ubicación es el sitio de un antiguo CVS en el vecindario Little Village. El refugio será parte del sistema de refugios para solicitantes de asilo existente en la ciudad de Chicago y albergará a aproximadamente 220 personas en su transición a una vida independiente. El desarrollo del refugio es parte de la inversión adicional de \$160 millones del Gobernador JB

a las personas seguras y ayudarlas en su camino hacia la autosuficiencia. "Esta nueva ubicación ofrecerá dignidad y respiro a los solicitantes de asilo que han viajado miles de kilómetros para encontrar seguridad", dijo el gobernador JB Pritzker. Se dará prioridad a las camas disponibles en el refugio de La Villita para familias e individuos con discapacidades. El sitio ofrecerá espacios para dormir, así como comidas, instalaciones de higiene y servicios integrales. Junto



The State of Illinois is recognizing Human Trafficking Awareness Day, part of the larger Human Trafficking Awareness Month, in an effort to raise awareness about one of the most under-reported and underidentified crimes. Human trafficking involves the use of force, fraud, or coercion to control another person for labor or commercial sex act purposes. Every year millions of men, women, and children are trafficked worldwide, including in the United States and in Illinois. Signs a person is being subjected to human trafficking may include:

- Disconnected family, friends, community organization, or houses of worship
- •A sudden or dramatic change in behavior
- •Being disoriented or



confused, or signs of mental or physical abuse Youth engaged

- commercial sex acts •Child has stopped attending school
- •Fearful, timid, submissive behavior
- •Indications the person is being denied food, water,

sleep, or medical care

- •Defers to someone they are with or appear to be controlled by another person
- •No freedom of movement – where they live or where they go
- •Unsuitable or unstable living conditions






