# Pappas Urges Property Owners to Pay First Installment Tax Bills by Friday, March 1 Due Date

First Installment Tax 2023 property Year taxes are due Friday, March 1, Cook County Treasurer Maria Pappas reminded taxpayers. The Treasurer's Office nearly posted 1.8 million bills online at cookcountvtreasurer.com in early December and mailed printed bills to taxpayers in late January. "If you don't pay your taxes by the due date you end up paying more because of the interest penalty," Pappas said. "This is the first tax bill that reflects how we succeeded in slashing the interest rate in half. But

the best thing to do is to pay your taxes on time." The Treasurer's Office accepts partial payments from those unable to pay the full amount. After March 1, any balance due is charged 0.75 percent per month, as required by state law. Illinois lawmakers in 2023 approved historic reforms championed by Pappas that reduced the interest rate penalty from 1.5 percent to 0.75 per month, or from 18 percent to 9 percent annually. # Governor Pritzker Celebrates State-of-the-Art Advanced Manufacturing Training Center at Heartland College



Governor JB Pritzker and the Illinois Department of Commerce Economic Opportunity (DCEO) joined Heartland Community College to celebrate the ribbon cutting of its new state-of-the-art Advanced Manufacturing Training Center. Funded in part by a \$7.5 million capital grant as part of the state's larger \$15 million manufacturing training academy investment, the electric vehicle manufacturing training facility prepares students to meet the growing needs of the Illinois' expanding EV industry.

Heartland's electric vehicle manufacturing program – which launched at a temporary site in August 2021 – provides students with training, certificates, and degrees in Electric Vehicle (EV) and Energy Storage (ES) Technology. The program also provides intensive upskill Electric Vehicle Technology Certificates for individuals with prior traditional automotive training and experience. The new 45,000-squarefoot state-of-the-art facility supported approximately 200 construction jobs. The facility incorporates

remodeled space to further support programs such as robotics, HVAC, welding, and digital media, in addition to the newly constructed State Farm EV Lab. The training exemplifies program between partnership regional businesses, and local economic development organizations, and education partners creating a true ecosystem designed to provide training in areas that grow our workforce and meet the needs of area industries, such as EV manufacturer Rivian.

## City of Chicago Sues Oil, Gas Companies for Climate Deception

City of Chicago announced that the City of Chicago is suing six oil and gas corporations and their largest trade association for deceiving Chicago consumers about the climate dangers associated with their products. Filed in the Circuit Court of Cook County, the complaint names BP, Chevron, ConocoPhillips, Exxon Mobil, Phillips 66, Shell, and the American Petroleum Institute as Defendants. The complaint details the history of Defendants' knowledge and deception around their products' role in causing climate change and alleges ten separate causes of action, including: Failure to Warn, Negligence, Public Nuisance, Civil Conspiracy, Unjust Enrichment, and violations of Chicago's municipal codes concerning Consumer Fraud and Misrepresentations



Connection with Sale or Advertisement of Merchandise. The nearly 200-page complaint details a myriad of climate changerelated damages Chicago has incurred, and will continue to incur, because of Defendants' conduct. It seeks relief in the form of compensatory and loss-of-use damages, penalties

and fines for statutory violations, disgorgement of profits, and enjoining the Defendants from engaging in the deceptive and unfair acts and practices alleged in the lawsuit, as well as associated fees, interest, and other relief as deemed appropriate by the jury at trial.

# State of Illinois Fiscal Year 2025 Budget | Observe the Partial Solar Eclipse at **Makes Investments in Higher Education**

Higher education leaders across the state applauded Governor JB Pritzker's budget announcement, which includes a fiscal year 2025 higher education budget of \$2.55 billion. The budget includes a \$10 million increase for the Monetary Award Program (MAP), a \$24.6 million increase for public universities, and a \$5.9 million increase for community colleges. The governor's budget an increase of \$10 million for the Monetary Award Program (MAP), bringing the total MAP appropriation to \$711 million. This supports the goal of increasing funding for MAP to \$1 billion within 10 years as set out in



the strategic plan for higher education in 2021. From 2019 to the fiscal year 2025 additional proposed funding for MAP, the governor has championed a 77 percent increase in MAP. The historic increases in MAP over the last five years have made significant inroads in affordability, increasing the size and expanding the number of grants for students from low-income households

statewide. Highlights include:

•\$10 million increase for MAP

•\$24.6 million (2 percent) increase for public universities general operations

•\$5.9 million (2 percent) increase for community colleges

•\$940,000 (3.8 percent) increase for the Illinois Mathematics and Science Academy

# Triton College Earth and Space Center

Prepare to experience one of nature's greatest spectacles on Monday, April 8, 2024, when a total solar eclipse will sweep across the continental United States. totality will not be visible from the Chicago area, Triton College's Cernan Earth and Space Center is hosting an event to safely observe 93 percent of the sun eclipsed, weather permitting. A total solar eclipse happens when the moon passes between the sun and Earth, completely blocking the face of the sun, according to Kris McCall, director of Triton's Cernan Center. After this year, "the next total solar eclipse to cross the United States will not be until 2045," added McCall. "We want everyone to witness this eclipse in 2024 instead



of waiting 21 years for your next opportunity." In preparation for the 2024 Triton College's Cernan Earth Center will feature the show, ECLIPSE: The Sun Revealed, in its Planetarium starting March 1, 2024. This dramatic program explores the history and cultural views of eclipses,
