Back of the Yards Holds Vigil Following Tragic Shooting

Following Saturday's Back of the Yards shooting that left 10 wounded and 9-year-old Ariana Molina dead, dozens of mourners took to the streets of Back of the Yards on Monday afternoon to speak out against the increase in gun

and was open to the public. "We are here to serve all the victims of gun violence," Glen Brooks, director of community policing for the Chicago Police Department, said at a news conference Tuesday morning. "You do not need a police report in order to get these services. All of

Back of the Yards Realiza Vigilia Tras Trágico Tiroteo

Tras el tiroteo del sábado en Back of the Yards que dejó a 10 personas heridas y a la niña de 9 años, Ariana Molina, muerta, docena de dolientes tomaron las calles de Back of the Yards el lunes por la tarde para hablar contra el aumento de la violencia de armas en Chicago.

En respuesta, la policía de Chicago y organizaciones comunitarias abrieron un centro de ayuda de emergencia cerca a la escena del tiroteo en el centro de Richard J. Daley Academy, 5024 S. Wolcott Ave. y fue abierto al público.

“Estamos aquí para servir a todas las víctimas de la violencia de armas”, dijo Glen Brooks, director de policía comunitaria del Departamento de Policía de Chicago, en una conferencia de prensa el martes por la mañana. “No se necesita un reporte de policía para tener estos servicios. Todos estos servicios son gratis. La meta aquí es empezar el viaje de sanación”. Hubo por lo menos 48 personas el fin de semana, incluyendo 11 tiroteos durante un solo ataque el sábado por la noche en el barrio de Back of the Yards.

Miembros de la familia estaban afuera en la cuadra 2000 de la Calle West 52, celebrando la confirmación de un pariente cuando un pistolero abrió fuego, matando a la niña de 9 años, Ariana Molina. Tres otros niños y siete adultos fueron heridos. Un niño de 1 año y otro de 7 años recibieron múltiples balazos y estaban en condición crítica el sábado por la noche. Un niño de 9 años sufrió un rozón en el dedo meñique izquierdo y estaba en buenas condiciones. Los oficiales dijeron que las edades de las víctimas van de 19 a 40 años – y la madre de Ariana fue una de ellas.

Tras el tiroteo, el Alcalde Brandon Johnson publicó una declaración sobre la tragedia. “Lamentamos la pérdida de la niña de 9 años cuya vida fue trágicamente truncada por la violencia de armas. Este acto atroz y cobarde de violencia sin sentido que deja a nuestra ciudad de luto por niños es más que reprensible y no tiene cabida en nuestras comunidades”, dijo el Alcalde Johnson. “Estoy rezando también por la recuperación de los tres niños y siete adultos que resultaron heridos en ese horrible tiroteo. La Oficina de Seguridad Comunitaria

de nuestro Alcalde ha estado en contacto con el Departamento de Policía de Chicago, quien está comprometido a identificar y aprehender a los individuos responsables”. Las organizaciones comunitarias están

ofreciendo ahora una recompensa de \$2,000 por información que conduzca a la resolución del caso. En el momento de esta publicación no se habían hecho arrestos en conexión con el tiroteo de Back of the Yards.

neighborhood.

Family members were outside, in the 2000 block of West 52nd Street, celebrating a relative's confirmation when gunmen opened fire, killing 9-year-old Ariana Molina. Three other children and seven adults were also wounded. A 1-year-old boy and a 7-year-old boy were each shot multiple times and were in critical condition Saturday night. A 9-year-old boy suffered a graze wound to his left pinky finger and was in good condition. Officials said the ages of the adult victims ranged from 19 to 40 — and Ariana's mother was

one of them.

Following the shooting, Mayor Brandon Johnson released a statement addressing the tragedy. “We mourn the loss of a 9-year-old girl whose life was tragically taken from her by gang violence. This heinous and cowardly act of wanton violence that leaves our city mourning children is beyond reprehensible and has no place in our communities,” said Mayor Johnson. “I am also praying for the recovery of the three children and seven adults who were injured in this horrific shooting. Our Mayor's Office of Community Safety has been in contact with the Chicago Police Department, which is committed to identifying and apprehending the individuals responsible.” Community organizations are now offering a \$2,000 reward for information leading to the case being solved. At the time of publishing, no arrests have been made in connection with the Back of the Yards shooting.

Clothing Swap:

Cicero Health Department Warns Residents of Possible Measles Infection

The Cook County Department of Public Health has released the second confirmed case of measles in Cook County. The location of the measles case, while infectious, was at the Super Mercado Torres at 5310 W. 25th Street, Cicero, IL, 60804, between the dates of April 6th and April 10th, 2024. Anyone who has spent time at this location during the below dates and times may have been exposed to measles:

4/6/24: 7:00am - 4:00pm
 4/7/24: 12:00pm - 9:00pm
 4/9/24: 9:00am - 6:00pm
 4/10/24: 11:00am - 3:30pm

Symptoms of measles include: Rash, high fever (up to 104°F), cough, runny nose, and red- watery eyes. If infected, individuals may develop symptoms up to 21 days following exposure and become contagious to others starting four days before the rash appears



through four days after the rash has appeared. If you are unable to reach your healthcare provider, or you do not currently have one, you can reach out to the Cicero Health Department at 708-656-3600 x147, or Cook County Health at 833-308-1988. For more

Cualquiera que haya pasado un tiempo en ese lugar durante las fechas y horas a continuación, puede haber estado expuesto al sarampión:


4/6/24: 7:00 a.m. – 4:00 p.m.
 4/7/24: 12:00 p.m. – 9:00 p.m.
 4/9/24: 9:00 a.m. – 6:00 p.m.
 4/10/24: 11:00 a.m. – 3:30 p.m.

Los síntomas del sarampión incluyen: Erupción, fiebre alta (hasta de 104°F), tos, catarro, y ojos llorosos. Si una persona es contagiada, puede desarrollar los síntomas hasta 21 días después de haber estado expuesto y se vuelve contagioso a otros desde el cuarto día antes de que aparezca la erupción hasta cuatro días después de que la erupción apareció. Si no puede comunicarse con su médico o no tiene actualmente uno, puede llamar al Departamento de Salud de Cicero al 708-656-3600 x 147, o a Cook County Health al 833-308-1988. Sinai Chicago Receives Grant for Safe Sleep Program



For the second year, Sinai Community Institute (SCI) was awarded a \$150,000 grant from the Illinois Department of Public Health to expand education on safe sleep practices for infants. Legislators Introduce Bills to Combat HIV Epidemic in Illinois



Illinois legislators have introduced several key bills aimed at ending the state's HIV epidemic by 2030 this month. Senator Lakesia Collins and Representative Kelly Cassidy filed the Connection to HIV Testing and Linkage to Care Act (HIV TLC). Senator Mike Simmons and Representative Hoan Huynh concurrently introduced the Strengthening and Protecting the Illinois HIV Funding Infrastructure

bill (SPIHFI, pronounced "spiffy"). Supported by AIDS Foundation Chicago (AFC), the leading HIV advocacy organization in Illinois, both the HIV TLC bill and the SPIHFI bill recognize that ending the HIV epidemic is not only a public health imperative but also a critical step towards achieving health equity and racial justice. Below are key highlights from each proposed bill: **HB5417/SB3711:** The

Connection to HIV Testing and Linkage to Care Act (HIV TLC) Introduced by Rep. Cassidy and Sen. Collins, the HIV TLC bill contains provisions to mandate insurers and Medicaid cover home test kits for sexually transmitted infections including HIV without cost sharing, to create Rapid Start for HIV Treatment pilot sites, and to ensure the availability of HIV/AIDS education

in county jails. Justice-involved people incarcerated or in reentry are considered vulnerable to HIV.

HB 5667 / SB 3809: Strengthening and Protecting Illinois' HIV Funding Infrastructure Bill (SPIHFI) Introduced by Sen. Simmons and Rep. Huynh, this legislation will provide \$4.5 million in additional funds to support HIV education, prevention, testing, and treatment. These funds will also help launch eight Rapid Start for HIV Treatment pilot sites across the state. SPIHFI also maintains funding for the Getting to Zero Illinois (GTZ-IL) initiative, African American HIV/AIDS Response Fund, PrEP4Illinois program, and STI testing, treatment, and prevention. The Getting to Zero Illinois (GTZ-IL) plan brings together communities with lived experience, advocacy, academic, healthcare, and public health organizations to end the HIV epidemic in the state.

complete strict training and education requirements in order to serve as a stenographer, providing a level of certainty in their work which can be critical to the parties in court cases. Following pandemic-era restrictions and social distancing guidelines instituted in Illinois courtrooms, many courtrooms opted to use digital recording equipment in lieu of in-person stenographers. However, technology error, machine malfunctions and a lack of technical training means this digital

recording practice was unreliably communicating court information. In many cases, faulty equipment or incorrectly transcribed transcripts threatened the validity of court records used to determine criminal and civil outcomes. Hernandez's bill ensures in-person transcription continues while state officials establish concrete language on guidelines, rules and procedures for the future of the shorthand reporter industry. House Bill 4426 passed the House on Monday, April 15.
