## City Unveils 'A Safe Chicago for All' Initiative

The Chicago Department of Public Health in conjunction with the City of Chicago unveiled A Safe Chicago for All, a new initiative designed to provide Chicagoans with the tools and resources to "take action and increase community safety."

"Our work is based on the belief that a holistic approach to community safety which, rooted in collaboration across all sectors, is essential to eradicating centuries of racism and purposeful disinvestment and violence, so that together we can forge a path toward a safer, more equitable Chicago," said Garien Gatewood, Deputy Mayor for Community Safety. A Safe Chicago for All focuses on raising awareness about the root causes of violence and how equity is being integrated into the city's community safety efforts. It highlights innovative and evidencebased solutions, as well as the current efforts and investments made to increase safety.

"The launch of this initiative complements existing efforts to build a safer, healthier city for everyone," said Olusimbo 'Simbo' Ige, MD, MPH, and Commissioner of the Chicago Department of Public Health. "There is an 11.4-year gap between Black and white Chicagoans, and gun-

related homicide is the second largest contributor to this racial life expectancy gap. This is a call to action for all Chicagoans, regardless of your zip code, to play a role in community safety." According to the City of Chicago, the A Safe Chicago for All digital action hub will provide residents with information about victim services and street outreach programs funded by CDPH to support individuals at the highest risk of becoming victims or perpetrators. It offers a plethora of resources for community leaders and Chicago residents who want to learn more about promising community safety solutions and ways to advance health and racial equity. The hub features: •Community resource guides for various n e i g h b o r h o o d s •An Introductory Guide to City Services for those who want to learn how to access city resources and take an active role

•Suicide prevention trainings, mental health skills-building, harm reduction training, and more.

"A Safe Chicago for All is a city-wide initiative calling on partners and community-based organizations to work together for a safer, more peaceful Chicago," said Claudia Rangel, Violence Networks Prevention Manager, Enlace. # City Announces Extension of Free WIFI Access at Parks, Schools

City of Chicago recently announced the extension of Chicago Public Schools' (CPS) Chicago Connected program and the Chicago Park District's Citywide Broadband and Digital Equity.

"We're grateful for the generous support from Mayor Johnson and our many partners that is allowing our District to continue providing this critical resource to those families currently enrolled in Chicago Connected as well as our students temporary living situations," said CPS CEO Pedro Martinez. "This is what it looks like to break down barriers to education for those most in need. Internet service supports learning and parents' connection to our schools' faculty and leaders, paving the way for our students and families to succeed." Both programs are focused on extending free Internet access to disinvested communities, serving more than 40,000 CPS students and 60 parks across the South and West sides of the city.

In an effort to expand Wi-Fi services, the Chicago Park District launched the Citywide Broadband and Digital Equity Initiative to implement public Wi-Fi at 60 parks in South and West side neighborhoods. The new system makes free broadband access available to Park patrons and extends service beyond the perimeter of a park to the immediate community with antenna signals reaching 100-200 yards, according to CPS.

The Park District is currently in the first phase of installation, having completed indoor broadband improvements at 27 of 60 park fieldhouses. Beginning in the fall of



this year, the District will execute the second phase of the project, focused on outdoor areas of the parks. The third and final phase, scheduled to begin in winter 2025, will refresh existing Wi-Fi connectivity at 100 additional park locations. Park locations were selected based on a number of factors, including the prioritization of parks in South and West side communities with limited broadband access and locations with larger fieldhouses. A few of the park locations include, Humboldt Park, Austin

Town Hall, Douglas Park, Garfield, and Ogden Park. For the full list, visit www. chicago.gov.

The one-year extension of Chicago Connected will apply to all families who are already enrolled in the program. These families will automatically have their free Internet access extended through June 30, 2025. In addition, students in temporary living situations (STLS), including our new arrival families, may apply for enrollment in Chicago Connected through their schools.

# Aquino Leads New Law to Strengthen Medicaid System, Improve Reimbursement

reimbursement for critical health services supporting vulnerable children and families, thanks to a new law led by State Senator Omar Aquino aimed at strengthening the Medicaid system. The new law makes significant improvements to reimbursement rates and add-on payments to support the full spectrum of health care needs in Illinois, including increased funding for psychiatric care, skilled nursing facilities, children's community health centers, birth centers, prosthetics and orthotics, optometry services and safety net hospitals, which serve some of the state's most vulnerable populations. Further, the law takes a significant step toward reducing barriers to mental health treatment by eliminating prior authorization for medications used to treat serious mental health disorders. It also lifts up the work often taken for granted by unpaid




caregivers who care for those with disabilities in their family. The law provides that they can

### Illinois Winner Claims Mega Millions Jackpot

The lucky Illinois iLottery winner of the \$552 million Mega Millions jackpot has come forward to claim their epic prize. The winner, nicknamed "MEGA Millionaire," snagged the jackpot after playing the game online – making this the largest jackpot won through iLottery in U.S. history. "I was scrolling through my emails when I saw one from the Illinois Lottery saying to check my numbers because I won a prize," shared MEGA Millionaire, who has requested to remain anonymous. "In the past,

I've won \$2 here or \$5 there, so I assumed it would be similar." The lucky winner continued, "You can't imagine my shock and disbelief when I saw that I had won the jackpot amount of \$552 million. I actually quit the app and then signed back in to double check and make sure it was real. It was real alright but it still feels unreal!" The MEGA Millionaire matched all five numbers and the Mega Ball, 19-37-40-63-69-17, to win the jackpot in the June 4, 2024 Mega Millions drawing.

"I was raised by a single mom and throughout my childhood, she had to work two jobs to provide for our family, to put food on the table, and for us to get an education," expressed the grateful winner. "The day after I graduated from high school, I started working and I haven't stopped since." During the Mega Millions jackpot roll that started on March 26, nearly \$28 million in total ticket sales generated \$11 million for the Common School Fund to support K-12 education in Illinois.

A fiveminute video that captures Pappas' achievements and her desire to make a difference in the lives of others may be viewed on the Cook County Treasurer's Office's YouTube channel. Pappas, a Loyola alumna, is among dozens of esteemed academics, artists and civic leaders whose personal papers are housed in Lovola's Women and Leadership Archives. Members of the public may make an appointment to view the archives at Loyola's Lake


Shore Campus in Chicago. "I am honored and humbled to be part of such a prestigious collection," Pappas said. "The Women and Leadership Archives showcase the life work of many trailblazers."

The Pappas collection includes media records, photographs and videos of ethnic and cultural events and copies of multilingual brochures and other outreach materials that were created to help taxpayers understand the property tax system. Pappas was raised in West Virginia, where she earned degrees in sociology from West Liberty State College and in guidance and counseling from West Virginia University. When she moved to Chicago in the 1970s, she worked with public housing residents enrolled in a drug-abuse prevention program. She earned a doctorate in counseling and psychology from Loyola University of Chicago and a law degree from Chicago-Kent College of Law. Just as Pappas transformed her life from humble roots in rural Appalachia, she has transformed how the Cook County Treasurer's Office operates and serves taxpayers. She served as a Cook County Board commissioner from 1990 to 1998, when she was first elected Treasurer. Pappas prioritized creating a website, cookcountytreasurer.com that averages nearly a million visits per month so taxpayers can check their payments, search for refunds, see possible missing exemptions, and more.
