Since its inception in 1987, Lawndale Christian Community Church, currently Lawndale Christian Development

Corporation (LCDC), has been at the forefront of addressing social issues and building, eliminating disparities, and building community wealth. To celebrate the organization's

history, LCDC invites all to join them for the "Reawakening North Lawndale" Gala to mark the organization's 37 years of steadfast commitment to revitalizing the community.

"I am most excited to showcase the seeds we have been planting. We are in a moment of opportunity for North Lawndale; this event is a celebration of an opportunity and the work

we are putting in North Lawndale for the families of North Lawndale, for the people who are from North Lawndale who are moving back to North Lawndale. Trying to bring

certainty to the community during uncertain times but do that through a vision that is crafted by north Lawndale natives. So, it's just a celebration of community and community voices and the impact of our work," said Whitney Smith, deputy director and counsel for LCDC.

Throughout the LCDC history, it has grown the North Lawndale Homeowners Association. There are 250 people in the organization and it is made of people who live in North Lawndale and are part of other Homeowners Associations. That collective has been able to band together and get the city of Chicago to put \$2.2 million in the Chicago Public Library at Homan and 13th. It also has been able to get land for new single family homes in North Lawndale, which is part of the organization's mission to build 1,000 single family homes in the community.

Over the past few decades, LCDC has developed more than 200 units of affordable housing and overseen around \$120 million of residential and commercial redevelopment in North Lawndale, like building the Carole Robertson Center

## Illinois Lottery Awards Its First Multi-Millionaire of the Year

An Illinois Lottery player is starting off the new year strong. No, not with a New Year's resolution to hit the gym. The lucky player won a life-changing \$10,000,000 top prize with the Illinois Lottery's scratch-off game \$10 Million. The \$10 million winning scratch-off ticket was purchased at a Speedway gas station in South Elgin, located at 1775 North La Fox Street. This is also a big win for Speedway, as the South Elgin gas station will receive a selling bonus of one percent of the prize amount, or \$100,000. The game had three \$10 million top prizes. The first top prize was won by a lucky player who bought their



winning ticket at Casey's convenience store in Alton in May 2024. The second \$10,000,000 top prize was scooped up in November 2024, after a player bought their winning ticket at Jewel-Osco in Countryside. In 2024, more than 64 million Illinois Lottery winning scratch-off tickets

## New Pathways to Wellness Initiative Looks to Build Enrollment in Graduate Healthcare Programs



Empowering more students, particularly Latine students, to pursue advanced degrees in healthcare is the goal of a new academic initiative from Dominican University. As the recipient of a five-year, \$3 million grant from the federal Promoting Post-baccalaureate Opportunities for Hispanic Americans program, the university is building Pathways to Wellness, a program designed to create new graduate degrees and new post-baccalaureate certificates, better

support graduate students holistically and financially, and increase graduate enrollment and degree completion in Dominican's Borra College of Health Sciences. The Pathways to Wellness program includes the following:

- the design of a new Master of Science in Mental Health Counseling degree to address regional inequities within this field, and the redesign of the university's Master of Health Sciences degree to create a more accessible path to advanced healthcare

programs and careers.

- development of post-baccalaureate certificates for high-demand careers in certified drug and alcohol abuse counseling and lab technology. These certificates will be stackable toward the completion of a master's degree.

- improvement of graduate program support services, including mental health services, academic supports, scholarships, emergency aid, and testing and licensure fees.

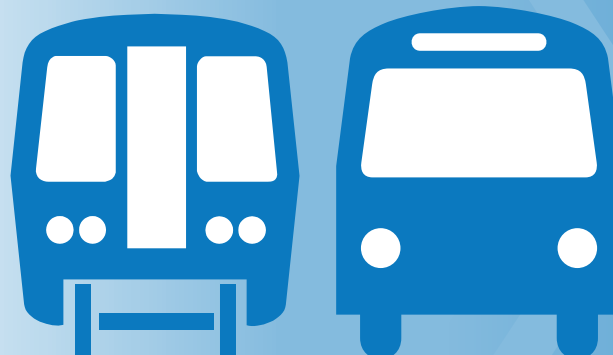

## Illinois DCFS Offers Post-Secondary Scholarships to Current and Former Youth in Care



The Illinois Department of Children and Family Services (DCFS) is currently accepting applications for the 2025 DCFS Scholarship Program. Through the program, a minimum of 53 academic scholarships will be awarded to current and former youth in care for the upcoming school year, with four awards reserved for the children of veterans and two awards

presented to students pursuing degrees in social work in honor of Pamela Knight and Deidre Silas, two DCFS caseworkers who succumbed to injuries sustained in the line of duty. Scholarship recipients receive up to five consecutive years of tuition and academic fee waivers if they attend an Illinois public university or community college including a monthly

grant of \$1,577 to offset other expenses and a medical card. The DCFS Scholarship Program is available to youth who have an open DCFS case, whose cases were closed through adoption or guardianship or who aged out of care at 18 or older. Applications are available online at <https://apply.mykaleidoscope.com/program/ILDCFS2025>. Students are encouraged to submit their applications in advance of the March 31 deadline. ## City of Chicago Announces 100 Percent Renewable Energy Milestone

Mayor Brandon Johnson, the Department of Environment (DOE), and the Department of Fleet and Facility Management (2FM) announced that the City has achieved its goal of transitioning all City facilities and operations to 100 percent renewable energy. With this step, Chicago becomes one of the largest cities in the U.S. sourcing the power for its operations with renewable energy. This milestone was officially

reached on January 1, 2025, following several years of collaboration between the City, nonprofit partner Elevate, retail electricity supplier Constellation, and Swift Current Energy. The project fulfills a long-term advocacy campaign, Ready for 100, led by Sierra Club and local community organizations, to encourage the City to make the transition to renewable energy. As part of the City's energy supply agreement with

Constellation, 70 percent of Chicago's renewable energy will come from Double Black Diamond, a new, 593-megawatt solar generation installation developed by Swift Current Energy in downstate Sangamon and Morgan counties. The remaining 30 percent will come from purchased renewable energy credits. and local Lou Malnati's. In August, LCDC celebrated the renovated Lazarus Apartments, 48-unit affordable rental housing development in the North Lawndale neighborhood. The Lazarus Apartments offers 1, 2, and 3-bedroom units, including accessible and adaptable options, with rents ranging from \$700 for a one-bedroom to \$1,100 for a three-bedroom. The project was supported by the City of Chicago, the Illinois Housing Development Authority, Chase Bank, the Steans Family Foundation and the Pritzker Foundation.

"From a personal standpoint it represents the acknowledgment of all that has happened in and to North Lawndale. It represents the journey and the moment of history when

Dr. Martin Luther King, Jr., identified North Lawndale as the place where he needed to be. He didn't come here because North Lawndale was so great, and it would be a comfortable place for him to have his family. Where he could have his family. He came to North Lawndale because he knew it was the place he absolutely needed to be to fight slum housing and wage his poor people's campaign. The story arc of the neighborhood is such that our journey to thriving, which is where we are hoping to arrive to has been a long one. So "reawakening" is that spark; that seed planted like we have been doing over the course of a year to push us forward. To really begin to blossom and produce in a way that the community

needs to begin to thrive," said Smith. LCDC offers a homebuyer education course that educates people on the process of becoming a homeowner. There is also a financial coach to help people repair and improve their credit while they are on the path to homeownership. ## New Laws, Rules Impacting Public Health to Take Effect in 2025

The Illinois Department of Public Health (IDPH) announced that a number of new laws and rules designed to strengthen the public health system will go into effect on New Year's Day, January 1, 2025. One of the key changes taking effect with the new year is a more stringent standard for public health intervention based on the results of testing of blood lead levels in children. Under Illinois law, any child residing in a high-risk ZIP code is to be tested automatically at 12, 24, and 36 months, and all children six years of age and younger are required to be assessed for lead exposure through a questionnaire administered by a pediatrician. Other key laws taking effect in the New Year include:

- SB 3115, sponsored by Sen. Julie Morrison and Rep. Anna Moeller. Requires that when a nursing home undergoes



a change of ownership, the new owner and prior owner must work together to develop and submit a plan of care for residents.

- HB 5429, sponsored by Rep. Camille Lilly and Sen. Laura Fine. Requires assisted living facilities to submit plans for construction or major renovations for approval by IDPH prior to commencing construction.
- HB 3521, sponsored by Rep. Kelly Cassidy and Sen. Karina Villa. Provides that the reporting requirements that apply to hospitals for cases of patient abuse by staff also apply to clinics or other health care providers affiliated with hospitals.
- HB 4667, sponsored by Rep. Anna Moeller

and Sen. Cristina Castro. Imposes new inspection requirements for mobile home parks and changes the fees for licensing mobile home parks.

- SB 2662, sponsored by Sen. Julie Morrison and Rep. Camille Lilly. Prohibits advertising or promoting electronic cigarettes that are designed to fool parents, guardians, teachers, or others into believing that the device is not a tobacco product.
- SB 3350, sponsored by Sen. Laura Ellman and Rep. Tony McCombie. Expands availability and distribution of free fentanyl test strips to help people detect the presence of the dangerous opioid before consuming substances.
