The International Latino Cultural Center of Chicago Announces First Concert of Their 2025 Latino Music Series

A pianist since the age of four, Heloisa Fernandes made her international debut to critical acclaim at Spoleto Festival USA in Charleston, South Carolina in 2008, three years after releasing her debut album *Fruto* which featured her own compositions and unique arrangements of works by Pixinguinha and Caetano Veloso. The idea for her third album was born in Chicago: specifically, with a Fazioli on the stage of PianoForte Studios in Chicago where she performed in 2014. The invitation to record a new album using this piano almost didn't happen after she fell gravely ill. Once she recovered, Fernandes wanted the album, entitled *Faces* and released in 2016, to have the edge and risk-taking of an improvised concert, to be thoroughly in the moment. Strong and original, ancient and modern, Fernandes' sublime creations blossom with rhythmic vitality and melodic delicacy. With her skill as an improviser, she searches for the music's emotional depths and soars with joy. She will conclude her Chicago stop with three days of



recording at PianoForte for her new solo album. Admission: \$30, general; \$25, ILCC members. For more information, visit

Chicago Public Schools Awarded Federal Grant for Personalized Learning

Four magnet cluster schools across Chicago Public Schools (CPS) are gearing up to adopt a new learning model that positions students at the center of designing their education. The schools recently received a five-year, \$15 million Magnet Schools Assistance Program (MSAP) grant from the United States Department of Education to become exemplar personalized learning schools. Personalized learning is an instructional model that allows students to play an active role with their teachers in co-designing their learning path, pace, and environment based on their individual strengths, needs, and interests. The model presents an exciting

opportunity for students and families as authentic connections are made to connect learning to their communities and outside the classroom. The four schools – Avalon Park Elementary School, Milton Brunson Math & Science Specialty Elementary School, Rudyard Kipling Elementary School, and Logan Square Elementary School – will join 13 personalized learning schools across the District. Implementation begins

at the start of School Year 2025-26 and will continue through School Year 2028-29. Funding will help schools provide professional development to help create best practices and shift classrooms into the personalized learning model. Some schools may incorporate new positions as well as technology, and create or build on community partnerships for enrichment opportunities such as field trips and after-school programming.

IEMA-OHS Encourages Testing During Radon Action Month

With no scent, color, or taste, radon is a stealthy killer. In fact, it's the second leading cause of lung cancer in the U.S. "January is National Radon Action Month and a good opportunity to learn about this gas," explained Illinois Emergency Management Agency and Office of Homeland Security (IEMA-OHS) Director

Alicia Tate-Nadeau. Radon test kits can be purchased by calling the Illinois Radon Hotline at 800-325-1245 or at most hardware and department stores. It is recommended to conduct one short-term test and one long-term test to ensure consistent readings. Should you find higher readings, you should contact IEMA-OHS at 800-

325-1245 for information about a licensed mitigation professional who are trained to reduce radon levels. "Enero es el Mes Nacional de Acción contra el Radón y una buena oportunidad para aprender sobre este gas", explicó Alicia Tate-Nadeau, directora de la Agencia de Gestión de Emergencias de Illinois y la Oficina de Seguridad Nacional (IEMA-

OHS). Los kits de prueba de radón se pueden comprar llamando a la línea directa de radón de Illinois al 800-325-1245 o en la mayoría de las ferreterías y tiendas departamentales. Se recomienda realizar una prueba a corto plazo y una prueba a largo plazo para garantizar lecturas consistentes. Si encuentra lecturas más altas, debe comunicarse con IEMA-OHS al 800-325-1245 para obtener

información sobre un profesional de mitigación autorizado que esté capacitado para reducir los niveles de radón. To be recognized as American Humane Certified, the Forest Preserves of Cook County passed a rigorous independent assessment that reviewed the wellbeing of animals in their care. The unique process is guided by the latest science and best practices and is informed by respected veterinarians and experts in the fields of animal welfare, animal science, zoology and ethics who have decades of experience in protecting animals. The independent



validation process provides visitors with confidence that the institution is meeting a high benchmark of care. The process includes submission of a pre-audit application, followed by an onsite audit that assesses animal welfare. Factors considered during the audit include, but are not limited to, housing, food, water, lighting, shade, sound, activity levels, and

the training of staff who are interacting with the animals. The benchmarks are species specific. The American Humane Certified™ program is the first certification effort solely dedicated to helping verify the welfare and humane treatment of animals living in zoos, aquariums and conservation centers across the globe.

Gov. Pritzker Announces Launch of BEACON Children's Behavioral Health Portal

Governor JB Pritzker and the Illinois Children's Behavioral Health Transformation Initiative (CBHTI) announced the public launch of the BEACON (Behavioral Health Care and Ongoing Navigation) care portal, a centralized resource for Illinois youth and families seeking youth mental health

services and care, including state agency support and community-based programs. BEACON is now live for use by Illinois residents and can be accessed at beacon.illinois.gov. In the portal, parents and caregivers can learn which community-based resources are available nearby and which state-funded programs youth

may be eligible for. These programs might include outpatient counseling, school-based services, wraparound services to help support families caring for youth with complex needs, or residential treatment services. BEACON also provides assistance in organizing information about a child's care and connecting families with the services, including communication with state agency representatives. BEACON provides Illinois families with information about available behavioral health services for children and adolescents, centralizing resources from the following agencies:

- Illinois Department of Human Services (DHS)
- Illinois Department of Children and Family Services (DCFS)
- Illinois State Board of Education (ISBE)
- Illinois Department of


