Windy City Drops Road Matchup to Long Island

The Windy City Bulls, presented by BMO, the NBA G League affiliate of the Chicago Bulls, dropped a 92-110 road matchup to Long Island on Wednesday night. Chicago Bulls two-way forward Emanuel Miller recorded a game-high 24 points, knocking down nine shots. Windy City center David Muoka added 16 points and eight rebounds in the contest. Guard Jordan Jackson ended with 13 points, while guard Marcus Domask tallied 12 points,

nine assists, and seven rebounds. Domask also made an impact on the defensive end, garnering four steals and two blocks. Long Island opened the contest with a six-point advantage after the first quarter as guard Killian Hayes led all scorers with eight points. The Nets extended their lead to 11 by halftime, shooting over 55% in the second frame. Long Island pulled away in the second half thanks to eight steals, three by Hayes, and 13 Bulls turnovers for

23 Nets points. Hayes topped Long Island with 20 points and eight assists. Nets forward Trevon Scott (16 points, 10 rebounds) and center Drew Timme (18 points, 10 rebounds) each posted double-doubles. Scott led all players with three blocks in the matchup. Windy City now sits at 5-7 with the loss. Long Island grabs its third straight win, improving to 5-4. Windy City stays on the road and travels to play Wisconsin on Sunday. Tipoff is slated for 5pm and the game will be broadcast on NBA TV.

Jordan Jackson terminó con 13 puntos, mientras el guarda Marcus Domask anotó 12 puntos, nueve asistencias y siete rebotes. Domask también tuvo un impacto en la defensa, consiguiendo cuatro robos y dos bloqueos. Long Island abrió el partido con una ventaja de seis puntos después del primer cuarto, cuando el escolta Killian Hayes lideró a todos los anotadores con ocho puntos. 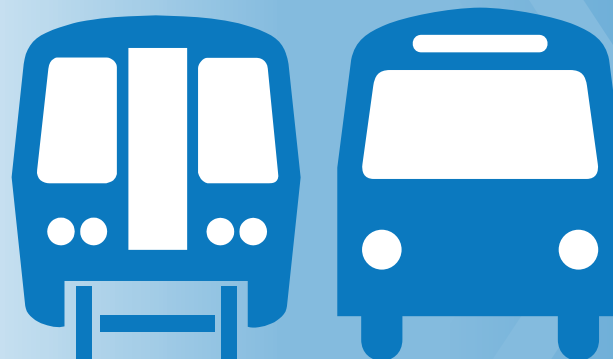

Money Launderer for Chicago-Based Drug Trafficking Organization Sentenced to More Than Eight Years in Federal Prison

CHICAGO — A money launderer for a Chicago-based drug trafficking organization has been sentenced to more than eight years in federal prison. COSME CHACON, 55, pleaded guilty in 2023 to a money laundering conspiracy charge. U.S. District Judge John J. Tharp, Jr. imposed a 100-month prison sentence during a hearing on Tuesday in federal court in Chicago.

Chacon was among four defendants indicted in Chicago in 2007. The defendants participated in a drug trafficking organization that transported heroin to Chicago from New York, Florida, and Texas. After the drugs were sold in the Chicago area, Chacon laundered the illicit proceeds through wire transfers to Colombia and other overseas locations. Chacon's three co-defendants pleaded guilty and were sentenced to federal prison terms of 16 years, 12 years, and one year.

Chacon was free on bond in 2009 when he failed to appear for status hearings in the weeks leading up to his scheduled trial. Chacon remained a fugitive until 2022, when he was arrested in Panama and returned to the United States.

The sentence was announced by Morris Pasqual, Acting United States Attorney for the Northern District of Il-



linois, Sean Fitzgerald, Special Agent-in-Charge of the Chicago office of Homeland Security Investigations, and Ramsey E. Covington, Acting Special Agent-in-Charge of IRS Criminal Investigation Chicago Field Office. Assistant U.S. Attorney Brian F. Williamson represented the government.

Valuable assistance in

securing Chacon's arrest and return to the U.S. was provided by IRS Criminal Investigation Panama City, the U.S. Department of State's Diplomatic Security Service, the U.S. Marshals Service, and the Justice Department's Office of International Affairs.

This case was part of an Organized Crime Drug Enforcement Task Forces

investigation. OCDEF identifies, disrupts, and dismantles drug traffickers, money launderers, and other alleged criminal offenders that threaten the United States by using a prosecutor-led, intelligence-driven, multi-agency approach that leverages the strengths of federal, state, and local law enforcement agencies against alleged criminal networks.

Property Tax Pointers: Ten Must-Know Tips for Homeowners

As Cook County Treasurer, I've learned the property tax system can be confusing and intimidating. Whether you're a new or longtime homeowner, or a senior citizen, I understand your frustrations. To help, I've created 10 tips to better understand your property taxes.

1. Familiarize yourself with the Cook County Treasurer's Office Website

Visit cookcountytreasurer.com, your one-stop shop for all things related to property taxes. That's where you can pay online for free, change your name and address and find out if any money is owed to you. It's also where you can access and download your bills and review the tax history of your property going back 20 years.

2. Know Your PIN

Your 14-digit Property Identification Number or PIN is on your tax bill and property deed. It is unique to each of the 1.8 million properties in Cook County. You will need your PIN to pay your bill, so keep it handy!

3. Understand the Billing Cycle

Cook County property taxes are divided into two installments a year.

The first installment covers 55 percent of the previous year's tax bill and is typically due in early March. The second installment covers the balance of your bill and includes your exemptions. It's usually due around August 1.

4. Check for Refunds and Exemptions

My office has over \$150 million in unclaimed property tax refunds. Check cookcountytreasurer.com to see if you've overpaid in the past 20 years. You also want to make sure you apply for all your qualified exemptions. Homeowners, senior citizens and disabled persons and veterans may be eligible for missing exemptions going back five years. No third-party assistance is needed to apply for refunds or missing exemptions.

5. Keep Your Information Current

It's important to keep your information up to date to ensure that you receive your bill on time. If you moved or changed your name, please update your contact information at cookcountytreasurer.com.

6. Find 24/7 Support In Your Language

It's a priority for my office to reach people in their own language. That's why our phone system operates 24/7 in English, Spanish and Polish at (312)443-5100.

Our cookcountytreasurer.com website support pages can be translated into 248 languages. We also offer informational brochures that can be downloaded in English and 27 other languages.

7. Decide How You Want To Pay



You can pay online through your bank account for free. If you pay with a credit card, there's a 2.1 percent convenience fee. Payments are also accepted at nearly 400 Chase Bank branches in Illinois or 160 community banks across the region. You can pay by dropping your bill into the mail for the cost of a stamp. If you want a face-to-face encounter while paying, stop by our offices located on the first floor of the County building at 118 N. Clark St. in Chicago.

8. Determine If You Need A Payment Plan

If you get behind on your taxes, you can set up a payment plan. Do so by using our free Payment Plan Calculator at cookcountytreasurer.com. This online tool helps you set up biweekly or monthly payments. If you set up a payment plan and opt in, we'll send you reminders via email or text.

9. Monitor Your Mortgage Escrow Account

If your property taxes are paid through an escrow account, ensure timely and accurate payments are being made by regularly

checking on the account. Don't be afraid to contact your bank or mortgage company if payments are not being made.

10. See Where Your Money Goes

The first installment contains your taxing district debt and shows whether obligations to the school district, town, village or other taxing district are unfunded. The second installment has a taxing district breakdown that shows how much each agency is taxing your property and where those tax dollars are spent in your municipality. It also compares those numbers to the previous year. For a deeper dive, visit cookcountytreasurer.com to access studies on property tax topics like referendums and voter participation. Explore the "Pappas Studies" section and subscribe to the Pappas Portal for valuable updates. By following these tips, you'll be better equipped to navigate the Cook County property tax system and hopefully save some money.

Mayor Brandon Johnson to Testify Before Congress

On Monday Mayor Brandon Johnson was asked to appear before Congress next month to discuss the city's status as a sanctuary city. The House Committee on Oversight and Reform sent a formal letter to City Hall on Monday, requesting Johnson's participation in a February 11th public hearing on Capitol Hill. The letter cites concerns about the impact of sanctuary policies in Chicago and three other cities—New York, Boston, and Denver. It claims such policies fail to comply with federal law and suggests, "Citizens of all four cities have suffered due to sanctuary policies." Letters were also sent to the mayors of New York, Boston, and Denver.

Pennoyer School District 79 Celebrates Newly Upgraded Facilities with Ribbon Cutting Ceremony and Open House



Pennoyer School District 79 will host a ribbon cutting ceremony this evening to celebrate a new addition to the school as well as the tireless efforts of educators and the Pennoyer community members who made the critical upgrades possible. After four failed building bond referendum attempts, voters passed a \$9.7 million building bond referendum for District 79 during the April 2023 Consolidated Election. The first phase of the renovations is now complete. The voter-approved referendum helped fund a new, two-story addition to Pennoyer School, 5200 N. Cumberland Ave., which includes: three "learning hubs" or flexible spaces, a resource room for small groups or meetings, locker rooms, eight unisex bathrooms, an elevator (which the school did not originally have) a Spanish classroom, art room and

music rooms. The special education wing received accessibility and security upgrades and a new fire alarm system was installed throughout the entire building. "Pennoyer students deserve a world class education in first rate facilities. The Pennoyer Education Association (PEA) worked tirelessly alongside community members to inform voters on the upgrades our school desperately needed," PEA President Sarah Adkins said. "Since the referendum passed in 2023, we have seen amazing improvements that will benefit student safety and accessibility. None of this would have been possible without the advocacy of our educators and support from the Illinois Education Association." The ribbon-cutting ceremony and open house was held on Wednesday.
