Funcionarios locales tuvieron una conferencia de prensa el martes para advertir a los propietarios de negocios indocumentados que estén preparados en caso de

deportaciones las próximas semanas. El Congresista Jesús "Chuy" García. Pero, no todos los propietarios tienen plan de seguir con sus negocios si son deportados.

"Los negocios que están enfrentando esos retos van a continuar porque son resistentes como lo son todos los inmigrantes", dijo Raúl Raymundo , presidente y CEO de Resurrection Project. La Cámara Hispana y otros están ofreciendo programas gratuitos, brindando a los propietarios los medios de preparación en caso de ser deportados. Leaders Warn Undocumented Business Owners for Potential Deportations

Local officials held a press conference on Tuesday to warn undocumented business owners to be prepared in case of deportations in the coming weeks. Congressman Jesús "Chuy" García, State Representative Lisa Hernandez members of the Illinois Hispanic Chamber of Commerce gathered at La Parra Restaurant in Berwyn Tuesday morning in an effort to equip the undocumented of their rights and are protected from U.S. Immigration and Customs Enforcement.

"The work of educating our immigrant family members

neighbors has helped protect them from mass deportation efforts that strike at the very heart of our country's founding principles," Hernandez said. "But more has to be done to protect workers and immigrant owned businesses from raids to come. I'm proud to be partnering with the IHCC and our local small businesses to emphasize basic protective measures and the fundamental truth that America welcomes immigrants wanting a better life, not ripping parent from child." There are over 140,000 Hispanic businesses in Illinois. From the kitchen to the bar, immigrant business owners make up nearly a quarter of

almost \$3 billion into the economy, according to the Illinois Hispanic Chamber of Commerce. But, not all owners have plans to keep their businesses going if they are deported.



that are facing those challenges are going to continue because they are resilient like all immigrants are," said Raul Raymundo, president and CEO of the Resurrection Project. The Hispanic Chamber and others are offering a free program, providing owners with preparation tools in case they are deported. The tools are not just for owners living in the U.S. without legal permission, but also for owners with citizenship that employ those living in the U.S. without legal permission. With the weather feeling like -10° outside, an Illinois Lottery player skipped going to the store and purchased a Lotto ticket online instead – and won a cool \$1 million. The lucky player matched all six numbers in the Monday, Feb. 17 Lotto Million 1 drawing to score the \$1 million prize. The winning numbers for the Lotto Million 1 drawing were:

8-16-20-25-42-46. Already this year, more than 930,000 Lotto tickets have been sold, netting Illinois Lottery players more than \$14.7 million in prizes. Lotto is an Illinois-only game that is played three times a week on Monday, Thursday, and Saturday. The current Lotto jackpot is at \$2.6 million. As well as the regular drawing, Lotto offers two additional

drawings: Lotto Million 1 and Lotto Million 2. These are additional opportunities for players to match six numbers to win a \$1 million prize. A federal judge has sentenced a suburban Chicago man to more than five years in prison for fraudulently obtaining more than \$1.5 million in small business loans under the Coronavirus Aid, Relief, and Economic Security (CARES)

Act. Over a five-month period in 2021, FEROZ JALAL participated in a scheme to defraud banks and the U.S. Small Business Administration. The SBA's Paycheck Protection Program allowed qualifying small Continued on page 12

Governor Pritzker announced the 2025 recipients of the Order of Lincoln, the state's highest honor for professional achievement and public service. This year's Lincoln Laureates will be honored at the upcoming 61st Annual Convocation at 5:30 p.m. on May 3, 2025, at the Krannert Center for the Arts located on the campus of the University of Illinois at Urbana-Champaign.

Established in 1964, the Order of Lincoln recognizes individuals who have made remarkable contributions to the betterment of humanity in or on behalf of the State of Illinois. The six recipients join more than 350 distinguished Illinois residents who have joined the Order of Lincoln over the last five decades. One of the recipients included: Sandra Cisneros, poet, short story writer, novelist, and essayist whose work

explores the lives of the working-class. Her numerous awards include NEA fellowships in both poetry and fiction, the Texas Medal of the Arts, a MacArthur Fellowship, the PEN/Nabokov Award for Achievement in International Literature, the National Medal of Arts, the Ruth Lilly Poetry Prize, and the Ambassador Richard C. Holbrooke Distinguished Achievement Award from the Dayton Literary Peace

Prize Foundation. Her novel The House on Mango Street has sold over eight million copies, has been translated into over twenty-five languages, and is required reading in elementary, high school, and universities across the nation.

Apartment Fire/Explosion Probe Reveals Unidentified Body in Building Debris

Cicero Police and Fire Responded to an explosion at a building at 2214 Central Avenue and neighboring properties at 2212 Central Avenue, and 5604-06 West 22nd Place on Saturday at 5p.m. Originally, when police and fire spoke with family members in the apartment where it was believed the explosion occurred, they were informed that all of the members of the family had been outside of the

building. However, in the process of the investigation to determine the cause of the explosion, fire investigators discovered the remains of an individual who apparently died as a result of the fire/explosion. Family members had indicated they believe the individual had been outside of the premises.

The deceased individual has not yet been formally identified. A neighboring building was also damaged

by fire and there was minor damage to a third adjacent building. Police and Fire are investigating the cause of the explosion. The investigation continues. A total of 11 units and families were impacted. The 11 families are being assisted by the Town of Cicero Department of General Assistance, according to General Assistance Director Carolyn Arias. Ms. Arias said that the damage varied to the

apartments, with several experiencing broken doors and windows that must be repaired before some of the families can return. All of the families are being provided temporary housing by the Town of Cicero and aid agencies such as the Red Cross.

President Larry Dominick expressed condolences to the family Sunday and directed that a donation drive by organized to help the families replace property damaged by the explosion and fire. The drive is being coordinated by the Cicero Department of General Assistance and the Cicero Clergy Committee headed by **Business License Director**

Investigación Sobre el Incendio y la Explosión de un Apartamento Revela Cuerpo no Identificado Entre los Escombros del Edificio

La policía y los bomberos de Cicero respondieron a una explosión en un edificio en el 2214 Central Ave., propiedades vecinas en el 2212 Central Ave., y 5604-06 West 22nd Place el sábado, a las 5 p.m. Originalmente, cuando la policía y los bomberos hablaron con miembros de la familia en el apartamento donde se creía ocurrió la explosión, fueron informados de que todos los miembros de la familia estaban fuera del edificio. Sin embargo, en el

proceso de la investigación para determinar causa de la explosión, investigadores de los bomberos descubrieron los restos de una persona que aparentemente murió como resultado del fuego/ explosión. Los miembros de la familia habían indicado que creían que la persona estaba fuera del lugar.

El individuo muerto aún no ha sido formalmente identificado. Un edificio vecino resultó también dañado por el fuego y hubo un daño menor a un tercer

edificio advacente. La policía y los bomberos están investigando la causa de la explosión. La investigación continúa. Un total de 11 unidades y familias fueron impactadas. Las 11 familias están recibiendo ayuda del Departamento de Ayuda General del Municipio de Cicero, de acuerdo a la Directora de Ayuda General, Carolyn Arias. La Srta. Assessor Kaegi Announces Property Tax Relief Bill for Hard-hit Homeowners

Cook County Assessor Fritz Kaegi announced the filing of a new bill in the Illinois Legislature aimed at providing property tax relief for struggling homeowners in Cook County. The Circuit Breaker Property Tax Relief Act was filed in the Illinois Senate as SB1978 by Sen. Patrick Joyce (D-40th) and in the House as HB3808 by Rep. Justin Slaughter (D-27). This program is designed to help homeowners who have seen their tax bills spike by 25 percent or more from one year to the next. Credits given to homeowners would cover up to half of the tax bill increase. The typical residential bill increased by nearly 20 percent, or about \$1,000, according to an analysis from the

Cook County Treasurer's Office. Circuit breaker programs are common across the country – 29 other states, as well as the District of Columbia, already have them on the books. Illinois has previously had a similar program in place for senior citizens. The relief program would apply to homeowners in the south and west suburbs, as well

as all other parts of Cook County, who have seen large bill spikes dating back to 2021. If enacted, homeowners will have to claim a General Homestead exemption, as well as meet an income eligibility limitation, to be able to apply for credits through the program.

El Asesor Kaegi Anuncia Proyecto de Ley de Alivio del Impuesto a la Propiedad Para los Propietarios más Afectados

El Asesor del Condado de Cook, Fritz Kaegi anunció el registro de un nuevo proyecto en la Legislatura de Illinois destinado a proveer alivio en los impuestos de propiedad para los propietarios del Condado de Cook. La Ley de Alivio del Impuesto a la Propiedad del Circuito Breaker fue presentada en el Senado de Illinois como SB1978 por el Senador Patrick Joyce (D-40th) y en la Cámara como HB3808 por el Representante Justin Slaughter (D-27). Este programa está diseñado para ayudar a los propietarios que han visto subir su cuenta un 25 por ciento o más de un año al

otro. Los créditos dados a los propietarios cubrirían hasta la mitad del aumento del impuesto. La típica cuenta residencial fue aumentada cerca del 20 por ciento o aproximadamente en \$1,000, de acuerdo a un análisis de la Oficina de la Tesorería del Condado de Cook. Los programas circuito breaker son

comunes en el país – otros 29 estados, así como el Distrito de Columbia ya los tienen en los libros. Illinois había tenido anteriormente un programa similar para los ciudadanos mayores. El programa de alivio aplicaría a propietarios en los suburbios sur y oeste, así como a todas las otras partes del Condado de



Cook, que han visto subir sus cuentas desde antes del 2021. Si es firmada, los propietarios tendrán que reclamar una exención 'General Homestead' así como cumplir con un límite de elegibilidad de ingresos, para poder solicitar créditos a través del programa.

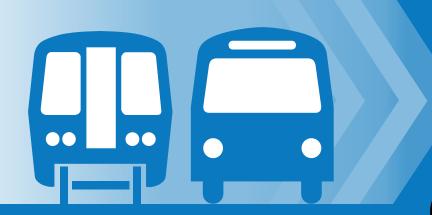

Planned Parenthood of Illinois (PPIL) is expanding abortion care options to include offering medication abortion through the PPDirect App. Currently, PPIL provides birth control, UTI treatment, at-home STI testing and emergency contraception through PPDirect. Adding medication abortion to the suite of services expands access, reduces wait times at health centers, avoids unnecessary travel, and provides the right care patients need wherever they are in the state. Patients using PPDirect fill out a questionnaire that is reviewed by a PPIL medical professional. PPIL mails the medication abortion pills to the qualified patients at their Illinois home address in 1-2 days. Patients can receive follow up care at a PPIL health center if needed and they can make an appointment through the PPDirect app. Medication abortion through PPDirect is \$200 which includes shipping. PPIL continues to offer medication and procedural abortion, birth control, gender-affirming care.
