# Mayor Johnson, City Officials and Developers Celebrate Groundbreaking of 79 West Monroe



Mayor Brandon Johnson, Alderman Bill Conway and city officials — including Deputy Mayor Kenya Merritt, Department of Planning and Development C o m m i s s i o n e r Ciere Boatright and Department of Housing Commissioner Lissette Castañeda — joined Lagfin, R2 Companies, and community leaders to break ground on 79 West Monroe, a landmark development that will set a precedent as Chicago's first officeto-residential conversion. This innovative project will transform the historic Rector Building, the oldest surviving commercial highrise designed by renowned architect Jarvis Hunt, into a dynamic residential space, addressing the growing demand for housing in the Loop. The renovation will add 117 new apartments to the Loop, offering a mix of market-rate and affordable housing. Notably, 79 W. Monroe will set a new standard for affordability in the LaSalle Street corridor, with 35 percent of its units (41 out of 117) designated as affordable housing. The project is spearheaded by Lagfin and Chicago-based developer R2. Lagfin, as the holding company of Campari, has made significant investments in Chicago-based projects their largest stake in any North American city.

# Chicago Teachers Union Step Closer to Agreement

After nearly a year of bargaining and ironing out a contract, the Chicago Teachers Union approved a tentative agreement with Chicago Public Schools. The tentative agreement will go to CTU's House of Delegates this week which will decide whether or not to advance it to CTU's 30.000 members for a ratification vote. If accepted, it will represent a major leap forward in the transformation of a district, according to the CTU. 'Our union is bargaining for what every parent wants for their child in our school communities. It shouldn't be a fight for children to get access to arts, sports, wrap around supports, and libraries. It's what should already exist," explains CTU Local 1 President Stacy Davis Gates. "We're

proud to have landed a transformative contract that turns away from decades of disinvesting in Black children and turns toward creating the worldclass education system for every single student in CPS no matter their zip code. If the contract is ratified by our members, we will be one major leap forward toward the educational experience Chicago's children and the mainly women workers who serve them in our schools deserve." In 2025, some highlights of the Chicago Teachers Union contract include:

- •Doubles the number of libraries and librarians for our schools.
- •Enforceable and smaller class sizes for all grade levels.
- •Ensuring social workers


and nurses serve students in every school, every instructional day.

- •Doubles the bilingual education staffing supports for students.
- •Additional staffing, curricular and enrollment supports for Early Childhood education students and programs.
- •Creates 215 more case manager positions districtwide to support students with disabilities.
- •A cost of living adjustment of 17-20% compounded (tied to inflation) over the four years of the contract.

# Ford y Líderes de Educación Superior **Alertan Sobre Recortes Federales**

La representante estatal La Shawn K. # Play On! Chicago Public Schools Brings **Museum Experiences into Classrooms**

More students than ever across the Chicago Public Schools (CPS) District now have access to designated spaces where they can touch and explore the physical world around them. In partnership with the Chicago Children's Museum, the District has been working to add Curiosity Classrooms to schools as part of efforts to bring sensorymuseum-quality rich, experiences straight to children in prekindergarten through 2nd grade. CPS CEO Pedro Martinez – along with other District leaders, school officials, and partners from Chicago Children's Museum – on Wednesday walked through one of the newest Curiosity Classrooms at Burke Elementary School. With



the 15 rooms that opened this year, the District has now expanded the number of participating schools to 25 total. The Curiosity Classrooms feature art spaces, book nooks, block play areas, nature corners, and sensory tables to dig, scoop, and pour – all features that are meant to spark curiosity and inspire the District's youngest learners to ask 'what if' questions. Key principles of the Curiosity Classrooms include:

•Use materials that invite

problem solving, selfexpression and creativity •Wonder, observe, question, test, fail, try again

•Provide authentic materials, equipment and

•Invite children to document and share ideas and discoveries

•Focus on STEAM concepts that can be directly experienced and are open-ended

•Include direct experiences with the natural and living world



homeownership center on the property's first The four-story floor. development will include 52 1-, 2-, and 3-bedroom apartments targeting households earning 30-60 percent of the area median income AMI. Resident amenities include indoor and outdoor community gathering spaces, a bike room, fitness center and onsite parking. The Ave will also create at least 1,000 SF in retail space for local businesses. The transaction is financed with

substantial support from the Chicago Department of Housing, which issued taxexempt bonds, 4 percent low-income housing tax credits (LIHTC) and \$18 million in tax increment financing proceeds. Construction financing and \$19 million in investor equity – generated by the tax credits – is provided through Bank of America. A joint venture of Leopardo and Ujamaa Construction is expected to begin construction in April, with completion likely in fall 2026.

# Federal Jury Convicts Chicago Man of Sex Trafficking and Kidnapping Offenses



A federal jury has convicted a Chicago man of violently sex trafficking five young victims, including a 15-year-old girl, and kidnapping two of them. The jury in U.S. District Court in Chicago on Tuesday convicted DENNIS WILLIAMS, 33, on all seven sex trafficking and kidnapping counts

against him. Williams faces a mandatory minimum sentence of 15 years in federal prison and a maximum of life. U.S. District Judge Mary M. Rowland set sentencing for Oct. 7, 2025. The convictions were announced by Morris Pasqual, Acting United States Attorney

for the Northern District of Illinois, and Douglas S. DePodesta, Special Agentin-Charge of the Chicago Field Office of the FBI. Valuable assistance was provided by the Chicago Police Department and the Lansing, Ill. Police Department. The government has been represented by Assistant

U.S. Attorneys Kristen Totten, Sushma Raju, and Michelle Parthum.

According to evidence presented at the weeklong trial, Williams used threats, violence, drugs, and other coercive means to force five victims to engage in commercial sex. Williams often restrained or assaulted the victims to force them to comply and turn over the proceeds to him. Williams also caused a 17-year-old girl, whom he also assaulted repeatedly, to assist him in trafficking the victims. Williams operated his sex trafficking operation in 2022 and 2023 out of his Chicago residence and motels in Lansing, Ill. On Aug. 2, 2022, Williams kidnapped one of his victims by luring her inside his truck and abruptly driving away. The victim escaped by leaping from the moving vehicle. On Jan. 10, 2023, Williams

kidnapped another of his victims by confining her to his closet overnight and then forcing her to engage in commercial sex with strangers. The victim escaped by jumping out of a second-floor window and running a quarter mile to a Chicago Public Library branch. All five of Williams' victims, including both of the kidnapping victims, testified about their


