differently.





The Town of Cicero's Office of the Assessor, Emilio "Emo" Cundari, will assist property owners to appeal with the Cook County Assessor's Office. Cook County is the only county in the state of Illinois in which local assessment decisions are made only by the County Assessor rather than the local township assessors.

Cundari stated that his office can help property owners complete the forms. The appeals period began on April 24 and will continue through June 6, 2025. Property owners can also appeal at home, online, by visiting www. cookcountyassessor.com A step-by-step process must be followed, beginning by clicking on "File an

Appeal." When your appeal is completed, property owners should receive an email confirmation of your submission. For more

May is National Foster Care Month

May is National Foster Care Month and this year's theme "Engaging Youth. Building Supports. Strengthening Opportunities," aims to raise awareness about the importance of involving youth in the decisions being made about their welfare, the significance of maintaining connections to important people in their lives and how to best support youth as they transition out of foster care. "Every child and youth in our care deserves to feel safe and loved" said Illinois DCFS Director Heidi E. Mueller. "It is because of our incredible foster parents across the state that children, youth and siblings can have a home and foster parent who has opened their heart, home and even their family so that a child can have the love and

stability they need during a very difficult time." DCFS works diligently to recruit foster families in every area of the state to join the 7,291 currently licensed foster families who have made it their life's mission to open their hearts and homes to children in need.

In late 2024, the department created Foster Emergency Resource Homes (ERH), which are licensed foster parents who have agreed to take a new youth in care for up to 10 days while the DCFS caseworker works to identify relative caregivers, fictive kin or a suitable home for the youth to reside. These ERHs have helped to significantly reduce the need to have youth sleeping in offices. Becoming a foster parent is a major commitment. Illinois DCFS provides a wide range of supports and services to ensure foster parents have what they

need to help the children in their home thrive, including ongoing training and a monthly stipend for the child's basic needs, such as food, clothing and housing costs.

The department also provides medical coverage specifically designed for Illinois youth in care; therapeutic, educational, recreational and crisis support services and access to caseworkers and peer groups to support the needs of the youth and their foster family. The DCFS Startup Funds Program, launched last year, provides preloaded Visa cards to foster families when the child is initially placed in the home, enabling caregivers to purchase bedding, clothing, personal hygiene and other essential items for the child quickly and easily.

Hernandez Passes Trio of Bills Aimed at Boosting Specialist Healthcare Access

Hernandez, D-Melrose Park, is taking aim at factors which contribute to shortages of specialist healthcare providers by passing three bills aimed at updating requirements and removing roadblocks that currently often lead to many Illinoisans being underserved. Hernandez recently passed three bills aimed at helping underserved areas to see increased numbers of

nearby specialist providers: House Bill 2676 would allow ophthalmologists, optometrists and anesthesiologists qualify for loan repayment assistance through already-existing Underserved Health Care Provider Workforce Program (UHCPW). This program incentivizes newly-trained specialists to move to and practice in "designated shortage areas" by helping with their educational loans if

they do so.

House Bill 3160 would require the Department of Human Services (DHS) to more promptly furnish providers of home and community-based services with updated and detailed rate sheets for the clients they serve. Rate sheets inform providers of the rates at which they can be reimbursed when caring for specific patients.

House Bill 3385 would require public colleges and universities to employ at

least three licensed mental health professionals if the student body is at least 3,750 students or one licensed professional per 1,250 students otherwise. It also would change the makeup of mental health

expert panels already required at public colleges and universities.

rápida y fácilmente ropa

de cama, ropa, higiene personal y otros artículos esenciales para el niño.

Arrest Made in 2016 Murder of Julio Servin

Cicero, IL – The Cicero Police Department announces an arrest in connection with the 2016 murder of Julio Servin.

On August 21, 2016, officers responded to a report of shots fired near 5539 W. Cermak Road. Upon arrival, officers discovered 22-year-old Julio Servin lying in the roadway with multiple gunshot wounds to the upper body. He was transported to a nearby hospital, where he was later pronounced deceased.

Following an investigation, 19-year-old Victor Martinez of Cicero was identified as the suspect. Martinez fled to Mexico shortly after the incident. Detectives worked closely with the Cook County State's Attorney's Office – Felony Review Unit and obtained

an arrest warrant for first-degree murder.

On Thursday, May 1, 2025, Victor Martinez was taken into custody by the U.S. Marshals Service upon his arrival at Midway Interna-

tional Airport. Custody was later transferred to Detectives of the Cicero Police Department.

On May 2, 2025, the Cook County State's Attorney's Office approved two counts of first-degree murder against Victor Martinez.

The Cicero Police Department thanks all law enforcement partners, in particular the US Marshals Service, who contributed to this arrest.

The Cicero Police Department wishes to remind the public that the reported charges do not constitute proof of the defendant's guilt. A defendant is presumed innocent until proven guilty and is entitled to a fair trial in which the government bears the burden of establishing guilt beyond a reasonable doubt.





The \$2B Wealth Transfer: How Cook County's Property Tax **Appeals System Rewards Businesses at the Expense of Homeowners**

Nearly \$2 billion in property taxes shifted homeowners onto from businesses over just three years, with a disproportionate share of the added burden falling on lower-income Black and Latino homeowners, a first-of-its-kind analysis by the Treasurer's Office found. The shift largely resulted from the wideranging success businesses appealing property valuations, called assessments, that determine their tax bills. From 2021 to 2023, which covers a complete three-year assessment cycle, business appeals shaved nearly \$3.3 billion off the total amount billed to businesses across the county. More than \$1.9 billion of that shifted onto homeowners.

Although previous studies have documented how assessment appeals shift tax burdens, the Treasurer's



Office study is the first to determine the resulting changes to the amounts billed to property owners. That analysis revealed the percentage increases in tax amounts billed to homeowners were far greater in areas with lower-income minority populations. "This study helps explain

why many homeowners have experienced sticker shock when opening their property tax bills in recent years," Treasurer Maria Pappas said. "We hope our findings help guide policy makers in their ongoing efforts to make the appeals system more equitable." Key Findings:

•Businesses

Homeowners: Successful appeals by businesses caused their collective tax bills to drop by \$3.3 billion, or 12.5%, while residential tax bills jumped by \$1.9 billion, or 6.9%.

•Business owners appealed their assessments nearly 64% of the time, while homeowners appealed 27% of the time — with businesses winning far larger assessed value reductions.

•Business' assessed value reductions surged to a total of \$25.5 billion from 2021 to 2023 compared to \$9.9 billion from 2015 to 2017. The difference is due mostly to larger reductions granted by the Board of Review. While business reductions rose,

assessed value reductions for homeowners declined to \$2.8 billion from \$3.2 billion from 2021 to 2023.
