Tips to Control Diabetes

November is Diabetes Awareness month and there are a several lifestyle changes that can help prevent type 2 diabetes, the most common form of the disease. If you've been diagnosed with prediabetes — high blood sugar that doesn't reach the level of a diabetes diagnosis — lifestyle changes can prevent or delay type 2 diabetes. Making a few changes in your lifestyle now may help you avoid serious diabetes health complications in the future. Lose Extra Weight

Losing weight lowers the risk of diabetes. The American Diabetes Association recommends people with that prediabetes lose at least 5% to 7% of their body weight to prevent diabetes. More weight loss can turn into even greater benefits. Set a weight-loss goal based on your current body weight. Talk to your healthcare professional about reasonable short-term goals and expectations. For example, aim to lose 1 to 2 pounds a week.

Be More Physically Active

Goals for most adults to

promote weight loss and keep a healthy weight include:

•Aerobic activity. Aim for about 30 minutes or more of moderate aerobic activity — such as brisk walking, swimming or biking — on most days of the week. Get at least 150 minutes of moderate aerobic activity a week. Or get at least 75 minutes of vigorous aerobic activity - such as running or swimming laps — a week.

•Strength training. Do strength training for all major muscle groups at least two times a week to increase your strength, balance and skills to keep an active life. Try to spread out your strength training through the week. Strength training can include lifting weights and doing body weight exercises such as squats.

•Balance training. For older adults, doing balance training two or three times a week can help keep range of motion and lower the risk of falls.

Eat Healthy Fats

Avoid eating many fatty foods that are high in calories. To help lose and manage weight, your diet should include a variety of foods with



unsaturated fats. These are sometimes called healthy fats. Unsaturated fats both monounsaturated and polyunsaturated fats promote healthy blood cholesterol levels and good heart and vascular health. Healthy fat sources include:

- •Olive, sunflower, safflower, cottonseed and canola oils.
- Avocados.
- •Nuts and seeds, such as almonds, peanuts, flaxseed and pumpkin seeds.
- •Fatty fish, such as salmon, mackerel, sardines, tuna and cod.


Amazon Donates \$10K in Books to Reavis Elementary, Celebrating Education Advocate Hannah Hayes

Illinois Department of Corrections Announces 'Voices of Connection: No-Cost Communication Pilot Program'

The Illinois Department of Corrections (IDOC) announced a new pilot program providing no-cost phone calls to individuals in custody at correctional facilities statewide. Beginning November 3, everyone in custody will receive 775 free domestic phone call minutes, or approximately \$6.20 per month, to call loved ones. The pilot program is part of IDOC's broader effort to provide reliable, affordable communication tools using technology. Building upon the rollout of a phone dialer application on ICSolutions tablets, this initiative will



significantly improve phone access for every individual in custody, allowing individuals to connect with loved ones directly from their own tablet when connected to Wi-Fi. This effort also is centered on the crucial role conversations play in maintaining family connections while supporting rehabilitation.

IDOC will assess usage and costs over the course of the pilot and may adjust the monthly allocation or work with the vendor to shift some of the funding to support program needs, such as replacement tablets and chargers. The pilot is scheduled to run through June 2026. For more information, visit www. illinois.gov.

As you may know, the U.S. Department of Agriculture recently announced that Supplemental Nutrition Assistance Program (SNAP) benefits will not be sent out on Nov. 1 due to the ongoing federal government shutdown. Starting next month, more than 527,000 families in Cook County will not be able to access the food aid they rely on.

•Greater Chicago Food Depository – GCFD is Cook County Health's partner oraganization in addressing food insecurity and will continue to serve the Cook County community

through its local food pantries, soup kitchens and mobile distribution locations. 
