Covenant House Illinois' Hosts Annual Sleep Out Chicago

On Thursday evening, many Chicago residents endured the colder temperatures to bring attention to the nearly 9.500 youth facing homelessness every night by partaking in Covenant House Illinois annual Sleep Out Chicago event. "November is National Homeless Youth Awareness Month, and as a number of prominent politicians and community leaders called out earlier this month, Chicago cannot forget about this most vulnerable community as it responds to the larger crisis of homelessness," said Susan Reyna-Guererro, LCSW, CEO of Covenant House Illinois. To bring homelessness to the forefront, volunteers gave up their beds to place a spotlight on the prevalent issue of youth and raised donations to fund critical sup-

Founded in 2017, Covenant House Illinois offers young people (18 to 24 years old) experiencing homelessness an "affirming community, absolute respect and a path to lasting independence." Covenant House Illinois provides interim and transitional housing programs and a Drop-In Center located on Chicago's west side as well as creates



tailored solutions for each young person that goes beyond short-term support and housing. Sleep Out Chicago makes it possible for Covenant House Illinois to provide more than 70,000 meals and nearly

15,000 secure nights of shelter every year. "Sleep Out Chicago was created for this purpose, to provide a platform for local allies, advocates, and community members to show their support for this invisible

population and raise funds to transform their lives and futures," said Ryan-Guererro.

The Chicago Mercantile Exchange (CME) Center and Rivers Restaurant hosted more than a hundred Sleep Out Chicago volunteers last Thursday. The event included presentations from program staff, group activities, life testimonials and reflections from program recipients, keeping Sleep Out focused on the event's purpose. Valparaiso University and City Colleges of Chicago (CCC) have entered into a guaranteed admission to support engineering students seeking a way to pursue a four-year degree. This new agreement ensures that all courses are aligned at both schools so City Colleges students can transfer from its School of Engineering to the University without losing any credits—guaranteeing that City Colleges of Chicago transfer students complete their Bachelor's Degree in Engineering within two years. The agreement was officially signed by all parties on October 8, and follows a previous agreement supporting students transferring to the University to earn a four-



year degree. Qualifying for admission requires a 3.0 transferable GPA from CCC, junior standing upon transfer, and transfer credit evaluation for up to 62 credit hours towards degree completion. Students with a cumulative transferable 3.5 GPA or higher will be considered for entry into Christ

Las Escuelas Públicas de Chicago Reafirman su Compromiso con el Acceso y la Equidad en los Cursos de Colocación Avanzada



Las Escuelas Públicas de Chicago (CPS) reconocieron el miércoles el continuo crecimiento y éxito de su programa de Colocación Avanzada (AP), reconocido a nivel nacional, destacando el aumento de la matrícula, los mejores resultados para los estudiantes afroamericanos y latinos, y decenas de millones de dólares en ahorros en la matrícula para las fa-

milias de CPS. Desde 2020, CPS ha aumentado la matrícula de AP en un 18% y el número de exámenes presentados en un 23%, con avances notables entre los estudiantes afroamericanos (+10%) y latinos (+5.5%). En la primavera de 2025, los estudiantes de CPS obtuvieron 28,328 puntajes AP calificados (3+), lo que equivale a casi 85,000 créditos universi-

tarios potenciales y \$42.5 millones en ahorros en la matrícula para las familias de CPS. La participación y el éxito en los Cursos de Colocación Avanzada se encuentran entre varias credenciales universitarias y profesionales tempranas que el Distrito monitorea para garantizar que los estudiantes de CPS estén preparados para tener éxito después de graduarse de

la escuela secundaria. En el marco de Success 2029: Together We Rise, el plan estratégico quinquenal del Distrito, los líderes de CPS establecieron el objetivo de aumentar el porcentaje de graduados de la escuela secundaria que obtienen créditos de

cursos avanzados y credenciales profesionales de un 49 por ciento informado en 2024 a un 70 por ciento para 2029. En 2025, el Distrito se acercó más a ese objetivo con un 56,3 por ciento de graduados que obtuvieron al menos una credencial a través

de cursos de Colocación Avanzada, Crédito Dual o Inscripción Dual, Programa de Bachillerato Internacional, el Sello Estatal de Alfabetización Bilingüe, Educación Profesional y Técnica, completando una pasantía y programación Junior ROTC.



Friend Health Celebrates Grand Opening of New Community Health Center in Back of the Yards


